

#### **Description**

The Holston Avenue Neighborhood Historic District is comprised of 132 principal properties, 113 of which are contributing, in a 57 acre area along and near Holston Avenue in Bristol (pop. 27,602, Sullivan County) in northeastern Tennessee. Almost all of the resources in the district are residences, although there is one small city park and one stone wall. Bungalow and Colonial Revival architecture together comprise over 50% of the houses. Significant examples of Tudor Revival and Queen Anne architecture are also found in the district. The majority of the houses were constructed by 1955, with some having early 1960s additions. There are a few infill properties but, overall, the district retains its architectural integrity.

To the north and south of the district is residential land use. Anderson Elementary School, a Bristol, Tennessee public school built in 1954, occupies the block immediately to the west of the district. To the east of the district is Volunteer Parkway which is also U.S. Highway 11E. Numerous businesses, most of which are retail establishments, are located along this extremely busy highway, which connects the center of Bristol with the Bristol Motor Speedway and Johnson City, Tennessee. The district is accessed only by residential streets. Throughout the district there are historic and non-historic concrete sidewalks. These sidewalks may be found along both sides of most streets, but only along one side of some.

The terrain of the historic district and most of the surrounding area is best described as gently rolling, low hills. Land use inside the district is almost exclusively residential. There are some vacant lots and one park with a basketball court and picnic tables. Most of the structures are single-family residential houses. The neighborhood also has some duplex houses and some apartment buildings. Properties to the south of Haynes Street are zoned R-2, which allows single family and duplex residential use, Properties to the north of Haynes Street are zoned R-3, which also allows multi-family dwellings.

#### INVENTORY

The following inventory is comprised of information about every building and site in the Holston Avenue Neighborhood Historic District. For each building, a description is given, followed by a C or NC designation. These designations indicate whether the building is considered to be contributing or non-contributing in terms of adding to historic associations and/or historic architectural qualities of the area within the district's boundaries.

Contributing status (C) was given based on the following criteria: (1) Construction was completed prior to 1963; (2) Significant aspects of integrity of location and setting are maintained. There is a connection with the historic development of the neighborhood; (3) Significant aspects of the historic materials and workmanship are retained on individual houses; alterations are minimal; (4) The overall design intent in plan and elevation are retained by structures; alterations are minimal.; and (5) There should be a strong sense of integrity of feeling conveyed by individual structures. The collective historic character and architectural continuity should be conveyed. Minor changes to a building will not prevent it from being considered a contributing resource, provided that most of the character-defining features are retained. These features would include porch elements, chimneys, fenestration, and original rooflines.

Non-contributing (NC) status was given based on the following criteria: (1) Construction was completed after 1962; (2) Major alterations have taken place that are unsympathetic to the original design intent, the original materials, and/or the workmanship; (3) A combination of minor alterations cause the building to lose consistency with the neighborhood's overall historic character.

Note that in the inventory, the name of the current property owner is given. For any property that has a known historic name, it is listed after the current owner's name.

711 7<sup>th</sup> Avenue. Blackburn House. c. 1900. Queen Anne form. Two story apartment, wood frame construction, aluminum siding, rectangular plan, brick basement, cross gable and hip roof with asphalt shingles, 1/1 double-hung aluminum framed windows, one exterior brick chimney, small gable roof front porch with vinyl-covered columns. (C).

Two story 30' X 40' garage. c. 1900. Stone and wood frame construction with aluminum siding on the second level, gable roof with asphalt shingles, seven 3/1 double-hung wood framed windows. Second level is an apartment. (C).

 809 7th Avenue. Williams House. c. 1923. Bungalow. One story residence, frame construction, brick veneer, brick pier foundation, cross gable roof with asphalt shingles, rectangular plan, 5/1 wood frame windows, one interior brick chimney, half length gable roof front porch with rectangular wood pillars on brick piers, exposed rafter tails. (C).

One story 30' X 40' garage and apartment. c. 1975. Wood frame construction with vinyl siding, gable roof with asphalt shingles, two wood frame windows. (NC).

3. 812 7th Avenue. Ragan House, R. E. Gobble House, c. 1921. Craftsman Bungalow. One and one-half story residence, wood frame construction, brick veneer with wood shingles on second level, brick basement, gable roof with asphalt shingles, irregular plan, 6/1 double-hung windows with aluminum storm windows, one exterior brick chimney, full shed roof front porch with two rectangular brick pillars, cement window lintels, eaves supported by brackets, gable roof dormer on front with four windows, awning over gable windows. (C).

One story 12' X 30' garage c. 1923. Brick wall covering, gable roof with asphalt shingles, two 6/1 double-hung wood frame windows. (C).

4. 815 7th Avenue. Leonard House, Evell Ross House. c. 1925. Craftsman Bungalow. One and one-half story residence, wood frame construction, aluminum siding, brick basement, gable roof with asphalt shingles, irregular plan, 3/1 wood frame windows, one exterior brick chimney, shed roof front porch with two rectangular wood pillars and two aluminum pillars, eaves supported by brackets, small shed roof porch on side, gable roof dormer on front with three front-facing and two side-facing windows. (C).

One story 30' X 40' garage-shop-storage building, c. 1950. Wood frame construction with vinyl siding, gable roof with asphalt shingles, one wood frame window, over-sized doors. (C).

5. 900 7th Avenue. Moore House, Dr. Chappel House. c. 1925. Bungalow. One and one-half story residence, wood frame construction, brick veneer, brick basement, gable roof with asphalt shingles, irregular plan, 3/1 double-hung wood frame windows, one exterior and one interior brick chimney, shed roof front porch with wide rectangular concrete pillars at each end, shed roof back porch with two iron supports, eaves supported by brackets, concrete window lintels, gable roof dormer in front with three front-facing and two side-facing windows. Gable roof dormer added in rear. (C).

One story 12' X 35' garage-storage building. c. 1925. Cedar shingle siding, gable roof with asphalt shingles, two 3/1 double-hung wood framed windows. Small shed attached to the end. (C).

6. 901 7th Avenue. Kiser House, Newman House. c. 1930. Colonial Revival. Two story residence, frame construction, brick veneer, brick basement, gable roof with asphalt shingles, rectangular plan, 9/1 double-hung wood frame windows, one interior brick chimney, small gable roof front porch with two wood columns, eaves supported by brackets, wood shutters on front windows, awning over lower level windows, half fan lights in gables, gable- roof carport on south side. Carport enclosed/screened c. 1980. (C).

One story 35' X 35' storage and shop (originally a garage) c. 1933. Brick exterior, gable roof with asphalt shingles, two wood frame windows, standard garage doors in front (C).

7. 903 7th Avenue. Rutherford House, Gobble House. c. 1930. Craftsman Bungalow. One and one-half story residence, frame construction, brick veneer, cedar shingles on upper level, brick and concrete basement, gable roof with asphalt shingles, irregular plan, 5/1 double-hung wood framed windows, one interior brick and one exterior brick chimney, full-length shed roof front porch with rectangular brick pillars and concrete floor, gable roof dormer on front, covered balcony on dormer, eaves supported by brackets, wood back porch. Front porch wood floor replaced with concrete c. 1990. Back porch reworked and wood deck added c. 2000. (C).

One story 23' X 26' two-bay garage. c. 1930. Frame construction, brick veneer, hip roof with asphalt shingles, side entrance with glass door and full double-hung window on opposite side. (C).

8. 904 7th Avenue. Grindstaff-McClellan House, Grindstaff House. c. 1920. Craftsman Bungalow. One and one-half story residence, wood frame construction, sawn-cedar shingle siding, brick basement, cross gable roof with asphalt shingles, rectangular plan, 9/1 double-hung vinyl framed windows, two exterior and one interior brick chimneys, full-length gable roof front porch with dentil molding and rectangular shingle-covered pillars, transom over front door, rafter tails. Rear wood deck and rail added c. 2009. (C).

One story garage – guest room (originally servants quarters) c. 1910. Sawn-cedar shingle siding, gable roof with asphalt shingles, windows replaced c. 2011, porch off room with concrete floor. (C).

- 9. 907 7th Avenue. Baker House, Arrants House. c. 1940. Colonial Revival. One and one-half story residence, frame construction, brick veneer, cement block basement, cross gable roof with asphalt shingles, T-shaped plan, 8/8 double-hung wood framed windows with aluminum storm windows, two exterior and one interior brick chimneys, gable roof front porch with aluminum columns, wood shutters, aluminum soffits, window boxes, sidelights at front door. Back porch screened in and rear deck added c. 2006. (C).
- 10. 908 7th Avenue. Wikerson House, Leslie House. c. 1908. Queen Anne Cottage form with Colonial Revival Influence. One and one-half story residence, frame construction, stucco and pressed metal siding, concrete block basement, cross gable roof with asphalt shingles, irregular plan, 1/1 double-hung vinyl framed windows, two interior brick chimneys, wraparound porch with wood railings and columns and pressed metal ceiling, pediment at front-center, dentil molding, large oak front door with transom and sidelights. Back porch enclosed c. 1940. Aluminum carport added to rear c. 1982. (C).

One story 13' X 22' garage - storage building, c. 1940. Dutch lap siding, gable roof with asphalt shingles. (C),

11. 914 7th Avenue. Dunn House. c. 1908. Queen Anne. Two and one-half story residence, frame construction, cement brick veneer, brick basement, cross gable roof with asphalt shingles, rectangular plan, 1/1 double-hung vinyl framed windows, one interior brick chimney, wrap- around porch with vinyl columns and balustrade, shutters. (C).

One story, one bay 14' X 21' garage. c. 1920. Concrete block construction, gable roof with asphalt shingles, two windows. New door added c. 2005. (C).

12. 915 7th Avenue. Smalling House, Snapp House. Craftsman. c. 1925. Craftsman. One and one-half story residence, frame construction, brick veneer, cement basement, cross gable roof with asphalt shingles, irregular plan, 6/1 wood framed windows, one brick exterior chimney, enclosed front porch, eaves supported by decorative brackets, shed roof dormer with three windows, balcony over enclosed porch, asphalt-shingle awnings over front windows and front door. Back porch replaced and enlarged c. 2006. (C).

Two and one-half story apartment residence, wood frame construction, vinyl siding, basement and crawl space of stone and cinder block, hip roof with asphalt shingles, rectangular plan, 1/1 double-hung wood framed windows, three brick interior chimneys (currently closed), full hip roofed front porch with four wood columns with ionic capitals, shutters on lower floor windows, transom above front door, hip roof dormer with two windows. Front and back porches reconstructed c. 2004. (C).

Shutters added c. 2004. (C).

One story 14' X 19' one-bay garage. c. 1922. Brick exterior walls, gable roof with asphalt shingles, one wood window. Covered picnic area added c. 1945. (C).

15. 918 7th Avenue. Robinson House, McClellan House. c. 1924. Colonial Revival. Two story residence, frame construction, brick veneer, cement basement, gable roof with asphalt shingles, L-shaped plan, 6/1 and 8/1 double-hung vinyl framed windows with storm windows, two exterior brick chimneys, front gable roof portico with four stucco-covered columns and Greek capitals, side drive-through car port with rectangular brick pillars. Rear addition constructed c. 1962. Storm windows and shutters added to front and sides c. 1974. (C).

One story 14' X 22' one-bay garage. c. 1924. Brick exterior walls, hip roof with asphalt shingles, one wood framed window. (C).

16. 920 7th Avenue. Wurmser House, Dougherty House. c. 1921. Craftsman Bungalow. One and one-half story residence, frame construction, brick veneer, brick basement, gable and hip roof with asphalt shingles, rectangular plan, 1/1 double-hung vinyl framed windows, two interior brick chimneys, wraparound shed roof porch with rectangular brick pillars, sidelights around front door, gable roof dormer with front balcony, enclosed back porch. Window replacement c. 2009. (C).

One story 17' X 22' one-bay garage (used for storage). c. 1921. Brick exterior walls, gable roof with asphalt shingles, two windows. (C).

- 17. 945 7th Avenue. Dell House, Davis House. c. 1920. Craftsman Bungalow. One and one-half story residence, frame construction, brick veneer, brick basement, gable roof with asphalt shingles, rectangular plan, 6/6 double-hung vinyl framed windows, two exterior brick chimneys, full front shed roof porch with rectangular brick pillars at each end, wood balconies at both gable ends. Balconies replaced and deck added in rear c. 2003. (C).
- 18. 947 7th Avenue. King House. c. 1950. Ranch. One story residence, frame construction, brick veneer, cement block basement, gable roof with asphalt shingles, irregular plan, 6/6 double-hung vinyl framed windows, one interior brick chimney, inset entry porch, screened back porch and deck, vinyl soffits, sidelights at front door. Aluminum three-car carport added c. 1984. (C).

One story 16' X 12' storage building, c. 1985. Wood frame construction, gambrel roof with asphalt shingles. (NC).

19. 1001 7th Avenue. Aldridge House. c. 1920. Dutch Colonial Revival. Two story residence, wood frame construction, vinyl siding, brick basement, gambrel roof with asphalt shingles, irregular plan, 9/1 double-hung vinyl and wood framed windows,

- 23. 1106 7th Avenue. Faust House, Miller House. c. 1930. Tudor Revival. One and one-half story residence, wood frame construction, brick veneer, concrete basement, cross gable roof with asphalt shingles, 6/6 double-hung wood framed windows, 35 pane picture window in front, one exterior brick chimney, small entry porch with gable roof supported by brackets, round-top wood front door, gable roof dormer with three windows, concrete front deck. (C).
- 24. 1107 7<sup>th</sup> Avenue. Smelser House. c. 1950. Minimal Traditional. One story residence, wood frame construction, vinyl siding, concrete basement, hip roof with asphalt shingles, irregular plan, 6/6 double-hung wood frame windows with aluminum storm windows, picture window, one exterior brick chimney, small entry porch. (C).

One story 276 s.f. garage. c. 1970. Vinyl siding, hip roof with asphalt shingles, two garage doors. (NC).

25. 1108 7th Avenue. Moore House. c. 1943. Tudor Revival. One and one-half story residence, wood frame construction, brick-stone siding, crawl space with brick piers, gable roof with asphalt shingles, rectangular plan, 6/6 double-hung wood framed windows with storm windows, one exterior brick chimney, inset brick porch on north side. Wood deck added c. 1970. (C).

Two story 13' X 22' utility building, c. 1980. Vinyl siding, gable roof with asphalt shingles. (NC).

26. 1110 7<sup>th</sup> Avenue. Young House. c. 1935. Bungalow. One story residence, wood frame construction, vinyl siding – stucco – brick, concrete basement, gable roof with asphalt shingles, irregular plan, 6/6 and 1/1 double-hung windows with storm windows, one exterior brick chimney, ¾ front porch with rectangular wood columns. There was a full front porch, but ¼ of it was enclosed to add a bedroom. (NC).

One story 10' X 18' garage, c. 1935. Wood siding, gable roof with asphalt shingles. (C).

- 27. 1117 7<sup>th</sup> Avenue. Bell House, Brightwell House. c. 1953. Ranch. One story residence, wood frame construction, brick veneer, cinder block basement, cross gable roof with asphalt shingles, irregular plan, 6/6 double-hung wood framed windows, bay window, picture window, two external brick chimneys, small inset entry porch. (C).
- 28. 1118 7th Avenue. Craig and Terra Kistner House, Bowers-Kistner House. c. 1925. Tudor Revival. One and one-half story residence, wood frame construction, brick veneer, concrete basement, cross gable roof with asphalt shingles, irregular plan, wood framed casement windows, bay window, screened shed roof porch on south side, two dormers in rear, round top wood front door. (C).

One story 12' X 20' garage. c. 1933. Weatherboard siding, gable roof with asphalt shingles, two windows. (C).

32. 1128 7<sup>th</sup> Avenue, Linebough House, Carreras House. c. 1925. Dutch Colonial Revival. Two story residence, wood frame construction, brick veneer and aluminum siding, concrete basement, gambrel roof with asphalt shingles, rectangular plan, 6/1 double-hung wood framed windows with storm windows, one exterior brick chimney, front portico with gable roof, flat roof side porch. (C).

One story 19' X 19' garage. c. 1980. Wood and brick siding, gable roof with asphalt shingles. (NC).

#### Statement of Significance

Summary

The Holston Avenue Neighborhood Historic District in Bristol, Sullivan County, Tennessee is being nominated under National Register criteria A and C. The district is comprised of 132 principal properties that have collective significance to Bristol in architecture and community planning and development. The neighborhood's pattern of development is associated with industrial growth and the urbanization of Bristol. With its earliest resources dating to 1900 and its most recent contributing resource dating to 1962, the neighborhood contains numerous good examples of Bungalows, Colonial Revival, Tudor Revival, and Queen Anne residences along with a few other building forms and stylistic influences. Although a small city park is included in the district, it is otherwise residential. A significant number of houses have added modern siding, replacement windows, and/or exterior storm windows. In only a few instances do these alterations combine to cause a building to become inconsistent with the overall character of the neighborhood. The district retains its historic and architectural integrity.

#### The Founding of Bristol

The City of Bristol, Tennessee - Virginia began as the dream of a merchant from nearby Blountville, Tennessee. This merchant, a young man named Joseph R. Anderson purchased 100 acres of land from his father-in-law, Rev. James A. King. Anderson believed that this land, which straddled the boundary between Virginia and Tennessee, was ideally situated for growth of a town. Shortly after purchasing the property in 1852, he had the town planned and surveyed. He distributed maps and began offering lots for sale. Believing, or hoping, that his town would become an industrial center, he named it for a city in England that was known at that time for developing new industries and commerce: Bristol.

One of the reasons for Anderson's optimism concerning growth of his town was the fact that it was on the proposed route of the railroad that would connect Richmond, Virginia with Knoxville and Chattanooga in Tennessee and Atlanta, Georgia. As he predicted, the railroad did play an important part in the growth and development of Bristol and Northeast Tennessee.

Anderson, however, was not the only person who could see the potential for a town located at the point at which the railroad would cross the state line between Virginia and Tennessee. At about the same time, or immediately afterward, Col. Samuel Goodson, cousin of Rev. James A. King, platted a town on land he owned immediately to the north of Anderson's Bristol. He called his development Goodsonville. Like Anderson, he anticipated growth and proceeded to construct rental property.

In 1856, the Town of Goodson, Virginia was incorporated to include all of Goodsonville, plus that portion of Bristol on the Virginia side of the state line. At that point, these "twin cities" were Bristol, Tennessee and Goodson, Virginia. That same year, the railroad came into town, and the already rapid growth accelerated. Although it was officially called Goodson, the city north of the state line continued to be known unofficially as Bristol. By 1890, the unofficial was made official, and Goodson, Virginia became Bristol, Virginia. The border cities shared their name. To this day, the thriving downtown areas of both Bristol, Virginia and Bristol, Tennessee are joined together along State Street (Bristol Commercial Historic District NR 5/22/03). Running east and west, much of State Street is also the state line. Also shared by the two states on East State Street is the Bristol Virginia-Tennessee Slogan Sign (NR 9/8/88).

#### Pre-Development Period

Before it was a residential neighborhood, the area currently occupied by Holston Avenue and surrounding streets belonged to members of the King family. Born in Londonderry, Ireland in 1752, Col. James King immigrated to Virginia in 1769. Col. King was able to acquire about 50,000 acres of land in and around what is now Bristol, Tennessee/Virginia. Land belonging to Col. King was conveyed to his son, the Reverend James A. King, the founder of King College in Bristol, Tennessee. Col. James King's son was the same Rev. King who sold 100 acres of land to his son-in-law, Joseph R. Anderson, considered to be the founder of Bristol,

Tennessee. The previously-described purchases made by Anderson and Goodson did not, however, include the location of the present-day Holston Avenue Neighborhood.

Rev. King's fifth child, Margaret, was born January 10, 1820 in what is now Bristol, Virginia. When Margaret King celebrated her 26<sup>th</sup> birthday, she was still unmarried. At that time, it was assumed that if a woman of Margaret's age was single and living at home, she would in all likelihood be a spinster. However, a widower named John Goodson English, 13 years older than Margaret, married her in Washington County, Virginia in September of 1846. Rev. King's mother and the mother of John Goodson English were sisters, so English and Rev. King were first cousins. Although he was born in Washington County, Virginia in 1807, English owned and resided at a large plantation called Strawberry Point in what is now Monroe County, Mississippi. The primary crop grown at the plantation was cotton, but it should be noted that there were also some large fruit orchards there. English wrote in his journal that over 1,300 peach trees had been set at Strawberry Point.

Although they resided in Mississippi, the English family visited Bristol about once a year while Rev. King was still alive. Upon King's death in 1867, John and Margaret English inherited a portion of his land. This land included the area that would become the Holston Avenue Neighborhood. This land had been cleared and used by Rev. King as upland pasture. While this land was owned by the English family, an apple orchard was planted on it. As mentioned previously, John Godson English had experience with fruit orchards in Mississippi and perhaps he wished to replicate in Tennessee the success he had known at Strawberry Point. It has been speculated that English was hopeful that the orchard would help him to recover losses resulting from the Civil War. Holston Avenue Neighborhood's Orchard Street, which runs between 9<sup>th</sup> Street and Holston Avenue, was so named because the area was once an apple orchard.

The Englishes had eight children, the last of which was named Cyrus Chalmers English. Cyrus was three years old when his grandfather, Rev. King, died. Following King's death, the English family spent much time at their Bristol property; thus, young Cyrus grew up in Bristol where he was educated in private grammar schools and attended King College.

Not long after Cyrus' 23<sup>rd</sup> birthday, his father died at his plantation at Strawberry Point. Cyrus went to northeastern Mississippi and for a brief time he operated the family plantation near Aberdeen. He soon moved back to Bristol and began pursuit of several enterprises, one of which was real estate development. Development of Holston Avenue and its intersecting streets was one example of this pursuit. Thus, from what had been Rev. King's upland pasture and then the English family's apple orchard, Cyrus Chalmers English began developing what is now the Holston Avenue neighborhood. The area developed slowly, without any known plat or plan.

History of Holston Avenue Neighborhood

The first houses in the Holston Avenue neighborhood were constructed in 1900. Streets were platted in a grid pattern ignoring the topography. Holston Avenue and 7<sup>th</sup> Avenue run generally north and south. Orchard Street, Haynes Street, Reynolds Street, Clyde Reser Street, Weise Street, Helms Street and West Cedar Street run perpendicular to Holston Avenue and 7<sup>th</sup> Avenue. West Cedar Street intersects U.S. 11E near the southeast corner of the district.

The first residential street in Bristol, Tennessee to be paved was Holston Avenue, and this occurred in 1914. A stone wall (#132) runs along a portion of the west side of Holston Avenue, which serves as a retaining wall. The rock for this wall was quarried from a nearby hillside by two men who used a chisel and sledge hammer to break out pieces of rock. These men placed the rock into a two-wheeled cart which they used to haul the rocks to Holston Avenue to construct the wall, which is still in use.

Thirty-one houses in the neighborhood were constructed between 1900 and 1920. Nine of these structures (29%) are Queen Anne houses, all of which were constructed between 1900 and 1908. Three extremely large Neo-Classical houses were constructed during that same period. These impressive buildings marked the area as an elite neighborhood.

Although other parts of Bristol, Tennessee are known to have received water distribution lines as early as the 1890s, the exact date of the arrival of water lines along and near Holston Avenue has not been documented. However, Sanborn maps indicate that by 1922, six inch and four inch water lines had been constructed along Holston Avenue.

In the 1920s, Beaver Creek served as the eastern boundary of the neighborhood. When the Volunteer Parkway/U. S. Highway 11E was constructed in the 1960s, the creek was relocated. To the east of the creek, the Southern Brick Plant, known also as the Bristol Brick Corporation, was in operation in the 1920s and probably provided building materials found in Holston Avenue Neighborhood houses. It is known that bricks manufactured at this facility were used in the construction of a major hotel in Bristol in 1927, and it is reasonable to assume that they were also used for housing construction during that period.

Tremendous industrial development resulted in remarkable population growth in the region in and around the northeastern Tennessee cities of Johnson City, Kingsport, and Bristol in the 1920s. This area, which came to be known as the Tri-Cities, went through a transformation from an agricultural to an industrial economy giving rise to a demand for all kinds of labor as lumber yards, warehouses, factories, and rail facilities were constructed. This regional growth spawned a need for additional housing, and the meeting of this need is shown in the number of houses constructed in Holston Avenue Neighborhood from 1921 through 1930. There are currently 51 houses in the neighborhood built during that ten year period. That number represents nearly 39% of the neighborhood's housing stock and is more than double the number of extant houses from any other decade. Mid-level wage-earners moved into the neighborhood and their arrival was reflected in the housing style. Of the extant houses built in the 1920s, over half of them were of a Bungalow form. It was during this period that the neighborhood began to have a mixture of socio-economic classes.

Bristol's rate of growth of the 1920s was not maintained as the nation went into the Great Depression. The rate of housing construction declined throughout the city, including the Holston Avenue Neighborhood. Of the extant houses in the neighborhood, 13 were constructed in the 1930s and 12 in the 1940s. There was also a change in the architectural style of houses being built. The Bungalow form, which had become so popular in the 1920s, accounted for only about 16% of the houses built in the two decades that followed. In their place, revival styles became much more popular. Colonial Revival and Tudor Revival houses combined account for 48% of the houses built in Holston Avenue Neighborhood during these two decades.

In the 1950s, more houses were constructed than in either the 1930s or 1940s, but growth did not match that of the 1920s. By this time choices were limited by the fact that not as many lots remained available. Eighteen extant houses were constructed in the neighborhood between 1951 and 1962, during which time yet another style shift occurred. Not a single extant house constructed during that time period is of a revival style. Instead, Minimal Traditional houses account for almost 28% of those constructed, while over 55% of the extant houses built in the 1950s are Ranches.

At its October 1952 meeting, the Bristol Tennessee Planning Commission was asked by Judge J. E. Caldwell to make a change in the zoning which would allow multi-family housing to be built between Weise (Clyde Reser) Street and Reynolds Street from the alley between 7th Avenue and Holston to Holston Avenue. The meeting report contained the opinion of Staff Representative Joe B. Whitlow, Jr. that multi-family housing would be acceptable in this area based on the fact that there were already several apartment buildings nearby, and the topography is not favorable for single-family dwellings. The Planning Commission approved a recommendation to change the zoning for this area from R-2 to R-3, allowing multi-family housing. However, the meeting report of the November 1952 Planning Commission meeting stated that following a public hearing, the governing body of Bristol, Tennessee disallowed the proposed rezoning.

Clyde Reser Street was originally called Weise Street. The portion of Weise Street between Holston Avenue and 7<sup>th</sup> Avenue was an alley. This segment's change from an alley to a street was apparently initiated at the November 19, 1956 meeting of the Bristol, Tennessee Planning Commission. Planning Commissioner James Dougherty presented a plan that included adding width to the alley so that it would be 40 feet instead of 15 feet, as well as replatting certain lots so that they would face on the new street. Preliminary approval was granted by the Planning Commission and the plan was apparently soon carried out. The four houses facing Weise Street were built in 1959 and 1960.



Six houses have been constructed in the neighborhood after 1962. Three were constructed in the 1960s and three in the 1970s. The youngest house in the neighborhood was built in 1979. During the 17 years from 1963 through 1979, builders in the neighborhood did not follow a predominant style; there being one modern, one Minimal Traditional, two Colonial Revivals, and two Ranches. Thus, houses built in the Holston Avenue Neighborhood after the designated period of significance have added to the variety that already existed.

Until the early 1960s, the land immediately to the east of the neighborhood was pastureland along Beaver Creek. However, in 1963 a four lane highway was constructed to the east of and down hill from the houses on the east side of 7<sup>th</sup> Avenue. The highway known as the Volunteer Parkway is still in use today. Its federal designation is U. S. Highway 11E and it serves as the main thoroughfare going southwest to Johnson City, Tennessee. None of the houses in the district face the highway.

#### Architectural Context/Comparison

About one mile to the east of the Holston Avenue Neighborhood is Bristol, Tennessee's Fairmount Neighborhood Historic District, which was listed in the National Register of Historic Places in 2010. Although the first lots were sold in Fairmount about 27 years earlier than those along Holston Avenue, both neighborhoods are about the same distance from downtown Bristol, and have experienced many parallels.

The developers of the Fairmount Neighborhood envisioned stately residences occupied by local society's most affluent members. In keeping with the vision, some of the first homes built along the most prominent streets were large Queen Anne residences. Apparently Holston Avenue was also considered to be a neighborhood for the elite in its earliest years. There are nine Queen Anne houses along Holston Avenue, Orchard Street, and 7<sup>th</sup> Avenue that were built between 1900 and 1913. This represents nearly 43% of the houses built in Holston Avenue Neighborhood during that time period. Add to these Queen Anne houses the three enormous Neo-Classical homes constructed along Holston Avenue in 1903 and 1908, and the case can be made that, like Fairmount, this area attracted the affluent residents. The fact that Bristol, Tennessee had at least two neighborhoods populated with

large, ornate houses can be attributed to the city's substantial boom during the last 15 years of the 19th century and the first 15 years of the 20th. As Holston Avenue was being created in 1900, plans were being made for a major expansion of Fairmount.

The previous section notes that during the 1920s, most of the houses built in the Holston Avenue neighborhood were of the Bungalow form due to the influx of mid-level wage earners. The effect of the 1920s population expansion had a similar effect on the Fairmount neighborhood. Reflecting this new type of resident, these Bungalows were more modest than the houses built previously. It should be noted that the Fairmount neighborhood has over three and one-half times as many primary buildings as the Holston Avenue neighborhood. Fairmount's development during the 1920s took place in its southern half, and there is to this day, a clear distinction between the two halves of the neighborhood. Being much smaller, the Holston Avenue neighborhood does not have the distinct geographical boundaries of development and architectural style as Fairmount. Although there is a core where the oldest and largest houses may be found, those large and high style houses of the 1900s and 1910s are across the street from Bungalows constructed in the 1920s. Just as the period from 1921 to 1930 was the most active time of growth for Holston Avenue, it was also a substantial period of development for Fairmount.

Building parallels between the two neighborhoods continued through the 1930s and 1940s. Revival styles became popular and a number of Colonial Revival structures were built in both neighborhoods. The Tudor Revival style was also fashionable in the Holston Avenue Neighborhood at this time, while, according to the National Register nomination, some Dutch Colonial houses and English Cottages were built in the Fairmount Neighborhood.

Twenty-one buildings in the Fairmount neighborhood were built during the 1950s. Houses build during this decade represent less than 5% of the neighborhood's buildings. However, in the Holston Avenue neighborhood, 17 houses were built in the 1950s and that number represents more than 13% of the neighborhood's buildings. Thus, even though more houses were built in Fairmount than Holston Avenue during this decade, 1950s houses represent a larger percentage of the buildings in the Holston Avenue Neighborhood than in Fairmount. The Ranch house was popular in both neighborhoods in the 1950s, during which time 52% of the houses built in the Holston Avenue Neighborhood were of that style, while in Fairmount they account for 57% of houses constructed in that period.

Although a comparison of the periods of construction and the styles that were popular during each period reveals numerous similarities between Fairmount and Holston Avenue, an examination of the current building styles reveals some similarities as well as a number of contrasts. The growth that was taking place in Bristol during much of these neighborhoods' periods of significance had some similar effects. On the other hand, there were some different influences. For example, while there was no Holston Avenue prior to 1900, buildings in Fairmount were being built in the early 1880s. Of the 463 primary buildings in the Fairmount Neighborhood, 43 (9%) were constructed prior to 1900. This earlier start for Fairmount helps to account for its higher percentage of Queen Anne and Queen Anne Cottage homes. Also, in its early years, residents of Fairmount had access to trolley car service, a large hotel, and a baseball field on which Bristol's minor league baseball team played. Holston Avenue enjoyed none of these benefits.

The table below compares the most popular house styles of each neighborhood. The Bungalow represents the largest percentage of houses in both neighborhoods. The neighborhoods have an almost equal percentage of houses built in this form. At 28.4% for Holston Avenue and 29.4% for Fairmount, less than one percentage point separates them. A style that was very popular in the Holston Avenue Neighborhood was Colonial Revival. While 20% of the houses in the Holston Avenue Neighborhood are of this style, it accounts for a little more then two percent of the houses in Fairmount. The fact that Holston Avenue had a larger percentage of houses built during the 1950s is the likely reason why it has a slightly larger percentage of Ranch homes. Holston Avenue has 12 Tudor Revival houses, while Fairmount has none. However, there are 10 English Cottage and English Cottage Revival homes in Fairmount.

The Fairmount Neighborhood has almost twice as many styles/forms as the Holston Avenue Neighborhood. This fact is not surprising because Fairmount is much larger.

National Register Resources in Bristol

If approved, the Holston Avenue neighborhood will join nine individual properties and two historic districts in Bristol, Tennessee that have already been listed in the National Register of Historic Places. The National Register sites are Bristol Municipal Stadium, Parlett House, East Hill Cemetery, Bristol Virginia-Tennessee Slogan Sign, First National Bank of Bristol, Paramount Theatre and Office Building, U. S. Post Office – Shelby Street Station, Edward Washington King House, and Gammon House. The National Register Districts are Fairmount Neighborhood Historic District and Bristol Commercial Historic District. The slogan sign and commercial district are located in both Bristol, Tennessee and Virginia.

#### Local Support for Integrity

For many years, the residents of Holston Avenue Neighborhood have strongly supported the idea that this neighborhood should have exclusively single-family residential structures. In 1952 the Planning Commission recommended a change of zoning to allow multi-family housing in a small area that allowed only single-family and duplex housing. Holston Avenue residents attended the required public hearing and voiced their opposition. As a result the zoning change was not approved. Strong support for maintaining the existing single-family residential character of the neighborhood still exists among the residents.

At this time, Bristol, Tennessee does not have a historic zoning commission to enforce regulations in local historic districts. National Register designation serves as a means whereby a historic neighborhood, such as Holston Avenue, can be documented as having special characteristics that are worth protecting and preserving. This designation must be recognized and taken into consideration by the local government and local planning and zoning.

#### Verbal Boundary Description

Both sides of 7<sup>th</sup> Avenue from West Cedar Street to Haynes Street; both sides of Holston Avenue from West Cedar Street to Orchard Street; both sides of 9<sup>th</sup> Street from a point 200 feet north of Orchard Street to Haynes Street; the south side of Orchard Street from 9<sup>th</sup> Street to Holston Avenue; both sides of Haynes Street from 9<sup>th</sup> Street to its eastern end about 150 feet east of 7<sup>th</sup> Avenue; the east side of Watauga Avenue from a point 200 feet south of Haynes Street to Haynes Street; both sides of Reynolds Street from Holston Avenue to 7<sup>th</sup> Avenue; both sides of Weise Avenue from Holston Avenue to 7<sup>th</sup> Avenue; both sides of Clyde Reser Street; both sides of Helms Street from Holston Avenue to 7<sup>th</sup> Avenue; and Belvedere Heights.

#### **Boundary Justification**

Boundaries of the historic district were drawn to include contributing residential resources along Holston Avenue, 7th Avenue, the streets that run between Holston Avenue and 7th Avenue, Haynes Street, the south side of Orchard Street, and Belvedere Heights. Anderson Elementary School is adjacent to the district but was not included because its appearance is not of the same era as the district's residential structures. Most of the houses north of Orchard Street were determined to have been altered too much and many would not have been considered to be contributing resources. Areas south of West Cedar Street and along Indian Hills Drive contained many houses that were of a more modern architectural style, and thus did not convey the same feeling. Expansion of the district's boundary eastward would have been impossible because of the presence of U.S. Highway 11E and the new commercial development that has taken place there. Thus, the district is surrounded by buildings that are either historic and altered or modern.




