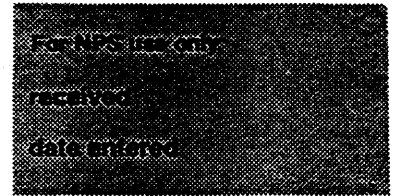

1. Name: Otto Huechling House, survey number 60
2. Location: approximately 2/10 of a mile east of Highway 61 and 1.5 miles south of Mimbres; ca. 25 east of the Dr. Granville Wood House, survey # 61.
4. Owner: Mimbres Foundation, c/o Melvin Nefsky, 521 N. La Cienega B Suite 202, Los Angeles, Ca. 90048.
7. Description: Photo 38; foundation unknown; stuccoed adobe; asphalt shingle hipped roof with gablets; 2/2 double hung windows, aluminum sliding windows; single doors; porch with chamfered posts on three sides. SW facade: centered door, with center hall behind, flanked symmetrically by new aluminum sliding windows. SE facade: two w/d/w groupings, with original double hung windows, apparently opening onto individual rooms.
8. Significance: Built in 1917 by Otto Huechling an early settler who homesteaded near here about 1870 and lead the construction of two irrigation ditches. It is located directly in front of the house of Dr. Granville Wood and probably reflects the consolidation of two early homesteads into a single ranch/farm.

This house is an excellent example of a hipped-roofed, center hall plan house type with extensive porches which has been identified in southern Arizona but has not yet been studied in southern New Mexico and meets Register Criterion C. It reflects not only the prosperity which the valley experienced by the turn-of-the-century, but also the diffusion of cultural forms from the South into New Mexico.

Verbal boundary: A rectangle, roughly 75' by 65', formed by lines parallel to and ten feet from the exterior walls of the building. Since this is an unplatted area, this boundary has been created to include only this house.
