Summary Paragraph

The spring of 1894 was an exciting and busy time for a dozen of the Tipton business leaders. Numerous meetings produced a stock company of 12 men who each subscribed to \$1,000.00 worth of stock. Public notice of their efforts appeared in the Tipton Advertiser, the first week in June 1894. Site choice was in the north end of Block Ten fronting on Cedar Street of Tipton. The hotel frontage of 101 feet lies on Cedar with a depth of 70 feet. The Sixth Street side (the north side of hotel) has a frontage of $142\frac{1}{2}$ feet back to the alley with a depth of 30 feet 5 inches.

Early in the stock company's plans a multi-storied building was a requisite. The lure of stable rents from storekeepers on the ground floor would provide additional and welcome income to the enterprise. The <u>Tipton Advertiser</u> proclaimed it would be a magnificent improvement to <u>Tipton and urged</u> the stock holders to "push on".

After visiting several architectural firms, H.W. Zeidler of Muscatine was engaged. It was the consensus that the ground level contain an office 20 feet by 30 feet including the lobby therein, with a dining room 30 feet by 40 feet. In addition provisions for a hall, kitchen, sample room, water closets and a washroom. The second story would house some 35 rooms plus service rooms. With a roughly calculated cost in excess of \$20,000 for the building and lots the stockholders were realistic that their enterprise would not generate personal riches but instead would meet the public need for such a facility.

By late July 1894 in the excavation for the cellar six teams were transporting about 100 loads of dirt per day. Near the end of July Kelley & Mahan of Davenport took the contract for \$15,997 excepting excavating, external sewer system, steam heating and electrical. The same day Foley & Mahan of Davenport took the contract rical. The same day Foley, Paul and Company of Cedar Rapids garnered the brick and stone work. This large hotel contract was appealing to the building trades for 19 general contractors bid the job.

In a push the cellar and footing excavations were completed on August 10. A railroad carload of vitrified sewer tile some 600' arrived from Carbon Cliff, Illinois on the Burlington, Cedar Rapids and Northern Railroad on August 8. At the same time sand and stone was unloaded from Senator Green's quarry at Stone City in Jones

County. Albertson & Spence of Washington, Ia. were awarded the plastering contract. O.C. Hardman of Tipton was low bidder on painting.

Three rail carloads of face brick for the two street side walls arrived on September 11, 1894 via the B.C.R.&N. Railroad from Muscatine. The balance of the brick was provided by Ketrell Brick Yard of Tipton from nearby deposits. A teamster company Williams, McCracken & Comstock hauled the brick and sand from the railroad yards. Fifteen men were working by September 20 and foundation in. First brick laid September 22.

Most large construction projects experience some changes in plans. This hotel was no exception. When complete the grade level facing Cedar Street contained 4 retail units, hotel office on the corner, closets, sample room, dining room, kitchen and pantries. On the second level 35 bedrooms, parlor, sitting room, 2 bathrooms and a sample room. In the basement a furnace room, laundry room, a cellar for the hotel, plus a cellar for two of the store-rooms. Among the other features steam heat, a gravel roof and plate glass windows.

The stock company reorganized in late December 1894 and was up to capital assets of \$25,000. A formal opening was on evening of March 27,1895. A banquet was followed by an elegant ball featuring Professor Busse's Chicago Orchestra of 10 pieces both brass and strings. As they danced all in attendance were delighted. In 1906 the hotel owners were calling themselves the Tipton Hotel Company. Cold and hot water were installed in most of the rooms in the summer of 1931.

This mecca for the traveling man and the permanent guest as well faded in the sunset on October 1, 1976 when Hotel Tipton closed its doors. The decision to this action was driven by falling profits, the heavy burden of potential remodeling to update the sleeping rooms, etc. The mercantile operations on the first floor were viable and continued.

After 1976 the hotel property was exchanged several times. Today 1998 there are 2 owners. The most recent landlord owns two thirds of the original building, the second owner the balance. Currently some of the second floor single rooms are being converted into apartments as Hotel Tipton will continue to provide living quarters for the general public. All were 9'x12'9'' long on north side. On south $9'x9\frac{1}{2}'$. Doors 32'' x84" with transoms, casings $4\frac{1}{2}''$. Plastered interior walls $5\frac{1}{2}''$. Hallway 4' wide - ceilings 128''.

STATEMENT OF SIGNIFICANCE

Summary Statement

The Tipton Hotel is eligible for the National Register under Criterion "A" as a commercial landmark which has been both the centerpiece of the north end business district and the largest hotel building in Cedar County. This "L" shaped brick building with exposure on two principal streets was built by a group of civic minded leading citizens of Tipton. It was their response to a perceived need for a facility to more adequately address the requirements of the traveling public, as well as Tipton residents needing shelter for various periods of time. Incorporation of retail space insured achievement of their vision.

D.B. Kenahan of Mason City secured a five year lease to the new hotel in early December 1894. Tipton tenants began to move into the ground level space at the same time. Mr. Little moved his furniture shop into the most southern storeroom, in addition to the rear part of the storeroom north of him. Elated with the choice quarters he added an undertaking department to his furniture shop. In this period of history it was common for a furniture store and the undertaking service to be carried on as a joint enterprise - wooden furniture and wooden caskets had a commonality for many years. The front portion of the room north of Little was leased to the post office. A grocery man, Dargets, controlled the lease on the third room from the south edge of building.

The new hotel helped boost Tipton's reputation. In early December 1894 the editor of the Mason City Times Herald (Kenahan's home town in an editorial congratulated Tipton for securing a man of Kenahan's caliber to be the landlord of Hotel Tipton "The editor pondered this question - How could a town such as Tipton with only 2,000 population build such a hotel and draw such a landlord? Why couldn't Mason City with her 6,000 people and a landlord like Kenahan already in residence do something in this line? Tipton is the county seat of Cedar County. It is considered one of the most enterprising towns in the state for its size. The building of the new hotel proves its hotels make a town popular."

The lure of appealing food draws people and their patronage to a certain area. The following accounting achieved this purpose. The Knights of Pythias in late February 1895 enjoyed a banquet and program at the new Hotel Tipton. Landlord Kenahan served a banquet to 228 guests, one hundred seated and served at a time.

An amazing menu was presented to the guests: Fish and oyster patties. Meats included turkey, beef, ham, tongue and veal. Salads were chicken, lobster, potato, cabbage, lettuce and beets. The confection menu included cream puffs, macaroons, kisses, lady fingers and chocolate slices. Fruits offered were oranges, apples, bananas and figs. In the breads a choice of cream, rye and graham. Entrees were celery, sage cheese, olives, radishes and mixed pickles. For dessert a choice of ice cream, assorted cakes and coffee.

Satisfied patrons advertise not only the hotel but the entire town as well. In October 1899 a man who travelled extensively and considered to be a connoisseur of hotels stated that "Hotel Tipton was one of the best \$2.00 a day hotels in this area of the state. He was exuberant about the structure of the hotel and particularly impressed by the perfect system of electric bells incorporated in the hotel." All rooms were outside rooms and provided with electric lights. Centrally located in the business district of Tipton and sported a first class barber shop as well as other features of an appealing nature to a traveling man.

The 1901 Cedar County Atlas on Supplement Page 8 carried an ad as follows: Hotel Tipton - O.A. Bleasdale, Prop. - Nothing Too Good For Our Patrons - Thoroughly Refitted - Good Table. In November 1906 Bleasdale announced he would sell meals to all Cedar County residents for 25 cents.

Not only did Hotel Tipton serve the many travelling men who came to the town to offer their products to the local merchants, it also served a percentage of local people who regarded it as home for varying periods of time. An example (although not typical) would be Ed Drake who stopped there on October 1, 1900 and occupied the same room until he died there in early October 1939.

In June 1939 Mrs. W.W. Weatherwax of Clarence was staying at Hotel Tipton while receiving medical treatment from a Tipton doctor for a scalp infection.

The Lantern Room was operating in 1939. This was a pleasantly large room in the hotel where a rather wide spectrum of Tipton and Cedar County people would gather for a wide variety of occasions. One might view it as the ancestor of the typical community rooms of the 1990's. Over its many years of service it was variously known as the Tipton Tea Room, Coffee Shop, The Lantern Room, Hotel Cafe, etc. During World War II days it was used by the local rationing board. In 1946 it returned to its normal usage.

A book in paper wraps printed for the celebration of Tipton Centennial in 1940 contained a picture and text depicting the relationship of Hotel Tipton and the community. They posed the question in this manner - "How does a hotel aid a community?" Their reply was -" We operate a clean comfortable room service to attract the traveling men who in turn bring business to Tipton. We furnish rooms for guests when your home is crowded. We have facilities for luncheons, club dinners, meetings and parties. We serve delicious Sunday Dinners and operate as modern and up to date Coffee Shop as you will find in any small community."

For over a century Hotel Tipton has been an anchor for the north end of the business district of Tipton - "a city within a city". On the grade level this hotel over the span of years offered many of the basic commodities and services required by Tipton residents. A partial list includes Lester Voss IGA Grocery - John Bender Meat Market - Pieruccini Confectionary - Elmer Peters Electric Motors - Klosterman Barbershop (in which C. Webb, a Negro Spanish-American War veteran, set up a shoe shining bench upon his return from the war. The Clothes Line - a succession of food serving businesses such as the Lantern Room Coffee Shop - Hotel Tipton Cafe - Baugh & Patersons Cafe - then U.S. Post Office - Littles Furniture & Undertaking - Foens Shoe Repair. Even after the hotel stopped providing sleeping quarters the retail stores continued.

Hotel Tipton is the largest hotel building in Cedar County and since early in its existence known as a landmark of the city. Its location on the main street of Tipton which is also Highway #38 has resulted in its use as a reference point when giving directions to those unfamiliar with Tipton.

FUNERALS HELD AT HOTEL TIPTON

Having written a societal history of Cedar County entitled Chronicles published in 1996, I was quite surprised when late research revealed that there were at least two men for whom funeral services were conducted in Hotel Tipton.

Joseph A. Patterson, age 68, died in Tipton and probably at Hotel Sunday noon February 9, 1936 from an intestinal obstruction. The funeral service was held at Hotel Tipton Wednesday afternoon February 12, 1936, burial at Red Oak Cemetery. At the time of death he was operating a butcher shop in one of the commercial stores in Hotel Tipton building. At this time his wife was manager of Hotel Tipton.

Edward Drake, age 77, died September 30,1939 of acute parotitis. He had lived at the hotel since October 1, 1900. Funeral services were held in the hotel at 2 pm October 2, 1939. Burial at Tipton Masonic Cemetery.

The nominee, Hotel Tipton, occupies lots Five and Six in Block 10 of the original town of Tipton. The east elevation fronts on Cedar Street while the north elevation is on Sixth Street. Refer to sketches attached.


VERBAL BOUNDARY JUSTIFICATION

The boundary justification is substantiated by the prescence of Cedar Street on the east side and Sixth Street on the north side. A north to south alley defines the west boundary. The north boundary of Lot Four completes the enclosure of Lots 5 and 6. The sketch provided depicts the configuration of the hotel building itself.




