South Carolina Inventory of Historic Places Description

Aiken Winter Colony Historic District I consists of approximately thirty-five properties constructed between ca. 1882 and ca. 1948, which include residences, outbuildings, golf courses, school buildings, and equestrian sporting facilities constructed between ca. 1882 and ca. 1948. The area is characterized by tree-lined streets and unpaved roads, large mansions with outbuildings and expansive lawns, and stables. In addition, the district includes the Highland Park and Palmetto golf courses and Hitchcock Woods. Most of the residences, which exhibit a variety of sophisticated architectural styles, were constructed between 1900 and 1930, during the golden era of Aiken's Winter Colony. The district retains integrity from this period.

Sich, ficance

Aiken Winter Colony Historic District I is significant as the area in Aiken most closely associated with the Winter Colony and the horse industry. The district contains many of the properties most important in the history of the Winter Colony including residences constructed by Winter Colonists between ca. 1900 and ca. 1930; the Whitney Polo Field, established in 1882; and the Palmetto Golf Course, begun in 1892. Also included is Hitchcock Woods, developed around the turn of the century for riding and fox and drag hunting.**

Verbal Boundary Description The boundary of the historic district is shown as the black line on the accompanying map of the city of Aiken, South Carolina, drawn at a scale of 1 inch equals 1,000 feet. It includes the largest concentration of resources associated with the theme as possible and excludes as many noncontributing properties as possible.

Many of the properties in the district are associated with key figures in the development of the Winter Colony including Devereux Milburn (#16), Mr. and Mrs. Oliver Iselin (#12), Seymour Knox (#30), and Ambrose Clark, owner and trainer of race horses (#23). A number of the properties in the district are architecturally significant including designs by Willis Irvin (#s29, 7, 19), Scroggs and Ewing (#s 25, 33, 18) and Julian Peabody (#s 8, 15, 16, 30).

Key properties which establish the character of the historic district:

- 1. Hitchcock Woods: approximately 1400 acres of wooded land developed for equestrian activities by William C. Whitney, F.R. Hitchcock and Thomas Hitchcock around the turn of the century. The woods contain drag lines for fox hunting, trails for jumping, and a horse show ring.
- 2. Highland Park Golf Course, (Highland Park Drive): constructed ca. 1912 by the Highland Park Development Corporation as a short, narrow, rolling course. Included in this property are the ca. 1925 clubhouse, a small brick building that served as the laundry for the Highland Park Hotel, and a modern swimming pool and small brick building.
- 10. Rye Patch (corner of Berrie Road and Whiskey Road): constructed ca. 1900, but later remodeled and enlarged; two-story, frame, weatherboarded residence; hipped-roof with plain boxed cornice; fenestration is varied and includes diamond-paned sashes; asymmetrical facade (east elevation) features a single paneled door sheltered by a small pedimented porch; rear (west elevation) features a two-tiered porch with chamfered posts and two two-story polygonal projections; estate property also includes stables and paddocks, guest cottage, laundry house, garage, clay tennis courts, and a high brick wall which was constructed in 1928.
- 11. Sandhurst (215 Dupree Place): built ca. 1900; two-and-one-half-story, frame, weatherboarded residence; irregular plan, truncated hipped roof with entablature with dentil course and modillions; varied fenestration; facade (north elevation) features a monumental pedimented portico with Corinthian columns and pilasters.
- 12. Hopelands (Aiken Thoroughbred Racing Hall of Fame) (corner of Dupree Place and Whiskey Road): This property contains the stable and garage, two servants cottages, greenhouses, and the serpentine brick wall associated with Hopelands. The main house was demolished ca. 1970; the outbuildings probably date from ca. 1900; the brick wall was constructed ca. 1930.
- 15. Hassler Cottage (621 Magnolia St.): built ca. 1930; two-story, brick-veneered Colonial Revival residence; irregular plan; six-over-six windows; hipped roof with cornice with modillions; facade (east elevation) features a central entrance; also on property are an indoor tennis court, one-story cottage with garage, and a high brick wall.
- 16. Devereux Milburn House (627 Magnolia St.): built ca. 1931; H-shaped stuccoed residence; six-over-six windows; multi-gabled roof with entablature; grounds contain a frame stable and one-story, stuccoed building.
