HISTORICAL NARRATIVE (FROM ORIGINS TO PRESENT): This address is listed for the first time in the city directory of 1902. Elisha P. Dismukes (and his wife, Annie) are listed at this address That year, he was vice-president of Georgia Manufacturing Co. (makers of pants, overalls, hosiery, etc.). The Dismukeses are listed at this address again in 1904, but in this listing, Dismukes is president of "Dismukes Grocery Co." (on Broad St.). In 1906, Dismukes is president of Georgia Manufacturing Co., and vice-president of Albright Manufacturing Co. (on 5th Ave.). By 1908, he's president of "Columbus, Georgia Buggy Co.," and "Georgia Manufacturing Co.". Dismukes remained at this address until 1918, the year that his son, E.P. Dismukes, Jr. (cont'd

STATEMENT OF SIGNIFICANCE (ARCHITECTURAL AND HISTORICAL): Local History: This house is significant as it was apparently built for Elisha P. Dismukes around the turn-of-the-century, Dismukes, who was president of the Georgia Manufacturing Co., Columbus, Georgia Buggy Co., and Dismukes Grocery Co. Architecture: Significant as a late Victorian structure where the builder experimented with classical revival features such as the 1/1 sash windows, classical revival porch, and qualons. This house is the only residential structure in the MRN area to employ quoins of this type.

IV. Significance

Local History: While this house is not outstanding, it is certainly significant to local history as the home of Elisha P. Dismukes. The importance of the Dismukes family to the development of Columbus cannot be over stressed. E.P. Dismukes was heavily involved in several companies which are listed in section III, History. The family today remains one of the most prominent in Columbus based on the early work of E.P. Dismukes. The minor repairable alteration to the front porch of this house bears little effect on the significance by association this structure holds.
