DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Marvin Newton House is situated in Brookfield, Vermont, on the Ridge Road, formerly a major stage route between Randolph Center and Brookfield Village (entered respectively on the National Register: 21 November 1974 and 28 March 1974). The house, remarkably unaltered, evokes a sense of the past and exemplifies a building tradition which, in many respects, has disappeared.

Built c. 1835, the Marvin Newton House is a late vernacular translation of the Federal style. With 2½ stories and 5 x 2 bays, the symmetrical elevations are capped by a gable roof. Originally there were two interior chimneys; now only the south flue continues above the roof. The standing seam roof covers an earlier wood shingle roof. There are no eaves overhanging and the molded cornice has short returns which are actually flush. The windows have retained their original 12/12 lights and plain surrounds. The central frontispiece has simple pilasters supporting an entablature with a projecting cornice shelf below which is a transom; the door itself is not original and was probably placed there c. 1900. The south side has an entrance to the kitchen which does appear original. The clapboard siding remains unpainted.

The interior of the house is based upon a central hall plan with the front half logically having two larger rooms while the kitchen and a smaller room are in the back. The two rooms on each side of the hall share chimneys as the fireplaces are placed back-to-back. The front rooms have decorative mantelpieces with reeding in the entablatures befitting "public" rooms of the house. Upstairs, only the master bedroom has a fireplace; the other bedrooms were fitted with stove pipes. The master bedroom also has traces of graining remaining on the floorboards. The interior's fabric remains largely unaltered: almost all of the original hardware, floorboards, molding, and woodwork remain intact.

One of the more interesting features of the house is the framing system in the attic that supports the roof. Braced purlins, set at 45° angles, lend support to the roof rafters which are connected to a ridge pole. While this was a common structural design in barn buildings, it was rarely used in houses.

Attached to the rear of the house is a 1-story ell which was built in 1854. The room in this ell has been sided in weathered barn board on the interior to provide a rustic backdrop for the display of the tool collection owned by the Historical Society of Brookfield.

To the rear and left of the Marvin Newton House is a carriage shed which was moved to this site in 1970 from East Randolph. Because of the date of this reconstruction; it does not contribute to the original historic character of the house.

STATEMENT OF SIGNIFICANCE

The Marvin Newton House is significant as a 19th century Federal style structure which has essentially remained intact. While unpretentious and devoid of any outstanding architectural detail, this house is a good example of a common building design and is important for interpretation because it has been largely unaltered.

Records and accounts pertaining to Marvin Newton, a blacksmith, indicate that his house was probably constructed in 1835. The date is significant because by that time the Greek Revival style had superceded the Federal style in popularity yet, Newton, or perhaps a builder, chose to build in the latter, more conservative style. Federal style features include the proportions of the building, fenestration placement of the 12/12 sash (original), the relatively light and delicate door encasement, and the narrow, plain cornice. It appears that the clapboards have never been painted. The only exterior alteration seems to be the removal of the exterior portion of the left interior fireplace chimney and the front door which is not original. The interior, with the exception of some wallpapered walls, reflects a modest and simple 19th-century lifestyle.

The house was bequeathed to the Historical Society of Brookfield, Vermont, Inc., in 1937 by descendants of Marvin Newton and is open to the public during the summer months.
