## Describe the present and original (if known) physical appearance

The Tuscumbia Historic District contains 639 properties that represent a diversity of residential, commercial, institutional, recreational buildings and sites associated with over 150 years of development in the city of Tuscumbia. The district is roughly located in an area that incorporates much of the town's original 1817 street plan. The district includes the 1973 Colbert County Courthouse Square District which detailed 22 buildings, two of which were subsequently torn down, out of approximately 160 that were located in the 20-block area. The Tuscumbia Historic District contains, overall, sixty-five complete blocks and thirty-one partial blocks with streets running in a North-South, East-West grid pattern. The district is bordered on the north by the North Commons, on the east by a small section off East Commons; on the south by Eighth Street, and on the west by Hooks Street and encompasses an area covering approximately 304 acres.

There are 461 or 74% of the buildings and sites of domestic, commercial, institutional, industrial and recreational use that are currently contributing or potentially contributing to the character of the district. Of these properties 326 or 51% are currently contributing properties, and 145 or 23% are potentially contributing to the character of the district because of the use of artificial siding, of some type, covering original wall treatment or because of reversible alterations. There are 169 or 26% of the buildings that do not contribute to the character of the district because of age (less than fifty years) or because of irreversible alterations.

Included within the district are two geographical features which have strong association with the development of Tuscumbia, these being Spring Park and the North Commons, which is the last undeveloped site representing the original boundary of the town. Located on the Commons is Deshler Stadium (#6) which was constructed in 1941 as a major Works Progress Administration project for Tuscumbia.

Domestic architecture found in the district includes several Tidewater-type cottages, which date from the 1820's and 1830's and are the earliest folk-house type found in the district; Greek Revival, although of very limited number; Queen Anne; Folk Victorian; Bungalow Style as well as Tudor. Also present are examples of houses that do not display any particular style.

The institutional architecture of the district includes the oldest church in the district, the 1827 Federal Period, First Presbyterian Church (#344) and St. John's Episcopal Church (#183). St. John's Episcopal Church, completed in 1852, is an example of Carpenter Gothic found in the district and is the oldest known religious building displaying this style in Alabama. Almost at the center of the district is the Courthouse Square, which has been the site of the Colbert County Courthouse since 1881. The present courthouse (#247), built in 1909, utilized the brick walls of the fire-gutted 1881 courthouse and displays an Ionic portico and distinctive clock tower.

The commercial area of the district includes several of the oldest known commercial buildings in Alabama. These are the Morgan-Donilan Building (#326), a simple 2½ story brick building constructed in 1825, and a group of seven contiguous, two-story brick commercial buildings (which were built in the mid-1830's) known as "Commercial Row."

**Statement of Significance (in one paragraph)**

Criterion A - Politics/Government

The Tuscumbia Historic District is significant for its association with government thru its service as the county seat of Colbert County. Tuscumbia first served as county seat after Colbert County was created in February 1867 until its abolishment by the State Constitutional Convention of November 1867. In December of 1869 Colbert County was again created by the Legislature and Tuscumbia has served as county seat from that time on. Since 1881 the block on which the present (1909) courthouse is located has been the site of the Colbert County Courthouse.

Criterion B - Politics/Government

The Tuscumbia Historic District is significant for its association with several government and political figures of city, county and state significance who have lived within its boundaries. These figures include Robert Burns Lindsay, Alabama's only foreign-born governor, who was elected as a Conservative Democrat in 1870 over Republican William Smith. Edward B. Almon is another figure of political significance who lived in the district, having served in the State Senate, was Speaker of the Alabama House and served as a Circuit Judge. Almon was also a member of the U. S. House of Representatives and was instrumental in the development of the Federal Highway System, the construction of Wilson Dam and the Nitrate Plants at Muscle Shoals, and in the creation of the Tennessee Valley Authority. Other political and government figures who have lived within the district include: Archie Carmichael (#576) who served as a state legislator, was a candidate for governor in 1926, and succeeded E. B. Almon in the U. S. Congress; John Anthony Steele (#88), who served as Colbert County Probate Judge, as a member of the state legislature and as a member of the Secession Convention of 1861; William Cooper (#487) who was also a member of the Secession Convention of 1861 and was appointed by Gov. A. B. Moore in December 1860 as a special commissioner to the state of Missouri, to advise that state on its actions regarding secession; Charles Womble (#246) who was the first Probate Judge of Colbert County; William R. Julian, who served as Colbert County's first sheriff; and Philip G. Godley (#169) who served as Tuscumbia's first mayor.

Criterion C - Architecture

The Tuscumbia Historic District is significant for its architecture, both domestic and commercial, which represents a sweep of styles and types spanning a period of over one hundred years. The district contains a diverse collection of domestic architecture that ranges from the Tidewater-type cottages which are the oldest houses in the district. These houses illustrate the influence of early house types transplanted from the upper seaboard southern states of Maryland and Virginia, an area from where most of Tuscumbia's early settlers immigrated. Greek Revival, although of very limited influence on the


The majority of the district's commercial buildings date from the late 1880's thru the early 1930's. Many of the late 19th century buildings display decorative storefronts that are characteristic of the late Victorian period and are best illustrated by the Palace Drugstore (#449). The early 20th century commercial buildings are one or two story, of brick construction and display relatively simple storefronts with little of the ornamentation found in the late Victorian buildings. Also found in the commercial area are examples of early 20th century Commercial Brick and an example of Beaux Arts Classicism, the Clark Building (#249).

Tuscumbia's early 20th century agricultural-based industrial economy is represented by the only industrial complex in the district, the Tuscumbia Cotton Oil Company/Ware Brothers (#223) agency complex with its brick industrial buildings that were constructed around 1910. Located behind the complex is a series of small simple frame mill workers' cottages which date from the early period of the mill's operation.

Of the buildings located within the Tuscumbia Historic District 14% are presently used for commercial or institutional purposes and the remainder are of residential use.

  - b. Plantation office, one-story frame, side facing gable roof, bay window to side. Built by David Keller around 1820. Home of Captain Arthur Keller, Confederate Officer and editor of the "North Alabamiam"; early childhood home of Helen Keller. Listed on National Register.
  - c. Log cabin, c. 1826; one story log, dog trot, with side facing gable roof, with sandstone chimney on each gabled wall, moved from Bear Creek Watershed in 1981 to present site.
4. 208 W. North Commons: c. 1870; one and one-half story frame dwelling
5. 107 E. North Commons: c. 1888; two-story frame Queen Anne, hipped roof with cross gable and lower front facing gable.
6. 200 E. North Commons (Deshler Stadium): c. 1941; Stadium with athletic field, native stone utilized in construction of stands. Exception to 50-year criterion; major Works Progress Administration project in Tuscumbia.
9. 507 N. Milton Street: c. 1920; one-story frame bungalow with front facing clipped gable roof, and lower hipped porch supported by three straight columns; triangular braces under eaves of gable.
14. 508 W. First Street: c. 1920; one-story frame bungalow with front facing gable roof and offset front facing gabled porch supported by two brick columns, triangular braces and exposed rafter tails.
19. 407 Almon Avenue: c. 1930; one story, native stone wall covering, side gable roof with offset gable porch supported by stone columns, exterior chimney.
20. 405 Almon Avenue: c. 1910; one story frame, hipped roof, inset porch supported by three wooden columns on brick piers.
21. 403 Almon Avenue: c. 1910; one story frame, with front facing hipped roof, centered hipped dormer, inset porch supported by three tapered wood columns on brick piers.
22. 410 W. First Street: c. 1900; one story frame, side gable roof with full length porch.

44. 110 W. First Street: c. 1920; one story frame bungalow, side facing gable, with offset front facing gabled porch supported by three tapered wooden posts on brick piers, exterior chimney.
46. 501 N. Main Street (Owen Julian House): c. 1884; one story frame, side facing gable, with centered shed dormer, enclosed hipped porch, gable extension at rear. Constructed on site of Barclay House destroyed by tornado in 1874.
47. 503 N. Main Street: C. 1920; one and one-half story brick bungalow, side facing gable with large front facing gable with offset lower gabled porch with tapered supports on brick piers, shed extension at rear.
48. 509 N. Main Street (McReynolds House): c. 1880; two story frame Queen Anne, hipped roof with front and side projecting gables, hipped porch across front and side, porch supports with decorative brackets, spindle work porch balustrade and frieze, gable wing at rear with cross gable at rear, prominent chimneys.



95. 201 W. Second Street: c. 1920; one and one-half story frame bungalow, side facing gable with large center gable dormer franked by small rounded dormers, exposed rafter beams, triangular braces, porch across front and sides supported by heavy pre-cast block posts.

domestic architecture in the district, is also found as well as a unique example of Carpenter Gothic. Late Victorian styles such as Queen Anne are also found although the majority of the houses from this period are the simple Folk Victorian type. The district also contains a large and varied collection of early 20th century Bungalows which are representative of a major period of growth for Tuscumbia. The architecture found within the commercial area illustrates the town's development as a local commercial center from the late 1820's thru the early 1930's. The Morgan-Donilan Building, the state's oldest known commercial building, dating from 1825, as well as "Commercial Row" which dates from the 1830's, represent a period when Tuscumbia was one of the most important trade centers of the Tennessee Valley. Also exhibited in the commercial area is a fine collection of buildings that date from the late 1880's thru the early 1930's representing Tuscumbia's revival as a local trade center. These buildings include late Victorian period structures that display High Victorian treatment of store facades, early 20th century Commercial Brick, as well as examples of Beaux-Arts Classicism.

Criterion A - Commerce

The Tuscumbia Historic District is significant as an area trade center during the period from the 1830's thru the 1850's and as a local commercial center during the late 19th and early 20th centuries. The 1830's thru the 1850's witnessed Tuscumbia's rise as an important trade center for the large area of the Tennessee Valley. This trade, based on cotton and made possible by the development of the earliest railroads in the state, created a period of economic growth for the commission merchants of Tuscumbia as goods were imported from New Orleans to be sold locally or to other markets in the Valley region. Beginning in the late 1880's, after a long period of severe economic depression following the Civil War, and continuing into the 1920's, Tuscumbia regained much of its importance as a local commercial center. This resurgence was the result of the industrial boom experienced by the neighboring city of Sheffield and the introduction of agricultural-based industries such as the Barton Agricultural Works and the Tuscumbia Oil Company into the city. These combined industries employed hundreds of workers from Tuscumbia and brought a new influx of capital into Tuscumbia that stimulated business and created growth in the commercial district.

**HISTORICAL SUMMARY**

**Tuscumbia Historic District**

The first white settlers of Ococoposa, what would even become Tuscumbia, settled at the site of present day Spring Park in 1815. By 1817 the little village consisted of three houses, a mill and a store. In 1821 the name of the town was changed to Big Spring and then to Tuscumbia the following year.

The first major immigration of white settlers into the Tuscumbia area began in the early 1820's primarily from the seaboard southern states of Virginia and Maryland. The early settlers constructed houses which utilized the folk house form with which they were accustomed; the Tide-water type cottage, which was most commonly a story-and-a-half structure with gable roof, dormer windows and prominent end chimneys.

The 1820's and 1830's witnessed the development of the Tennessee Valley into one of the major cotton-producing areas of Alabama. Planters up river from Tuscumbia were at a severe disadvantage in shipping their cotton to market by river because of the un-navigable Muscle Shoals. In order to alleviate this problem, wealthy Valley planters, led by Benjamin Sherrod, initiated the construction of a railroad to bypass the Shoals. This railroad, the Tuscumbia, Courtland and Decatur, ran approximately forty-one miles from Market Street in Decatur to 5th Street in Tuscumbia and junctioned with the Tuscumbia Railroad, which ran approximately two miles from the center of the commercial area to Tuscumbia Landing. The completion of the Tuscumbia, Courtland and Decatur Railroad in 1834 opened, for planters above Tuscumbia, access to cotton markets in New Orleans via the Tennessee, Ohio and Mississippi Rivers by steamboat from Tuscumbia Landing. This thriving trade created a period of economic growth for the merchants of Tuscumbia as goods from New Orleans were brought in by steamer for sale to local residents, planters and farmers or for distribution to other markets in the Tennessee Valley area. The Tuscumbia, Courtland and Decatur Railroad fell victim to the Panic of 1837 and to high construction costs of approximately \$5,000 per mile, and declared bankruptcy in 1837. The line continued to operate as the Tennessee Valley Railroad until it was acquired in 1851 by one of the most important railroads in the antebellum south, the Memphis and Charleston Railroad, for use as that line's principal route through north Alabama.

During the 1840's soil exhaustion in the Valley caused many planters to immigrate to other, more fertile, cotton lands in other parts of Alabama as well as other southern states. This exodus resulted in a period of stagnation in the development of the area as large land holders, who had remained, increased their holdings by acquiring vacated tracts of land. An early reference to Tuscumbia is found in an entry from the diary of William Joseph Camp who came through the town on October 6, 1860 while traveling through north Alabama to Texas.

"This morning we geared up and started on our journey. After about a mile, we came to Tuscumbia, which is a very old place, built in the old style. The fairgrounds were beautifully situated on a small creek..."

The fairground noted by Camp was located at the present day Spring Park. This park has been used throughout its history as a fairground, exhibit area, meeting place, drill field for military units, and as a bivouac for federal troops during the Civil War.

The Civil War brought great destruction to the Tennessee Valley as Federal and Confederate armies occupied the region several times. Captain Arthur Keller described the destruction in the Tuscumbia area.

"There was no part of the South more completely devastated than was the beautiful Tennessee Valley. Tuscumbia was in the center of the fiery, desolating track of the armies of both sides. Large blocks of brick stores and many houses were destroyed and condemned. Cavalry horses roamed at will through grounds that were formerly the pride of their owners."

Tuscumbia was recovering from the devastation of war when it was again struck by disaster, this time from the forces of nature. On Sunday night, November 22, 1874 a killer tornado ripped through Tuscumbia. Captain Arthur Keller's paper, The North Alabamian, described the disaster that had hit the town.

"Over one-third of our town is laid in ruins...several large and elegant brick mansions and a large number of frame buildings were totally destroyed. Many buildings were also more or less injured. The fairground buildings and two mills were also destroyed...The amount of property destroyed is estimated at from \$200,000 to \$250,000...More than sixty houses being wrecked or destroyed."

Tuscumbia's depressed economy began to recover during the late 1880's and the 1890's as the town received beneficial effects from the industrial boom experienced by the new neighboring city of Sheffield. Other factors that contributed to Tuscumbia's economic recovery were the introduction of agricultural-based industries such as the Barton Agricultural Works in 1898 and the construction of the Memphis and Charleston Railroad (now controlled by the Southern Railroad) car and locomotive repair shop in the Tuscumbia area in 1898. The combined industries located in the area employed hundreds of Tuscumbia residents and introduced new sources of revenue into the town's commercial area. The new-found revenue stimulated business and led to the resurgence of Tuscumbia as a local commercial center.

During the last decade of the 19th century and the first decade of the 20th century, many new houses were built in Tuscumbia to meet the demands of the population. Many new modern services were introduced into the Tuscumbia area. These services included a street car line between Tuscumbia, Sheffield and Florence, a telephone exchange, electrical power system and a water system between Tuscumbia and Sheffield.

The period from 1910 thru 1930 saw continuous development in both the residential and commercial areas. Tuscumbia gained a new agricultural-based industry during the period as the Tuscumbia Cotton Oil Company was founded. It was sold to Nicholas and William Ware who continued to operate the complex as a cotton oil factory and then expanded the operation in 1926 to include a fertilizer factory. Also during the period a major portion of the housing within the district was constructed, utilizing the bungalow-style, some of which used sandstone from local quarries in the construction.

During the 1930's thru the early 1940's, development in Tuscumbia was effectively slowed because of the Great Depression. The major development during the period was the Works Progress Administration projects of Deshler Stadium in 1940 and Spring Park.


