

Describe the present and original (if known) physical appearance

The Harrison B. Brown House of Portland, dating from 1861, is a vernacular example of the Italianate style.

The two-story building is of frame construction with two internal brick chimneys, hipped roof, bracketed cornice, clapboard siding, and brick foundation.

The 3-bay facade faces north-west and features a central entrance with enclosed projecting entry capped by **a** later added simple balustrade. The sides of this entry are fitted with elaborately framed oval windows. Fenestration is 6/6, save for the pavillioned left bay which consists of paired 4/4 windows.

The north-east side of the house is 3 bays long with 6/6 fenestration in the second story, and an elaborate projecting bay to the right side of the first story. The south-west side of the building is 2 bays wide, with 6/6 sash in the second story, and projecting bracketed bay windows below.

A two story ell in the rear contains a studio with large floor to ceiling windows overlooking Portland Harbor.

Statement of Significance (in one paragraph)

This property derives principal significance as the residence during most of his productive career of Harrison B. Brown, widely recognized 19th century marine and landscape painter.

Born in Portland in 1831, Harrison Bird Brown was orphaned at an early age and, leaving school, was apprenticed to a house and ship painting firm. His creative powers early demonstrated themselves in the drawings and paintings with which he covered the walls of the shop where he worked as well as every available scrap of paper.

Following his apprenticeship, he entered business for himself as a "sign and fancy painter" doing "oil graining, imitations of woods and marbles executed in the neatest manner". As a sideline at first, he produced landscapes and portraits and was encouraged in the former by Portland's art critic, John Neal. Brown soon began concentrating on the depiction of nature and was first listed in the Portland Reference Book in 1858 as a landscape painter.

His success seems to have been almost immediate. Between 1858 and 1860 five of his pictures, borrowed from their owners, were shown at the National Academy of Design in New York. Thereafter he was the only Maine artist of his day to exhibit there.

As his career became established he acquired numerous pupils including the sculptor, Franklin Simmons, and the animal painter, Scott Leighton.

Brown's output was large because he depended on the sale of his paintings for an income to support the fairly high standard of living which his family seemed to demand. His best work dates from the 1860's and early 70's when his style was delicate and detailed and his colors rich and vibrant. Some of his later work had the feeling of studio potboilers.

He was perhaps best known as a marine painter and his painting of White Head on Monhegan Island was exhibited in the Maine pavilion of the Chicago World's Fair of 1893.

In 1892 Brown moyed with his family from Portland to London, England, where he died in 1915. The house, built by Brown in 1861, was his residence until his departure for England.
