Summary Paragraph

The Lowe Mill and Mill Village Historic District is a planned textile mill and mill village located in the southwestern portion of Huntsville. Unfortunately, unlike the Dallas, Lincoln, and Merrimack mill villages in Huntsville, the plan for Lowe is obscured to a fair degree by later development. The district is generally bounded to the north and west by two major streets, Governor's Drive to the north and Triana Boulevard SW to the west. Tenth Avenue SW generally forms the southern boundary and the eastern boundary is defined by the rear property lines of the resources fronting along Summer Street SW. The district encompasses approximately 142 acres and includes 392 resources of which 293 are contributing and 99 are noncontributing.

Narrative Description

The district began development in 1900 when the first portion of the extant mill facility was built, which was expanded in 1902, 1914, and 1928 when a three story addition was constructed with wide eaves and decorative wood brackets (Inv.#s 215-216, Photos #1-3). It remains one of only two extant textile mills in Huntsville and is the most intact of the two. The other mill, Lincoln Mill, retains only a portion of its historic mill complex. At the same time the mill was begun, Lowe Mill investor, board member, and planner Tracy Pratt began to build the residential village, which developed continually through the 1940s. By then, it was complete with the mill complex, a general merchandise store (founded circa 1882 before the mill and rebuilt circa 1925, Inv. #388, Photo #15), worker and middle manager's housing, churches, a 1915 Mission style YMCA (Inv. #87, Photo #14), small stores and commercial buildings, and the Art Deco style Centre Theatre (circa 1945, Inv. #387). Scattered infill development continued to occur through 1961 when the West Huntsville Baptist Church was constructed (Inv. # 385, Photo #20).

The mill facility occupies the southeast corner of the district bounded on its north side by Eighth Avenue SW and by Seminole Drive SW on the west. The southern boundary of the mill facilities, and the entire district, is Tenth Avenue SW where the residential village lies between First Street and the west side of Sixth Street. The western boundary of the district is primarily along Triana Boulevard (formerly Seventh Street), although the district extends one block west of Triana Boulevard to Eighth Avenue to include the McCormick Building (West

Huntsville YMCA, Inv. #87, Photo #19) and several houses as well as the circa 1895 Tracy Pratt Office (Inv. 188, Photo #17).

The residential portion of the district is anchored between the mill at the far southeast corner and by a concentration of most of the district's non-industrial and non-residential resources on its far west side. There, within one and one-half blocks of Triana Boulevard are all (with the exception of the mill itself) of the district's most architecturally important resources. Included are the J. D. Brown General Merchandise (Inv. #388, Photo #15); the Centre Theatre (Inv. #387, Photo #14); and a church with a crenellated roof and squared central loggia (Inv. #85).

Between the mill and the Triana Boulevard SW area are 349 residential mill houses laid out in a mostly scattered, random pattern with the exception of several concentrations of pyramidal roof duplexes on Ninth Avenue SW (see description for Type B, below; Inv. #s 141, 143, 145, 147, 149, 155, 157, 159, 161, and 163, Photo #5), T-plan houses also on Ninth Avenue SW (Inv. #s 144, 146, 150, 151, 158, 160, 162, and 166, Photo #7); duplexes on Eighth Avenue SW (Inv. #s 37-45, 47-48, 66-67, 69-70, 76, and 80, Photos #22-23); and circa 1915 to circa 1925 shotgun houses along Boardman and Summer Streets SW and Seminole Drive SW (Inv. #s 5, 9, 11, 13, 15, 18-27; 193-197, 200,203, 205-207, 209, 211; 349, 352, and 361, Photo #33). The largest collection of houses that can be grouped into a single type are described below under Type A (71 examples) and there are smaller groupings of other recognizable types (typically less than five examples each). Otherwise, the district assumes an eclectic layout and pattern containing a wide diversity of styles, although all are restrained in design and reflective of typical mill housing of the period.

The earliest houses were built at approximately the same time as the earliest mill facilities and adjacent to the mill along Ninth and Tenth Avenues. The Tracy Pratt office predates the village (Inv. #188, Photo #17) and the J. C. Brown General Merchandise store (Inv. #388, Photo #15) was established prior to the mill, although the present building appears to have been constructed circa 1925. Subsequent development occurred north and west of the mill with the latest development (circa 1935-1961) being essentially in the center of the district between Seventh Avenue and Governor's Drive and between First Street SW and Triana Boulevard SW.

Fifty-eight resources (15%) were constructed prior to 1920 including seven representing the Type A house form (Inv. #s 39, 41, 43, 45, 47, 48, and 67, Photos #22-23); sixty-four resources (16%), in addition to the McCormick Building (Inv. # 161, Photo #19), were constructed between 1920 and 1925; and 160 (41%) were constructed between 1926 and 1945. By 1921, there were approximately 200 residences in the village mostly north and west of the village forming, at that time, an irregular inverted L shape; there were few, if any mill houses north of Seventh Avenue. During the next few years, until the late 1920s, growth continued to evolve north and west, by the early 1950s the village attained its present generally rectangular shape.

Residential resources account for 282 of the district's 293 contributing resources (96%). Of these, 208 are classified as single dwellings, 72 as duplexes, and one as an apartment building. The majority of these are one story in height, with only three contributing resources being one and one-half stories (Inv. #s 242, 263, and 307) and two being two stories (Inv. #s 154 and 165). The predominant residential building type is frame, historically clad with wood novelty siding or weatherboards, although there are scattered brick, stucco, concrete block, and stone veneer residential buildings. Examples of the latter are more prevalent after circa 1935.

Historic windows are typically 6/6, 2/2, or 4/4 double hung, and there are a wide variety of roof styles including front gable, side gable, pyramidal and hip for residences constructed mostly with asphalt but also with tin especially on many shotguns. There are also a few residences that retain patterned composite shingle roofs (Inv. #s 365-367, Photo #9).

Aside from double hung windows and simple detailing, most have one or two brick or stucco chimneys and front porches with simple wood columns, although some also have brick piers. Renovations that occurred to many houses in the 1940s and early 1950s include the installation of composition shingle siding, wrought iron porch posts and railings, the construction of side or rear additions (particularly on shotguns), and the replacement of windows typically with horizontal 2/2 sash and occasional picture windows.

During the 1960s and 1970s many houses were refaced with aluminum siding, and later, in the 1970s through the present, with vinyl siding. In recent years, a number of houses have had their windows replaced with synthetic windows. Only a few resources have enclosed, or partially enclosed, porches. Of the 99 noncontributing resources, 52 (52%) were constructed in or before 1961 and have been altered to the point where they no longer retain integrity. Typically such resources have seen both the replacement of their siding and windows and often additions as well. The remaining noncontributing resources were constructed after 1961.

Nonresidential buildings account for only eleven of the district's contributing resources (4%). These include the mill and mill office (Inv. #s 215-216, Photos #1-3), the 1915 stucco McCormick Building (Inv. #87, Photo #19), the Centre Theatre (circa 1945, Inv. #387, Photo #14) and the circa 1895 Tracey Pratt Office (Inv. #188, Photo #17). There are also two contributing commercial buildings (Inv. #s 167, and 376, Photo #10) in addition to the J. C. Brown General Merchandise Company (Inv. #388, Photo #15). There are also three churches (Inv. #s 85, 180, and 385, Photos #12 and #20).

Inventory

For descriptive purposes, two standardized designs of mill housing in the district for resource types numbering in excess of ten examples are outlined below. The inventory will identify individual resources by type where applicable and will describe only alterations to or variations from its standard type.

Type A (71 examples, Photos 22-23, 30, and 32) – Type A dwellings are typically one-story frame duplexes with a rectangular core with a side gable roof and often a rear extension. The 4 bay wide façade is characterized by two centrally-located adjacent doors flanked to either side by a 6/6 window and typically with a central chimney, a brick pier foundation, and a shed roof porch. Some were built in a modified form with no rear extension.

Type B (14 examples, Photos #4-5) – Type B dwellings are typically one-story frame duplexes with pyramidal roofs, a rectangular or square plan, a four bay façade with two 4/4 windows and two doors, and a partial or full width shed porch.

Statement of Significance Summary Paragraph

The Lowe Mill and Mill Village Historic District is locally significant under National Register criterion A in the area of Industry and under criterion C in the area of Architecture. Lowe Mill was constructed beginning in 1900 and soon became one of Huntsville's major industrial facilities. The company began constructing housing for its mill workers soon afterward along a grid of streets that extended to the west and north of the mill. While some scattered rental housing was constructed adjacent to the company-owned houses prior to the mill's closure in 1937, much of the area in the northwest portion of the district represents development that occurred as the area transitioned from a traditional mill village to a neighborhood of workers employed in other industries. This transition began with the mill's closing and accelerated after the conversion of the mill into a shoe factory in 1945. The mill complex remains as the most intact of only two surviving historic textile mills in Huntsville. Both the houses constructed by the mill and the later housing illustrate early to mid-twentieth century residential building typologies found in Huntsville's working class neighborhoods. The Centre Theater, the churches and the commercial resources are also representative of the types of public buildings constructed to serve these neighborhoods.

Narrative Statement of Significance(provide at least one paragraph for each area of significance)

Industry

The Lowe Mill complex is significant in the area of industry as it represents the most intact of only two such complexes surviving in Huntsville. The other mill, Lincoln Mill, retains only a portion of its historic mill complex. Following the Civil War, the South struggled to transition its economy, in part, from agricultural to industrial. Between 1880 and 1890, in fact, all the southeastern states experienced a boom in the development of their textile industries when the number of textile mills increased from 161 to 239 and the number of spindles and looms in operation rose from 553,940 to almost 1.6 million (Stephens, p. 13). Safford Berney's Handbook of Alabama of 1892 records twenty-five cotton textile mills in Alabama for that year, four of which were located in Madison County, the largest number of mills in any one county in the state during that year (Ibid.). Lowe Mill was a major facet of Huntsville's twentieth century industrial development and operated from circa 1900 through 1937. The complex was acquired by the Genesco Shoe Manufacturing Company in 1945, which operated the facility until 1978.

Architecture

The Lowe Mill and Mill Village Historic District contains a significant collection of mill housing typologies that are consistent with one or more of Huntsville's other three mill village historic districts and which are representative of Southern mill housing in general. These include the double pen [Type A in this nomination], shotgun, bungalow and the square or rectangular pyramidal roofed house [Type B in this nomination]. The double pen, in particular, is one of the oldest types of mill houses and was promoted in D. A. Tompkins' Cotton Mill, Commercial Features. Additionally, all of Huntsville's mill village historic districts, including Lowe, retain their Colonial Revival style Superintendent's or Manager's house. Other architectural styles represented by mill houses or post-mill houses include Craftsman and the Ranch and Minimal Traditional styles. The West Huntsville Baptist Church displays Renaissance Revival influences. The Centre Theater is the district's only Art Deco building. The articulation of these styles is modest in scale and simple in design, reflecting the working class character of the district. Finally, the mill complex itself contains the most intact and well-preserved examples of a mill and its ancillary buildings in Huntsville.

Developmental history/additional historic context information(if appropriate)

Historical Narrative

Lowe Mill was incorporated in 1900. Tracy W. Pratt, the most visible of the so-called "town builders," according to Huntsville historian Patricia Ryan, had brought other textile manufacturing mills to the city, and by the turn of the century, persuaded Arthur Lowe of Massachusetts to locate a mill in Huntsville. Lowe, the fifth mill to be established in Huntsville during the period of the late nineteenth and early twentieth centuries, was located at Ninth Avenue and Seminole Park Drive (now simply Seminole Drive). The initial stock capitalization of \$100,000 was invested in heavily by Northerners, as well as by Southerners, as follows:

The above listing accounts for \$90,000 of the initial capitalization for Lowe Mill. The remaining \$10,000 was probably raised by local investors in small increments (Ryan, 21).

Tracy Pratt and investor Willard Wellman served on the Board of Directors of Lowe, the only Huntsvillians to do so (Perry, p. 185). Pratt met Wellman while they were both attending the University of Minnesota during the 1870s. Soon afterwards, they moved to Sumbrota, Minnesota to enter banking, and later pursued their profession together in Pierre, South Dakota (one account says that Pratt came to South Dakota with his newspaper). Pratt later served on the Pierre City Council, and along with Wellman, went into the insurance business there during the 1890s. By late 1891, they had also reincorporated the North Western Land Association (in which Wells had been a principal) with capital at \$6,000,000 up significantly from its original \$100,000. While its main office was in Pierre, a second office was in Huntsville where the two moved in 1892 (Inv. #188); and by the end of the decade they had formed Lowe Mill (Ryan, 28).

At the same time that the company incorporated in 1900, Tracy Pratt laid out the mill complex as well as housing for its workers. The mill itself was to be situated on nine blocks, which had been donated to the company at the time of incorporation by the West Huntsville Land & Improvement Company in return for Pratt's promise to build a "10,000 spindle mill within the year" on the site (Ryan, p. 2).

Pratt fulfilled his agreement, and in 1901 the south section of the mill was built; four years later, in 1905, the north section was constructed and connected to the earlier portion (Inv. # 325, Photos #1-3; Index to Photographs, HAER Southern Textile Industry Survey, Textile Industry in Huntsville, Alabama, October 1998) With some 250 employees, and using steam power, the mill began producing gingham, shirting, and yarn (Stewart, p.10). In 1903, Lowe expanded its operations substantially when it absorbed Eastern Manufacturing Company, an entity that bleached and dyed, as well as wove and finished, textiles. Within two years, Lowe was operating at 15,000 spindles, and by 1905-1906 it had 25,000 spindles and some 400 employees. Within another year, moreover, there were 900 employees.

By 1908, according to a Sanborn Fire Insurance map, the giant mill complex had electric lights, a pump house, boiler room and engine house, and while one section of the mill operated by steam, the other worked off "hot air." There was a Grinnell Auto Sprinkler system which was fed by a 30,000 gallon capacity water tank, and the water came from a creek just 500 feet from the plant. It also had, typical of mill complexes during this period, its own fire department including five outside double hydrants with a 100-foot long, 2 1/2" diameter hose attached to each (Sanborn Map, 1908).

During this first decade, the company also built housing for its workers in a wide variety of styles. Built adjacent to the mill, the first worker houses were constructed along Ninth and Tenth Avenue. By circa 1910, there were also houses built for managers who reported directly to the superintendent and were responsible for supervising specific tasks, sections of the villages, etc. and were known by locals as "second hands" (McMullen 6-16-03). By then, the original J. C. Brown General Merchandise Store had also been built to serve all of West Huntsville including the residents of Lowe Village. Here, on what is now the westernmost edge of the village along Triana Boulevard, mill workers bought shoes, got haircuts, and sent and received mail. The extant J. C. Brown store (Inv. # 388, Photo #15; constructed circa 1925) served the village until the 1990s (Ibid.).

In 1911 Lowe was bought out by the Hunter Manufacturing Company although it continued to operate under the Lowe name (Ryan). A few years later, in 1914, Lowe let a contract to Baxter Brothers to build two dwellings, one six-room and one eight-room at a cost of \$7,000 (Manufacturer's Record, May 28, 1914), as well as a new \$12,000 warehouse which remains as part of the extant complex (Inv. #215; Manufacturer's Record, September 3, 1914). At the same time, the company built dozens of additional houses.

Perhaps the most striking non-industrial building in all of West Huntsville was finished in 1915. That year, Virginia McCormick (1861-1941), daughter of Cyrus H. McCormick(1809-1884), inventor of the famous McCormick reaper, announced the opening of the West Huntsville YMCA (Inv. #87), which she had funded for the benefit of the residents of West Huntsville, as this area was then known. The two-story stucco building with an arched arcade wing located on Eighth Avenue has historically been known as the "McCormick Y" and also the McCormick Building, in her honor. The building contained two swimming pools which were filled in the 1980s, and it was here that Lowe and other nearby workers showered, watched movies, and participated in company-sponsored tournaments and sporting events including softball, basketball, bowling, tennis, billiards and cards. There was also a full size basketball court inside and a bowling alley. The McCormick Y was the hub of the community and at one point had over 2,000 dues paying members. During World War II, the building was taken over for use as a USO.

During the late 1910s and early 1920s, Lowe Mill continued to build houses, mostly shotgun houses just northwest of the mill along Boardman and Summer Streets, and Seminole Drive. By 1921, there were approximately 200 residences in the village mostly north and west of the mill giving the village an inverted "L" shape; there were few, if any, mill houses north of about 7th Avenue to Governor's Drive except for between Sixth Street SW and First Street SW (Sanborn Map, 1921). By then, there was also a neighborhood playground (Sanborn Map, 1921,1928), a grocery store, and café immediately west of the mill none of which remain (McMullen). There was also the no longer extant West Huntsville School and several churches only one of which remains, the simple one story Craftsman style West Huntsville Christian Church on 9th Avenue (Inv. # 180, Photo #12).

During the first half of the 1920s, the mill village continued to grow rapidly, but by 1925, the number of employees had decreased from 600 in 1920 to 550. Nonetheless, many new houses and a few stores were built in the continued wide variety of standard mill types, which were scattered rather than concentrated, throughout the village; there were also scattered non-standard bungalows and vernacular styles. In addition to duplexes, there were many single family residences built including some one and one half story styles likely built for skilled and middle managers. Also constructed were one-story single-family Craftsman style bungalows including a large stone veneer bungalow on Sixth Avenue (Inv. #308, Photo #26).

During the 1920s, there were also several stores or commercial buildings built including a stone veneer building (Inv. #183) that has been extensively altered in recent years. The company built at least one major addition to the mill then, a picker room built in 1928 by Gallivan Building Co. of Greenville, South Carolina with J. E. Serrine & Co. serving as engineers (Manufacturer's Record, July 12, 1928).

Within a few years, however, the Great Depression hit, the numbers of employees declined to 500, and by 1930, the company no longer produced a full range of cotton products, including gingham, shirtings, and chambrays in addition to yarns as it had, but was solely producing "grey goods" or unbleached sheeting (Davidson, 9). Conditions continued to worsen and, by 1932, the company declared bankruptcy (Davidson, 9, and Stewart, 10.). Although it was reorganized again as Lowe Mills, this company too was dissolved in 1936 (Stewart, 10).

During the 1940s, tremendous change came to Lowe Mill Village. In 1945, the Genesco shoe manufacturing company purchased the property and operated a shoe factory on the site until 1978.

In addition to the housing built by the mill company, additional housing had been constructed for mill workers by individuals as rental property prior to 1936. Stylistically, the houses were generally similar to those built for the mill company, but this also accounts for some of the stylistic eclecticism that occurred in the village. After 1936, additional non-mill worker housing was developed, particular in the northern and western portions of the district. This development was likely spurred by the conversion of the former mill into a shoe manufacturing plant in 1945 that employed 800 workers, many who lived in the former Lowe Mill Village. Notable resources from this period include the Art Deco style Centre Theatre (Inv. #387, Photo #14) constructed circa 1945.

Today, the huge mill complex remains intact and is used for a variety of civic and cultural endeavors, and the adjacent village retains a very strong sense of setting, location, and planned form.
