The Capitol North District, built between 1905 - 1930 is a good blend of middle to upper class housing stock, primarily of frame construction with clapboard siding. Frame styles range from single story plains cottages to two story picturesque cottages. Several streets have brick veneer and brick construction houses in two story cottage modes and eclectic villa forms. Much of the architectural character of the district derives from the similarity of features of the properties. Design elements such as varied roof structures and imaginative massings of elements which are sometimes repeated on the same block, generate visually active street scapes. Fenestration patterns, chimney placements and design, porch locations and shapes, decorative motifs in gables, occasional stained and beveled glass ornamental windows, varieties of dormer types, and entry way ornamentation all serve to provide a rich catalog of architectural details. Uniform setbacks on most streets and developed landscaping with continuity in plantings serve to make the district cohesive.

Because of its proximity to the State Capitol and other State buildings, this district has provided housing for officials of state government including governors, state legislators, lawyers, judges, and other related professionals. In the southwest corner of the district at the corner of Pioneer and 26th Street is Gilchrist Park, dedicated by a prominent resident of the area in the early 1900's. The park, along with a memorial shaft to the east, create a mood setting corner stone for the district.

At present many home owners in the area have organized a neighborhood association intended to defend and preserve the residential character of the district. This, in reply to the increasing threat of state government expansion. Several blocks of similar housing between the districts southern boundry and the state capitol have already been violated by encroachment from new state buildings. Further impact into the district is feared.

Some significant and typical buildings contributing to the character of the district include:

- *1. The Luke Voorhees House (2819 Thomes): 1884; Picturesque Cottage, 2 stories, originally clapboarded, covered with vinyl siding, cut-out wooden soffit and frieze, one of the few remaining 19th century residences in Cheyenne. Original owner, Luke Voorhees was among the first settlers and served as Territorial and County Treasurer for 4 years and also was appointed receiver of public moneys and disbursing agent for the U.S. Land Office of Cheyenne in 1913.
- *18. The Trautwein House (2800 Carey Avenue): 1922; Italian Villa; William R. Dubois Architect; 2 stories, yellow brick, hipped roof of red tile; built for Cheyenne banker C.W. Hirsig; the Hirsig family was also among the first settlers.
- *25. Judge Guthrie's (2800 Capitol Avenue); 1922; Eclectic Villa, 1 story, red brick with wide mortar joints, hipped roof and central pavilion, open entrance patio and covered side porch. Built for contracting engineer J.B. True.
- *27. Cyrus Beard House (2710 Carey Avenue): 1911; Picturesque Cottage, 2 stories, clapboarded; variety of features including hipped roof, battered piers, flared gable, large front dormer, fish scale shingle, projecting window; Cyrus Beard, Chief Justice Wyoming State Supreme Court, occupied this house from 1915 until his death in 1921.

5 SIGNIFICANCE

Capitol North is a well preserved but endangered middle to upper class neighborhood directly north of the Wyoming State Capitol. The districts development and evolution is a direct result of the construction of the state capitol and the expansion of government related functions. This area has provided housing for officials of state governement, related professionals, and small businessmen, from approximately 1905 to present. Some significant residents include: Luke Voorhees, Teritorial and State Treasurer and Laramie County Treasurer, Reciever of Public Moneys and Disbursing Agent of the U.S. Land Office 1913; Cyrus Beard, Chief Justice Wyoming State Supreme Court 1905–1920; W.E. Chaplin, Registrar U.S. Government Land Office 1911–1920; James Greenwood, Deputy Attorney General and Attorney General 1928–1934; H.R. Millard, Secretary, State Board of Sheep Commissioners 1912–1915; Leslie Miller, Governor 1933–1939; C.W. Hirsig, Vice President Citizens National Bank 1920's; Moses P. Keefe, Pioneer Contractor 1877–1929, Territorial Legislator 1886, County & City Commissioner and Mayor 1902–1903.

Although there is a variety of housing styles the district remains architecturally cohesive because of scale, uniform setbacks, the dominance of clapboarded houses and an abundance of landscaping. Regardless of house size, the residences are rich in exterior & interior architectural details because of the ready accessibility, via the railroad, of such elements from Midwestern and Eastern suppliers. Two churches within the district also demonstrate consideration of these same characteristics and blend into the character of the Neighborhood.

- *34. Moses P. Keefe House (210 West 27th): 1910; Eclectic Cottage; Moses P. Keefe, designer;  $l\frac{1}{2}$  stories, clapboarded, stone foundation, enclosed porch with Tuscan columns and pedimented temple front, 2 gabled dormers, and tower. Constructed by Moses Keefe, a prominent Cheyenne contractor involved in construction of Fort Russell, the State Capitol additions, many Cheyenne residences, schools, and churches. The Keefe family owned and occupied the home until 1975.
- *44. Governor Leslie Miller Home (108 W. 27th): 1908; Picturesque Cottage, 2 stories, clapboarded covered with vinyl siding, enclosed porch with undecorated pilasters, and frieze. Second story windows 6 over 1 pattern with pattern reflected in dormer windows and porch, roof hipped and flared on dormer, porch and house. Simplified classical details. Although the governor's mansion had been completed by the time Governor Miller took office he chose to remain in this house throughout his term.
- *75. W.E. Chaplin House (2622 Central): 1910; Plains Cottage, 2 stories, red brick with more classical details than usual, string course of brick and corners quoined with entablature, porch trimmed in sandstone with segmental arches (for drainage) and sandstone sill, hipped dormer and hipped roof. Built for W.E. Chaplin, Registrar for U.S. Land Office in 1913. Mr. Chaplin later became a noted editor in Laramie, Wyoming and a respected Wyoming author.
- *72. A.A. Underwood House (214 W. 26th) 1905; Plains House, 2 stories, clapboarded on first floor and shingle on second, intersecting gable roof with clipped gable on east, stained glass in upper  $\frac{1}{2}$  of windows, stone foundation, upper story wall flared, with fishscale in front gable. Originally this house was constructed for A. A. Underwood a foreman whose family has owned and operated small businesses in Cheyenne since the 1880's. The Underwood family still lives in the house.
- *77. D. S. Swan House (2612 Central Avenue) 1915; Plains Cottage, 1¹/₂ stories, clapboarded, 2 hipped dormers with shingles, hipped roof with large overhang, wing walls flared at base. Original owner D.S. Swan a prominent Cheyenne business man who started the first electric light company in Cheyenne, one of the first in the West.
- *103. James Greenwood House (2522 Warren Avenue) 1910; Plains Cottage, 2 story, asphalt siding, clipped gabled roof, slight overhand, occasional gable over windows which functions as a hood, original stained glass in upper  $\frac{1}{2}$  of front window & transom. A nice composition of elements to make it vertical. Mr Greenwood served as Deputy Attorney General and later as Attorney General in the 1930's.
- *109. Kathryn Menass House (2507 Central Avenue) 1908; Plains House, 1 story, clapboarded, gabled roof with fishscale shingle in the gable, entrance porch with Tuscan columns, wooden entablature and mansard roof which butts into gable. This house is one of many in the district which demonstrate the transition from the simple plains house to the cottage style, and housed many middle income families.

INTRUSIONS IN THE CAPITOL NORTH HISTORIC DISTRICT

- 60. G & R Service Center a converted 1960's Gas Station of concrete block construction. This building is brightly painted and does not contribute to the historical or architectural continuity of the district. (314 Randall Avenue)
- 63. Pinon Tree Cafe another converted concrete block building, which is of the same unimaginative construction as the Service Center, painting is also not copacetic with the character of the district. (312 Randall Avenue)
- 99. VanSchaak Realty a remodeled Plains House, the character of which has been severly violated by the addition of a mansard roof of shake shingles, stucco, and colonial details such as shutters and broken pediment over the door. The integrity of this building could possibly be restored at considerable expense. (100 E. 26th Street)

Gilchrist Park is a triangular plot of ground bounded on the west by Pioneer Avenue, on the south by 26th Street, and on the northeast by Randall Avenue, just west of the intersection of Carey and Randall Avenues.

Located in the park stands a memorial to Robert Burns. The statue itself, a bronze image of Burns, attired in the costume typical of his times, stands  $6\frac{1}{2}$  feet high on a pedestal of Georgia gray granite  $12\frac{1}{2}$  feet high. The statue was prepared by noted Scottish sculptor Henry S. Gamely. Mr. Gamely was known internationally for his studies of Burns and others done in both bronze and marble.

Funds for establishing the park and statue were donated by longtime Cheyenne resident, Mary Gilchrist. The park was donated and established in 1926 in memory of Mrs. Gilchrist's husband Andrew. Andrew Gilchrist was an early Cheyenne pioneer. Arriving in 1877, he made a fortune on the cattle industry and then established the Stockgrowers National Bank. Mr. Gilchrist later served in the territorial legislature and was very active in the community for many years.

Burns was a favorite of Mary Gilchrist and she had the statue constructed in the park, "so that passers-by might pause and spend a quiet moment contemplating his gentle philohsophies". The statue was dedicated in 1929 and is reputed to be the first of its character erected in Wyoming.

Just east of the park, on a tiny triangular plot, stands the Holliday Memorial. This shaft originally served as a light for the park area and plans are underway by the neighborhood to have it put back into use. The shaft was erected early in the 1920's by Mr. and Mrs. Cal Holliday in memory of their son. The Hollidays' were prominent citizens involved in a variety of civic activities, the most outstanding of which was their donation of land and monies for the establishment of Holliday City Park. Mr. Holliday served as Park Commissioner for many years and later as mayor. The shaft stands approximately 15 feet high on a concrete base.

Both memorials were erected on small plots of ground resulting from the diagonal cutting of Randall Avenue. Both deserve inclusion within the district. Gilchrist Park has long been the only park in the neighborhood and is used by many residents of the area. The Holliday Memorial, though not used by the neighborhood in the same way as the park, serves as a gateway to the neighborhood and like Gilchrist Park contributes to the sense of time and place that is evident throughout the neighborhood.
