Summary Paragraph

The Egan House, also known as Harmony Hall, was built 1883 and is located on Camino Capistrano near Mission San Juan Capistrano, built in the Renaissance Revival style. It is a one and one half story red brick building with a large, hipped asphalt shingled low pitched roof that covers the 2 inset dormers with windows that open to Juliet balconies on the North and West side and a small dormer on the south side. 4 metal finials are located on the roof. On the east side of the building is a wood/shingled structure that was added in 1996, used as a kitchen during the building's tenure as a restaurant. The west side facing Camino Capistrano has an open sitting porch with a roof that extends around the corner of the building to the south to a small vestibule. A wood railing and ramp, separate from the house, were later installed on this side of the house. Under the house is a basement that served as a wine cellar. It also had a tunnel that went underneath Camino Capistrano from the house directly to the jail that was located in what is today the El Adobe Restaurant. The tunnel no longer exists. Only the door frames in both buildings can be seen.

The house was constructed for Richard Egan by William English, a contractor well known in San Juan Capistrano, in 1883. This large square red brick building (3000 square feet) is the only Renaissance Revival residence found in San Juan Capistrano (Photo # 1, Figure # 1) It is located on 0.22 acres and faces Camino Capistrano, the main road that goes from Los Angeles to San Diego.

William English, a well-known contractor, designed and constructed this one and one-half story building using the left over bricks that came from the from the construction of another building, called Casa Grande. In 1882, Marco Forster, who had the property behind Egan's lot, had plans for building his home, known as the "Casa Grande." Forster asked Egan to order brick from San Diego. A slight miscalculation on the part of Richard Egan, ordering more bricks than needed for the Casa Grande, enabled Egan to use the surplus brick when he built his own home.

The upper part of the Egan house caught fire in 1897 that destroyed most of the upper floor and parts of the roof. William English rebuilt the upper floor and roof in the same style as the original in 1898.

The 4 walls on the first floor of the Egan House are solid brick. A brick frieze runs along all four sides of the house. Two wall dormers with Juliet balconies plus a smaller dormer are located on the lower part on the roof. (Photo 2)

The front of the house facing west on to Camino Capistrano shows a covered porch, which wraps around the southwestern corner of the building to the middle on the south side of the building. Seven wooden pillars support the porch roof. (Photo # 3) A protective wood railing was installed when Camino Capistrano was widened. The street, which originally level with the porch, was lowered by four feet, necessitating the railing's addition to the exterior of the house.

There are 2 front doors on the porch. The one on the left opens to a large room that connects with the "Judge's Chamber" located in the back. From the "Judges Chamber" a narrow stairway is located in the back for access to the upstairs rooms. The door on the right side is the entrance to a large entry parlor with fireplace. The door shows the original door knocker, door knob and glass panels held in place by soft lead. (Photo # 4 & 5)

The stairway on the south wall of the house goes to the second floor. (Photo # 6 & 7) On the south side where the porch extension ends is a small wood enclosed vestibule with a door and 5 large windows. That door connects to the room with the fireplace. (Photo # 8 & 9) Next to it is the entrance to the basement. The doors are basement cellar doors. Inside are the steps leading down to the basement. (Photo # 10 & 11) The basement was used for the wine cellar and was the entrance to the tunnel that went under Camino Capistrano to the Yorba Adobe (now the El Adobe Restaurant) which is now sealed off on both sides.

On the North side of the house are 3 windows and on the far corner is the door that opens to the Judge's Chamber. (Photo # 12 & 13)

The walls on the second floor are partial brick and stucco. Photo # 14

There are 2 rooms upstairs with 2 bathrooms. The 2 dormers with Juliet balconies are located in the large room. One dormer overlooks Camino Capistrano, next to the stairs, while the other dormer in the same room faces north. Both dormers with Juliet balconies have a single hung window with 2 fixed glass panels on each side Photo # 15

On the south side is the small dormer located on the wall of the large stairway going up from the living room to the second floor. It opens for ventilation and has 6 glass panels that are set in soft lead

The roof of the Egan House is hipped and covered with asphalt shingles; the attic is accessible as a second floor of the building. Eaves are open with visible rafter tails. Wall dormers are located on the North and West side, each topped by a hipped roof, with a central door flanked by two small windows. The doors access small balconies enclosed by a wooden balustrade, framed by two wooden posts, each capped by a wooden finial. There is a smaller roof dormer on the south side of the roof, with only one window and no balcony. On top of the roof are 4 copper finials and a brick chimney that extends from the fireplace in the former living room on the first floor. Photo # 1 & 2

On the east side of the building is a wood shingle building addition added in 1996 (30x11 feet) which was the kitchen when the Egan House was a restaurant. This accessory building is attached to the back wall of the Egan House. (Photo # 17) On the northeast corner is a small trash enclosure adjacent to the kitchen. (Photo # 18)

Specific Features:

The 8 supporting posts on the sitting porch are typical of the Renaissance Revival architectural style. They are 6x6 square wood posts with 45 degree chamfered edges. The posts are installed atop a 12 inch high 10x10 brick base.

The front door opening to the room with the fire place has 2 glass panels set in soft lead All the windows on the first and second floor are single hung with the exception of the vestibule that has 4 solid windows. The house still has the original mahogany floors

Historic Integrity

The building is un-altered and looks the same as seen in photographs of 1898 after restoration of the roof and the second floor, due to the fire in 1897 that destroyed the roof and parts of the upper floor. The 1990s addition to the building rear has resulted in some loss of integrity of design and materials, but the original house retains a high degree of integrity in all other aspects.

The Egan House is a single-family residence built in the Renaissance Revival style. The property is eligible for the National Register under Criterion B, at the local level of significance, for its association with Judge Richard Egan, an attorney, justice of the peace, and philanthropist significant to the community of San Juan Capistrano and San Juan Township. The property is directly associated with elements of Egan's working life. The period of significance is 1883-1923, spanning the year the house was built until Egan's death in 1923.

Richard Egan, born in Ireland came to San Juan Capistrano 1868.

A surveyor by trade he purchased large pieces of land which he cultivated .Besides farming he was the towns telegrapher, notary, agent for local landowners, keeper of rainfall records and dispenser of charity for the local towns people. During that time he was appointed to be one of the two justices of the peace for the San Juan Township from ca. 1870 to 1890. This is the reason why he was called Judge Egan- a title he kept all his life. He built the Egan House, which he called Harmony Hall in 1883 and was well known for giving lavish dinner parties for the rich and famous. In 1897 a fire destroyed the upper floor of the house. It was rebuilt in 1898 by William English, the same contractor that originally did the work in 1883. During his lifetime Egan held many positions and was much involved with County politics. Egan House is the only office and courthouse that Judge Egan used, and is therefore the only building that captures his historic significance. He died in 1923

Narrative Statement of Significance (Provide at least **one** paragraph for each area of significance.)

Richard Egan was born in County Waterford, Ireland in 1842. At the age of 10 he came to the United States with his uncle and lived on Long Island where he attended public schools Later on as a young man he travelled all over the world and lived for 1 1/2 years in San Francisco. Upon his return to southern California he travelled by stage coach from Los Angeles to San Juan Capistrano in 1868. He bought 160 acres north of San Juan Capistrano and later 600 acres just east of the Mission. On his ranch he planted several walnut groves and rented out the rest of the ranch to tenants that paid Egan by giving him one-fourth of the produce and one half of the walnuts.

At first Egan lived in an adobe on his farm land, and decided in 1883 to build the red brick house on Central Avenue, the road now known as Camino Capistrano. He named the house "Harmony Hall." Around Harmony Hall, Egan planted large eucalyptus trees and Lombardy poplar trees that can be seen on the photograph taken in the 1890s before Camino Capistrano was widened. (See Fig. # 8) Several of the original trees are still standing on the southwest corner of the property.

According to Samuel Armor, editor of the "History of Orange County"¹ 1921 Egan was both a public-spirited man and a leader of wide and valuable business experience. In 1870, the telegraph first came to San Juan Capistrano, and Egan became its operator. He was a school board trustee in San Juan for 32 years. In addition, Egan served for four years as county supervisor of Los Angeles County, from 1880 to 1884. He was appointed this position due to his business experience. Egan was one of three men appointed as Commissioners to adjust disputed questions between the Counties of Los Angeles and Orange County when Los Angeles County was divided into the two counties of Los Angeles and Orange. He was also elected as one of two justices of the peace in what became Orange County, a position he held for many years.

During his time as justice of the peace from 1870 to 1890, Egan donated all fees for his services to the poor. He supported himself with his extensive agricultural landholdings throughout San Juan Capistrano.

In addition to being Justice of the Peace, Egan became a director of the Atchison, Topeka and Santa Fe railroad beginning in 1887, securing rights of way that made it possible for trains to travel from Los Angeles to San Diego, stopping in San Juan Capistrano, a great boost for Orange County as well as for Southern California. Due to his surveying experience, Egan was one of the Commissioners appointed by the Supervisors of Orange County to oversee the construction of the public highway system.

Egan was instrumental in the restoration of Mission San Juan Capistrano, working with the Landmarks Club in 1895, who helped finance the restoration. He spearheaded the local effort and carried out much of the physical restoration himself. He was a member of the Southern California Historical Society and kept many of the valuable records that after his death unfortunately were lost. It was due to Egan's unselfish work for the community that he was called "Judge Egan", a title that he held for life. Records show that he was a trustee for the local school board for thirty-two years. He was also known for his very fancy dinner parties at Harmony Hall. Among his frequent guests were Louis F. Moulton, a well-known rancher, and Madame Helena Modjeska the famous polish actress who dubbed him "The King of Capistrano" Fig. ,# 5, # 6, # 7

During his life in San Juan Capistrano Judge Egan had a distinct and lasting impact on the Community and also the County of Orange. He died on Feb. 9, 1923, and the town lost one of its most beloved citizens. Throughout his life, Egan was repeatedly called upon to assume public trust as a justice of the peace, Los Angeles County supervisor, school board trustee, keeper of rainfall records, and director and right-of-way agent of the Atchison, Topeka & Santa Fe Railroad. Harmony Hall, the Egan House, is a property where much of his work was carried out, and is thus directly associated with Egan's life under National Register Criterion B.

It is a one and one half story masonry building with a hipped roof of low pitch A brick frieze runs along all four sides of the house, interrupted by two wall dormers with Juliet balconies on the primary façade, facing west, and on the western wall. A smaller, hipped dormer is located on the southern side of the roof. Contractor William English built the house using bricks left over from the construction of an adjacent building, Marco Forster's "Casa Grande." The house was damaged in an 1897 fire that destroyed most of the upper floor and roof. It was rebuilt by William English in 1898 in the same style as the original.

The Egan House is eligible under Criterion B as the primary residence, office and chambers of Judge Richard Egan. Born in Ireland in 1842, Egan came to the United States at age ten, and traveled the world, including stays in San Francisco and southern California. In 1868, he purchased 160 acres north of San Juan Capistrano, and an additional 600 acres east of the Mission. This land, planted as walnut groves, was sublet to tenants. Egan replaced an earlier adobe on his farm with this house in 1883, landscaping the home site with eucalyptus and poplar trees. Egan quickly became involved in the civic affairs of the region, serving as a school board trustee for 32 years, and from 1880 to 1884, as a Los Angeles County Supervisor. He was appointed to a three-man commission that supervised the division of the county into Los Angeles, and Orange Counties, and was elected as one of two Orange County justices of the peace, a position he held from 1870 to 1890. Egan was also a director of the Atchison, Topeka and Santa Fe Railroad in 1887, securing rights of way for this railroad to reach San Diego from Los Angeles via San Juan Capistrano.

Egan was instrumental in the restoration of Mission San Juan Capistrano, working with the local Landmarks Club in 1895, spearheading and coordinating much of the restoration. In later life, he was a member of the Southern California Historical Society and kept many of the organization's records at his home, although many of these records were subsequently lost. He was also known for his dinner parties, held at his home. At one of these dinner parties, visiting Polish actress Madame Helena Modjeska dubbed Egan "The King of Capistrano." During this period, Egan's primary office and place of business was his home, in offices accessed by a separate business entrance. Thus, the property is directly associated with the significant events of Egan's life, with a period of significance of 1883 until 1923, the year of Egan's death. The nomination was submitted by a third party consultant on behalf of the property owner. Three letters of support have been received, including the property owner and the city of San Juan Capistrano.

Staff supports the nomination as written and recommends that the State Historical Resources Commission support the determination that the Richard Egan House is eligible for the National Register under Criterion B at the local level of significance, with a period of significance of 1883-1923, and should be listed in the National Register. Staff recommends the State Historic Preservation Officer approve the nomination for forwarding to the National Park Service for listing in the National Register of Historic Places.

I am a 43 year resident of San Juan Capistrano, where I currently reside with my family. I am writing to express my support for Egan House's listing on the National Register of Historic Places. It is one of the most historically significant buildings in town, and I was surprised to learn that it is only now being considered for the National Register.

Constructed in 1883, Egan House unlike any other historic building in town in terms of its architecture and historic significance. Also known as "Harmony Hall", it is a Renaissance Revival building that served as the town courthouse and Judge Egan's private residence. Judge Richard Egan, who was known as the "King of Capistrano", was elected Justice of the Peace in 1870 and was routinely re-elected until 1890 due to his outstanding reputation. The revered Judge Egan was instrumental in defining the boundary line between Los Angeles and Orange County and securing the right-of-way for the Santa Fe Railroad to pass through to San Diego. He initiated critical repairs to save Mission San Juan Capistrano in 1896, which he could overlook from the north-facing dormer window on the top story.

I strongly urge the SHRC to vote to list this property on the National Register of Historic Places. I plan to attend the SHRC meeting, but wanted to express my support beforehand.
