lying & being in the county of Guilford on the waters
of Hunting Creek of Reedy fork of Haw River

Beginning at a Large white Oak Standing on the top
of a hill North of the Mill Runing from thence west one
Hundred & Ninety two poles to a Stone Fosters Corner

thence with his line South Ninety Two poles to a Span
ish Oak his Corner thence East forty Two poles to a
white Oak his Corner thence East forty Two poles to a

White Oak near a Pond thence South with Hoskins
line Sixty one poles to the Great Road thence with
the Same North fifty-eight Degrees East Twenty one

poles to a post Oak that Cannon Ball was
Cut out of thence North forty eight Degs East twenty fou

 ranted Sold Aliened conveyed & Confirmed & I do hereby
 Give grant Warrant Sell Alien convey & Confirm unto the
 Said Jacob Gresson his Heirs & assigns for ever a certain
 piece or parcel of Land Situate in the County & State afd.
 and on the waters Henking Quarter Creek the boundaries
 is as follows (viz) Beginning at a Post Oak the Old
 Corner Turning thence North Twenty Nine Chains and
 fifty links to a Sower Wood by the Creek the same Cor-
 ner Continued in all forty four Chains & fifty links
 to a bunch of Logwoods thence west Twenty four links
 to a Black Oak thence South fifteen Chains to a white Oak
 thence west thirten Chains to a white Oak
