The Hipple House is located on a large lot in the city of Pierre, South Dakota near the State Capitol complex. This Prairie style house built in 1913 for John E. Hipple and his family. The house is on a full basement with a foundation constructed of concrete. A beltcourse is located between the basement level and the first level. The house features a projecting hip dormer on the south elevation. Red slate tiles cover the hip roofs and hip dormer with four casement windows. The stucco exterior remains in good condition. A large retaining wall is on the edge of the east elevation. Stone piers provide the opening for the steep stair sidewalk.

The front façade (east elevation) has a one-story full width porch with three openings. The shed porch roof also features the balcony for the second story porch. The northern opening is the entrance to porch, which leads to the front entrance. Starting from the north the fenestration pattern on the first floor is a casement window, the front door with sidelights, and a Chicago type window. The second floor features a twelve-over-one window on either side of the balcony. The balcony entrance is by a multi-light door. On either side of the door is a nine-light casement window.

The south elevation has a two-story bay and a hip projection. The bay features a ribbon of four oneover-one windows on the second level and a Chicago Style window on the first level. On either side of the bay and below the beltcourse is a one-over-one window. The east elevation of the hip projection has a one-over-one window on the first and second level. A ribbon of three nine-light fixed windows and a twelve-over-one double hung window are on the second floor. The first floor has triple window located on an oriel with a parapet. Below the oriel is a small one-story projection with a parapet wall. The south elevation of the projection features a one-over-one double hung window.

A side entrance with sidelight is located on the north elevation. The first level also features two oneover-one windows. The second level has windows in the following pattern, a casement, a one-overone window, a pair of twelve-over-one window, and two single twelve-over-one windows.

The rear elevation (west) on the first level has two nine light casement windows. North of the casements is a pair of nine-over-one double hung windows. A small hip roof projection is located on the north corner of the building. The south elevation of the projection has a back entrance door and a one-over-one window. A pair of twelve light casements is located on the second level along with a single one-over-one window, a pair of nine-over-one windows, and a single nine-over-one window.

Statement of Significance

The John E. Hipple House is eligible for the National Register of Historic Places under Criterion C. This house is an excellent example of Prairie Style house. The 1913 building is a well-preserved example of Prairie style in a small community.

"Prairie identifying features include: low-pitched roof, usually hipped with wide overhanging eaves; two stories with one story porch; details emphasis horizontal lines; often with massive square porch support. The Prairie style originated in Chicago and is concentrated throughout the United States in early 20th century suburbs. Vernacular examples were spread widely through pattern books. Most were built between 1905-15."¹

Historical Background

The Chicago and Northwestern Railway formed the city of Pierre on October 6, 1880 by selling 100 lots from the original plat. Over 500 people lived in the city of Pierre by the end of the 1880. John E. Hipple moved to Pierre in 1888 and organized State Publishing Company. Five years later, he sold his interest in State Publishing and started the Hipple Printing Company. In 1905, John purchased the Weekly and Daily Capital Journal.

John along with another prominent family in Pierre had houses built in 1913. Henry Karcher, a businessman, built the first brick commercial building in town. The Karcher house is located next door to the Hipple House, but faces East Prospect Street.

Hipple served as mayor from 1924-1939. He contributed many improvements to the city of Pierre. During one of his terms of office, the city purchased several outlets from the Chicago and Northwestern Railway. This land includes almost two miles of Missouri River front property, which became in 1974 Steamboat Memorial Park. Hipple also convinced the Civilian Conservation Corps

officials to locate a camp on Farm Island. The city had owned the land since 1889, but did little with the property. John E. Hipple envisioned a recreational facility. This dream transpired through the work of the CCC. They built two public picnic areas, gravel roads, and cabins for the Boy Scouts, Girl Scouts, and Izaak Walton League.

Ruth Hipple was an active member in the women's suffrage movement. Other women involved in the suffrage movement stayed with the Hipple's, when they came to Pierre. Mrs. Hipple influenced several Pierre women to join the movement. She also helped start the Girl Scout program in Pierre.

The John E. and Ruth Hipple House retains a high degree of architectural integrity and has only a few interior alterations. Few examples of this building type remain in South Dakota with a high degree of architectural integrity. The house remains an example of a Prairie Style House and is therefore eligible for listing on the National Register of Historic Places under criterion C.
