Describe the present and original (if known) physical appearance

Calle Salud #47 is a raised, one-storey, brick-masonry residential structure on the northwest corner of Calle Salud and Calle Aurora, in the historic urban center of Ponce. The overall volume of the house is oriented on a diagonal, the main facade facing the street corner. At either end, the plan turns an angle inward, allowing the volume's extremes to present facades perpendicular to their corresponding streets. The property is surrounded by a low, plastered masonry wall with wrought iron railings above, that also cuts the corner with a small diagonal wrought-iron gate. The lot is landscaped with gardens along the front triangular-shaped yard.

The main facade presents an angular concave-shape consisting of a podium, a series of Ionic columns defining a full-width, recessed loggia, and a cornice with a battlement parapet above. An inward-sweeping stair or "stoop" accesses the raised loggia at center. A concrete balustrade defines the loggia and serves as a base for a series of symmetrically arranged Ionic columns: one at either side of the main stair and one at either extreme of each segment of the concave facade. A simple, unornamented cornice wraps around the entire structure and supports a battlement parapet consisting of alternating rounded embrasures and rectangular merlons.

Within the loggia, 5 equivalent bays define the central segment of the concave facade, 2 rectangular bays define the left segment, and a planar wall wraps around the side of the right segment onto an extension of the loggia parallel to Calle Aurora.

The 5 arched windows of the central segment consist of narrow openings housing wooden, double-doors with jalousie panels, intricately carved wooden transoms, and stained-glass fanlights above. A planar surround defines each opening and an ornate hood-mould or architrave, supported by brackets, crowns each arch. The central entrance bay is treated differently only within the door design: intricate, curvilinear wrought-iron railings enclose circular openings in a typically European Art-nouveau manner. All other windows are similar to the arched windows of the facade, but adapted to rectangular openings.

The house has not been altered in any significant manner and thus preserves the original exterior design and interior distribution and elements.

Statement of Significance (in one paragraph)

Calle Salud 47 is one of Ponce's most distinctive residential structures. It was designed in 1913 for Doña Isabel Oppenheimer de Santiago by one of Puerto Rico's foremost early XX century architects, Alfredo Weichers. Mr. Weichers studied in Barcelona, Spain and returned to Puerto Rico, where he left much Spanish-Art Nouveau influence. Specifically, Weichers designed many of the mansions of Ponce's aristocracy, of which Salud #47 is one, integrating the contemporary modernist movement to the folk building tradition of the southern coast of Puerto Rico.

In Salud #47, in response to city ordinances which required a chamfered corner for urban lots, Weichers utilized the exact negative of the chamfer for the overall form of the house and reduced the actual street-line chamfer to the configuration of the surrounding gate. Thus, an almost suburban residence with front gardens and open galleries resulted within an urban lot, only two blocks away from the Plaza. In all, Calle Salud #47 is one of the best examples in Ponce of the Puerto Rican adaptation of the architecture of the Barcelona School, and, forms an integral part of the series of late XIX and early XX century grand houses which defines the unique urban character of the center of Ponce.
