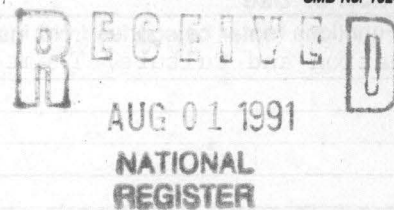

Description

The Beebe Theater stands on Center Street in downtown Beebe, a small railroad town in White County. The circa 1930 building is of basically vernacular architecture with a few stylistic details on its front elevation. Although its present use is unknown, the theater is intact, has not been significantly altered, and is in relatively good condition.

Its two-story, rectangular floorplan is constructed of buff brick and stucco with a decorative brick panel separated by a single brick course above the second-story fenestration. A metal awning has been added to the front facade, which covers a slightly recessed, raised porch that holds the ticket window bay and two multi-paned french doors flanking it on either side. Another french door is located to the right of the porch area, with a six-over-six double-hung window to the left. The theater also has three brick interior chimneys, a brick foundation, and a flat, parapeted roof.

Significance

The Beebe Theater is being nominated under National Register Criterion C with local significance because it is a good example of the commercial building practices of the first three decades of the twentieth century in small White County towns. It was the tradition among small town commercial builders at this time to construct simple, vernacular structures and then add a few architectural details, usually in the area above the second-story fenestration. The later addition of the metal awning is another embodiment of a type, period and method of construction, as it was a definite attempt to keep pace with current trends in movie theater design.
