The house at 36 Aegean Avenue is a two-story, irregular plan house constructed of stuccoed hollow tile. It rests on a poured concrete foundation and is sited on portions of two lots on the west side of Aegean Avenue near the intersection of Albermarle Avenue. The house stands amid dwellings that are similar in style and scale. The front of the house is landscaped with a lawn, palm trees, shrubs, and other ornamental plants. The garden at the rear of the house also features decorative flora, including citrus trees.

The fenestration of the structure is irregular and sparse on the main (east) elevation and is dominated by the baroque cast stone frontispiece that surrounds the main entrance. This plateresque element features a high "classical" entablature supported by narrow pilasters and crowned by finials. The frieze of the entablature and the spandrel immediately above the doorway have decorative designs executed in both high and low relief. The same elevation is further enhanced by a matrix of patterned tiles and openings which form a screen over the dining room window. Most of the original wood casement windows still survive in the house.

The major spaces on the first floor of the house consist of a living room, dining room, two bedrooms, a sitting room, and a kitchen. There are also a variety of minor spaces including a bathroom. Pecky cypress beams and a cast stone fireplace decorated the living room. The second floor (not shown in the floor plan) contains only a master bedroom and bathroom.

Located at the southwest corner of the lot is a one-story, two car garage constructed of stuccoed hollow tile. This building retains its original wooden doors and terra cotta roof tiles and contributes to the site. It was not possible to photograph this structure or the interior of the house.

This residence is architecturally significant for demonstrating the great variety of architectural types and details within the Mediterranean Revival vocabulary employed within the context of the development of the Davis Islands subdivision. The house was one of a number of residences personally designed by Miami architect Martin L. Hampton, who was hired by D.P. Davis in 1924 to oversee development of the subdivision. This residence, and the other buildings produced from early plans for Davis Islands, reflect the developer's initial attempt to produce a coherent design theme that he believed--based on his observations in Miami Beach--would make marketing the properties more successful.

The house was built at a cost of \$15,000 for Lauriston G. Moore, one of the officers of Davis's real estate firm. The house appeared to be nearly complete when it was photographed on June 9, 1925 for an article to appear in the Tampa Tribune. The house also appears in the 1925 issue of the Sanborn insurance maps of Tampa. Moore lived in the house until 1944. The residence was purchased by its present owner in 1965.

This house was one of those structures found along Adalia and Aegean avenues that were promoted as "model homes" by the Davis organization to promote further real estate sales and construction in the subdivision. These homes were often occupied by members of his organization as an advertising technique; however these houses were usually sold to members of the public after the promotional benefit had been gained. Moore was unusual, in that he continued to occupy his house and remain a Tampa resident long after the organization founded by D.P. Davis had been dissolved.




