DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Stony Point, one of the earliest brick dwellings in east Tennessee, and conceivably the first brick building in what is now Hawkins County, is situated on a hill overlooking Highway llW. Even though it is shaded partially by magnificent trees, most travelers, first noticing the brick springhouse near the road, do not miss the distinguished house.

Stony Point consists of several buildings on the south side of the highway. Two separate outbuildings are still standing: the springhouse with a thatched roof, and nearer the main structure, the smokehouse with a stone foundation, thatched roof, and open, diamond-shaped brickwork.

Facing the highway is a <u>two</u>-story rectangular brick building which served as the kitchen. Although the building is trimmed with Victorian bracketing on the cornice, other architectural elements suggest that it was built in the early nineteenth century. The present owners, who are descendants of the builder, believe it dates circa 1810, or about twenty years later than the main house.

The main dwelling faces west, which at the time it was built was probably the location of the main stage route. It is a two-story brick building which has been stuccoed and rusticated, a highly unusual exterior wall treatment in Tennessee. Bricks, irregular in size and color, can be seen where the stucco had deteriorated, suggesting that the building was always intended to be stuccoed. There is a chimney on each end. The cornice is carved. Across the front are three simple openings on both floors. The windows are nine over nine.

A photograph taken circa 1871 shows that changes have been minor. The present front porch extending the length of the house replaced a small porch with a pediment which just sheltered the front door. There is a porch across the east side of the house, no doubt a later addition also. Shutters were on the rusticated front in 1871. The kitchen building and connecting clapboard-covered dogtrot both had Victorian trim on the cornices. The dogtrot has since been covered with brick and a small brick extension to this area has been built on the east side. In 1871, a picket fence enclosed the house, and there was very little landscaping.

The interior of the main dwelling has changed little. It has the central hall opening into a room on each side. Grained work [[FIVE]] and wainscoting are used throughout the first floor. Manuals are simple but well carved, while the wainscoting has fielded one JAN 3 1973 Floors are original. A simple stairway with some carved detail NATIONAL tucked rather unusually in the southwest corner of the hall.

7. DESCRIPTION (cont.)

The original room arrangement of the kitchen building is more difficult to determine. Presently, the second floor consists of a central area or hall with a room on each side. The first floor has the room on each side, but the center section is divided into a hall and pantry. There are fireplaces only in the east rooms on both floors. The existence on the second floor of the door with a fanlight is puzzling and suggests the building may have served as additional living or entertaining quarters. The present owners remember the door opening onto a balcony.

Stony Point is in need of repairs. The present owners have begun to do some work. Hopefully, they will retain the architectural character of the building which has managed to survive since its construction almost two hundred years ago. It is also hoped that Stony Point will survive the widening of Highway 11W.

STATEMENT OF SIGNIFICANCE

Stony Point is architecturally important for several reasons; it is one of the earliest brick dwellings built in the state; the stuccoed and rusticated exterior surface is a unique example remaining in the state and was probably atypical for the area even at the time it was built; and the character of this highly individual structure has been altered very little.

In addition to its architectural significance, Stony Point was built by one of the earliest, and as expected, most influential families to settle in the area. <u>William Armstrong</u>, who was born in 1757 and grew up in Augusta County, Virginia, received a land grant in Carter's Valley in what is now Hawkins County, in the early 1780's. Armstrong family papers state that a daughter of William Armstrong and his wife, Elizabeth Galbraith, was married at Stony Point in 1791, documenting that a part of the house had been built. In 1797, Louis Philippe recorded having a good supper at William Armstrong's on the Holston River. Armstrong, who was a wealthy landowner and farmer, also owned a tavern, livery stable, and stage coach line.

The property is still owned by Armstrong descendants, although its continued protection has been threatened by the widening of Highway 11W.
