





The Ocean Forest Country Club clubhouse is located at 5609 Woodside Drive in Myrtle Beach. It is associated with the property sub-type, "Public-Use Buildings," as identified in the Multiple Property Listing, "Historic Resources of Myrtle Beach, South Carolina."

Characteristics of the Classical Revival style displayed by the clubhouse are two-story entry porch supported by Doric columns, each on a square plinth; oval light located in the centered gable; lunette light located on the north wing gable; wooden elliptical sunburst located over main doors in place of fanlight; and three-part composition composed of a two-story unit flanked by one-story wings on either side.

The clubhouse is of frame construction with both weatherboard and vinyl siding. It is two-and-one-half stories with a lateral gable roof. The rectangular plan core is flanked by one-story wings on both the north and south ends of the building. The seven bay symmetrical facade has a central entry and a full-height entry porch extending the width of the central three bays. The entry porch has a projecting gable supported by four Doric columns and two pilasters. The central entry is composed of one set of double doors. The wooden framed doors contain eight panes of glass each and a panel in the lower portion. The doors are set within a wooden surround, with two carved pilasters and an elongated portion with panels on either side of the doors. The surround also contains an elliptical sunburst motif over the doors. The windows of the main portion of the clubhouse are six-over-six double-hung-sash with shutters. Flanking the entry porch on the first story the windows are multi-paned and designed to reflect the general shape and pattern of the front doors. Dormer windows are located on the roof slope and an oval window is located in the front gable. There are two interior brick chimneys on either end of the main rectangular building.

The west wing of the clubhouse is a one-story section that is six bays wide, with the entrance located closer to the end of the building. A one-story entry porch with a front gable spans three bays and has three rounded arch openings. The windows on this portion of the building are six-over-nine double-hung-sash with shutters, and there is a traceried fanlight located in the gable of the entry porch. The west wing has one exterior brick chimney. The doorway into this portion of the building is a single door with a multi-paned upper section and a paneled lower portion. The door surround, similar to the central entry, is a pediment over a sunburst motif and pilasters on either side of the doorway.

The east wing is a one-story extension of the main building with a portion on the front facade projecting perpendicular to the core. The windows are six-over-six with shutters and dormers are located on the roof slope. One interior brick chimney is located here.

The rear facade of the clubhouse, which faces the recreation facilities, is symmetrical with a full-facade, flat roof, colonnaded porch. The window fenestration is similar to that on the front facade, as is the door surround except that it has multi-paned side-lights. The dormer windows on the roof slope are multi-paned rounded windows. The side wings are identical, with porches that have rounded arched openings. The wings both have a one-story gable projection containing a multi-paned window topped with an the same sunburst motif as the central entry.

A vinyl-sided addition to the west wing was constructed ca. 1960.

The present 18-hole golf course, designed and constructed in 1946 after eighteen holes of the original 27-hole golf course were sold for real-estate development, includes nine of the original 1926 holes and nine 1946 holes; it also contributes to the significance of the property.

Located on the property are croquet fields and a swimming pool, which was remodeled after Hurricane Hugo in 1989. Also located on the property is a small, one-story, non-historic building that is used as a restaurant.

The Ocean Forest Country Club (including the golf course), now known as Pine Lakes International Country Club, is significant for its association with Myrtle Beach's period of growth and prosperity as a coastal community resort from 1926 to 1954 and as an excellent example of the landmark buildings built in Myrtle Beach in the mid-twentieth century.

The property meets Criterion A for its association to historic contexts identified in the Multiple Property Listing, "Historic Resources of Myrtle Beach, South Carolina," in particular, Myrtle Beach's growth and prosperity as a coastal community resort/vacation destination. It meets Criterion C as a representative example of the property sub-type, "Public-Use Buildings." It also meets Criterion C as an unusual example of Classical Revival architecture and in the area of landscape architecture for the present 18-hole golf course dating to 1946.

The Ocean Forest Country Club is historically associated with an important period in Myrtle Beach's history--the tenure of John T. Woodside and the Woodside Brothers. In 1926 the Woodsides purchased 65,000 acres of beach front and other prime real estate from Myrtle Beach Farms Company for \$850,000 [See attached "Map of Golf Course Section" for original layout of area]. Although Woodside would lose his holdings in Myrtle Beach following the stock market crash of 1929, his vision for Myrtle Beach and accomplishments during his tenure had a great deal to do with its subsequent growth and prosperity. One of his greatest accomplishments was the development of the Ocean Forest Hotel and Country Club. The club and hotel were designed by an influential New York architect, Raymond Hood. Construction on the club began in 1926 and was completed in 1927.<sup>1</sup>

When the club was built, a 27-hole golf course was built in association with the club; it was designed by Robert White, a golf course designer and future president of the Professional Golfers Association of America (PGA).<sup>2</sup> Although the original 27-hole course is no longer intact, the present course dates back to 1946, when the new owner, Fred Miles, sold 18 of the 27 holes to John Mcleod for real estate development, retaining only nine. Mr. Miles then hired Robert White, a native of St. Andrews, Scotland, to redesign the nine that were left and to add nine more, resulting in the

present course.<sup>3</sup> The original 27-hole course can be seen on the 1939 USDA aerial photograph and on attached "Map of Property Conveyed by Ocean Forest Company to Ocean Forest Club Incorporated." The present 18-hole course, redesigned in 1946, can be seen on attached "Horry County Aerial Tax Map #174."

The clubhouse was originally used for lodging until the Ocean Forest Hotel was finished in 1930. Although the hotel has since been demolished (in 1974), it was part of the Woodside's dream of Arcady, an elaborate plan for an entire development that was to include a four-course golfing and beach complex. The Woodside Brothers described Arcady as "A national playground where the leaders of contemporary life may sustain their capacity for work by bringing to its utmost the art of rest and recreation."<sup>4</sup> But this was never to be. As a result of the stock market crash in 1929 and the following Great Depression, most of the wealth that the Woodside Brothers had amassed was lost. Although the club continued to run as an inn and country club, the ownership passed hands several times.<sup>5</sup>

The club was reorganized in 1944 under the ownership of Mr. Frederick Albert Warner Miles, whose family owned and operated many fine hotels throughout the south during that time. At that time, Miles changed the name of the club to Pine Lakes International Country Club and sold 18 holes of the original golf course layout to Mr. John McLeod for real estate development. The club became a private facility in the 1970s and the 42 guest rooms and dining facilities were closed to the public.<sup>6</sup>

Although the Woodside Brothers' had lost their fortunes, they did build the first golfing facility in Myrtle Beach and paved the way for Myrtle Beach to become the golfing mecca that it is today.<sup>7</sup>

Over the years, Pine Lakes has been host to many famous people, both golfers and non-golfers. It was the birthplace of Sports Illustrated magazine, which was founded in 1954 by a group of Time-Life executives who had come to play the well-known golf course and plan a new weekly sports publication.<sup>8</sup> Known as "The Granddaddy," the Ocean Forest served as the introduction of golf to an area that would become the "Golf Mecca of the World."<sup>9</sup> It is one of over 40 golf courses along the Grand Strand area. Golf has become a big form of entertainment, with Pine lakes being visited by people from all over the world, every year.<sup>10</sup>

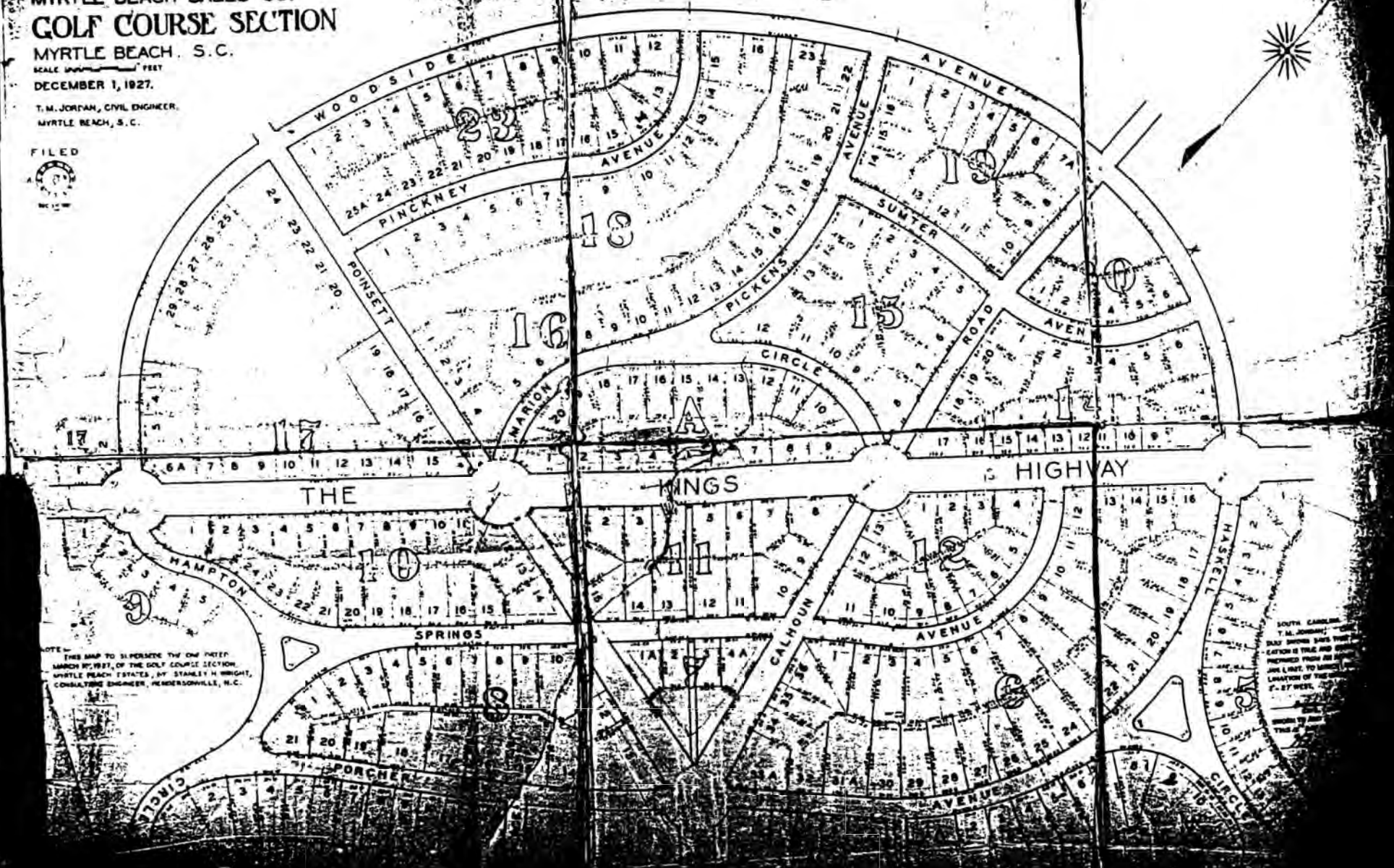

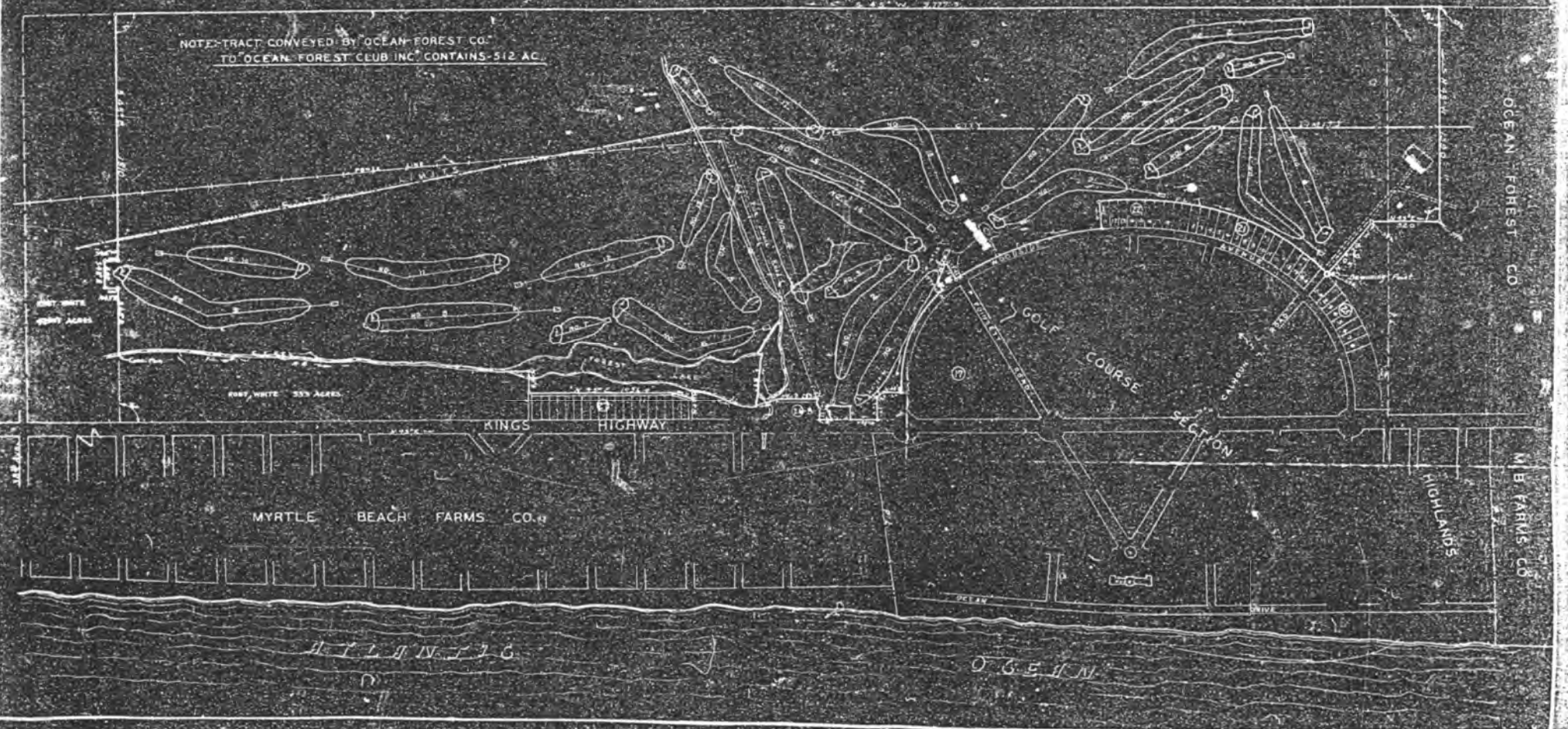

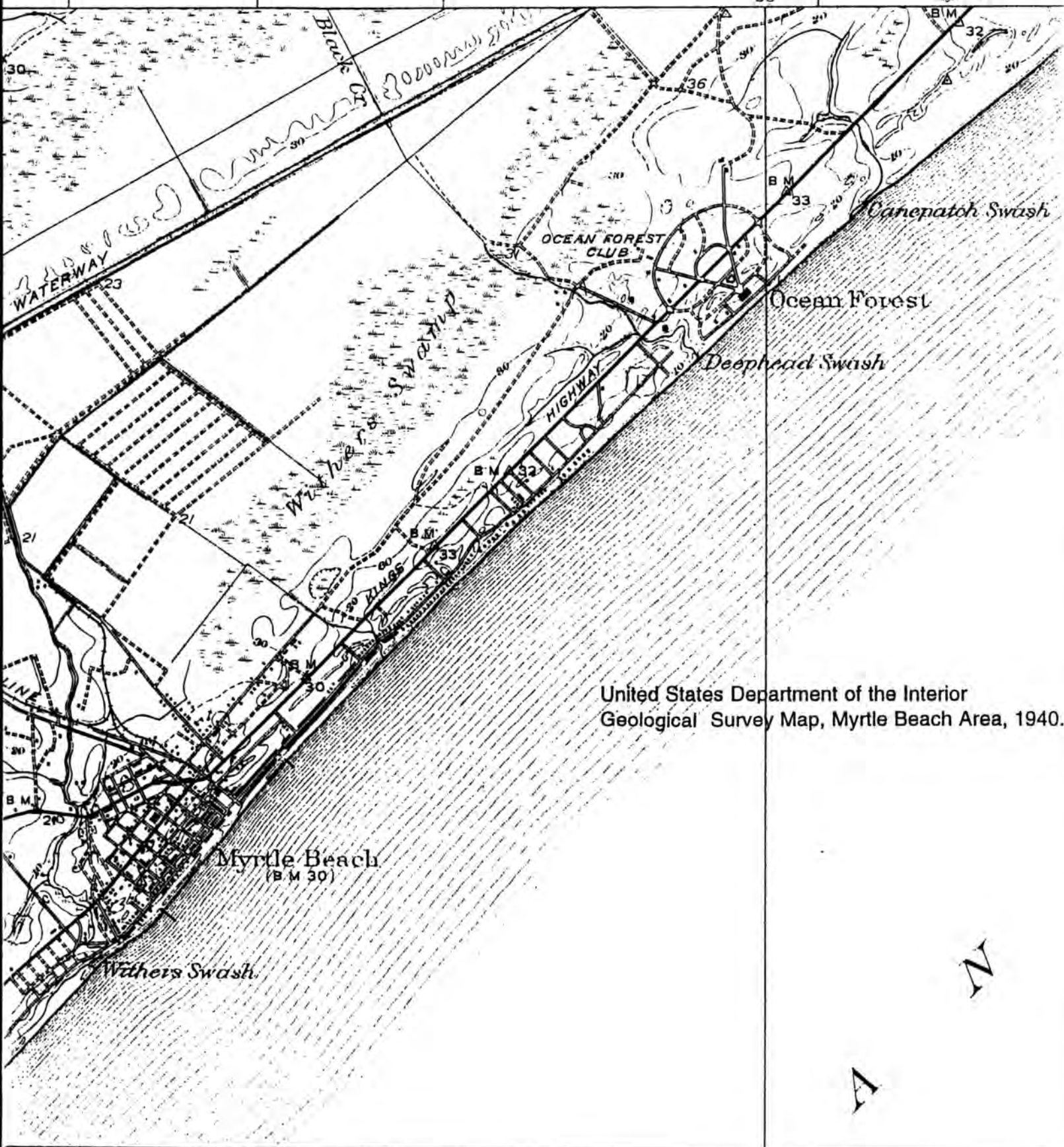
