Describe the present and original (if known) physical appearance

The Hamblen Block (1835) consists of four adjacent brick row-houses of almost identical configuration. Each is three-and-one-half stories tall above a half-story basement, the common foundation being of field-stone with granite trim. Their pitched roofs are asphalt and/or slate shingled, shielded by parapets, and prominently separated by party-wall projections, each of which abuts two chimnies. The block's gable ends are flat, unornamented, and irregularly fenestrated.

The four facades retain a sharp and quite uniform appearance, although inspection reveals small idiosyncracies of later date. Each is three-bayed with entrance hall to the right, the doorways framed by simple Greek Revival surrounds. Two of the entries (nos. 188 and 194) retain their original sidelights. One original door (no. 192) has been replaced by Victorian double doors, with an iron railing replacing the original wooden bannister.

Each facade window has a brownstone sill and lintel. Fenestration is as follows: short, double-sash on the basement and top half-stories, full double-sash on the first floor, and triple sash on the second floor. Number 190 is the exception, the second-story windows having been reduced to double-sash length (date unknown). About one-third of the windows retain their original 6/6 and 6/6/6 glass (3/3 in the half-stories).

The brickwork is painted on all elevations save for the rear walls of the two middle units (nos. 190 and 192). The facade windows had shutters as late as 1924.

An ornamental iron-work balcony that originally extended across the entire facade, below the second-story windows, was long ago removed. A few iron supports remain as evidence.

Small yards for each unit extend to the block's rear. The rear elevation is plain but regularly fenestrated. The windows are segmentally arched with brick lintels. A one-story brick ell extends to the rear of number 188.

The interiors are simply ornamented in the Greek Revival manner, with original doors, railings, mantels, etc.

Statement of Significance (in one paragraph)

Portland's Hamblen Block is one of the two oldest surviving units of brick Greek Revival row-houses in the state. The type is extremely uncommon in Maine generally, the few other examples, with the exception of the Samuel True Block (1835-36) in Bangor, being confined to Park Street in Portland.

Portland's Park Street row-houses, including the notable Park Place Row, were constructed exclusively in the late 1840's, more than a decade after the Hamblen Block. While Park Place Row is the largest and perhaps most decorative of the city's rows, its originally uniform facade is interrupted at two points by later Victorian bays. Except for the most minor changes, notably the replacement of one door and certain window sashes, the Hamblen Block remains completely uniform.

Bangor's True Block, dating from the same year as the Hamblen, has experienced numerous exterior alterations and is in poor physical condition.

The Hamblen Block is named for its developers, Nathaniel and Eli Hamblen, who financed numerous other rows and double-houses during Portland's westward expansion.
