

### 7. Description

Architectural Classification: Late 19th and Early 20th Century American Movements: Craftsman

Describe present and historic physical appearance.

This 1½ story, wood frame, Craftsman style residence sets on a concrete foundation and has a gable roof with asphalt composition shingles. The eaves have simple rafter ends with simple bracket supports at the gable ends. The two shed-roofed dormers, facing north and south, have three 3-over-1, double-hung wood sash windows, and exterior wood shingle siding. A variation in siding divides the exterior walls into three horizontal bands: wood shingles extend from the foundation to the sills of the first floor windows; above this, narrow lap siding covers to the headers of the first floor windows; wider lap siding covers the upper portions of the gable ends. A full width front porch is set under the main body of the roof and is screened. The brick chimney, located in the north center portion of the roof has a corbelled top, as do most of Hardin's Craftsman style houses.

To the rear of the lot, west of the house, sets a small, hip-roofed garage with exposed rafter ends. Sided with wood shingles, this garage dates from the early 1930s (tax record)—within the historic period of significance—and contributes to the historic value of the property.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The J.J. Ping House is eligible for the National Register under Criterion C, as an excellent example of Craftsman style residential architecture in Hardin. The house gains significance under Criterion B, for its important associations with J. J. Ping, an individual active in the business and social life of early Hardin.

The house is a very well-preserved example of Craftsman architecture, having had no additions or alterations made to the structure over the years. It typifies the Craftsman style in its square massing, projecting, upper-level dormers, and ample front porch supported by battered piers. In addition, the house achieves a characteristic horizontality through the banded fenestration rhythms, contrasting bands of wood shingle and narrow lap siding, and the low-pitched roofline with its projecting eaves and exposed rafter ends and brackets.

The original owner of the house, John Boyum, was a partner and manager of the local English and Boyum Lumber Company. During the late teens, Boyum purchased several lots in this undeveloped Hardin city addition. Although undocumented, it appears that in association with the lumber company, he developed several properties during that period, erecting sturdy homes of Craftsman design. Three houses were erected on portions of this, lot 7, by 1920. The J.J. Ping House was apparently built in 1919, and sold by Boyum to the first resident, E.B. Russell, for \$5,000. Russell was a sales clerk for W.A. Peden, owner of Hardin's first general store.

James Jackson Ping, always known as J.J., arrived with his family in Hardin on September 15, 1916, to enter the mercantile business. They started Ping's Ladies Ready to Wear with \$1,300 from the sale of their previous home in Liberal, Missouri. In 1921, they purchased this house from Ernest B. Russell, and the home is still owned today by their daughter, Margaret Ping.

J.J. and Ruth Ping were actively involved in community affairs, on many levels, throughout their lives. Ping was associated with the First National Bank, as Vice President of the Board of Directors in June of 1927. He remained with the bank for 50 years until his retirement in 1973. He also served on the school board for 15 years. Ruth was active in church work, Girl Scouts and, for many years, the Cancer Drive. Both were active in Masonic groups both locally and in the state.

Quote from Lookin Back, p. 188:

"While Ruth was always taking up new interests and hobbies, J.J. kept loyal to his great interest in gardening. He found it hard to understand anyone who didn't want to grow things.... Both were interested in having Hardin enjoy all the good things which a town can provide for its citizens, and had a part in establishing the Community Center, the Mountain View Rest Home, the Masonic Temple, the Senior Citizens' Center. J.J. was chairman of the Cemetery Board from the time it was established, and took great pride in seeing it change from a brown, dusty hillside to the green and shady place it is today. Ruth died in 1970, and J.J. in 1975. Both are buried in the cemetery they spent so many hours planning for beautifying."
