Describe the present and original (if known) physical appearance

The Castine Off-The-Neck Historic District consists of eleven scattered farmhouses strung along a rural highway leading to the village of Castine. The southern boundary of this district is formed by the British Canal, a man-made earthen ditch which separates the peninsula from the mainland. Hatch Cove marks the southeast and eastern boundary, and a heavily wooded area defines the natural boundary on the west and northwest. The northern terminus of the district is at a private driveway which was formerly Ferry Road where it intersects the highway, Route 166.

The following buildings and one site contribute to the character of the historic district. All are located on Route 166:

- a characterization of the Description Site No. ې د سه د د ده او شر ش شاره د انه س British Canal, 1814-15 Dug for defensive purposes. 1
 - Earthen ditch, 10-12 feet wide and 80 rods long extending from Wadsworth Cove to Hatch Cove at the beginning of Castine Neck.
 - 2 Jonathan Hatch House, c. 1795-1800 Federal style, 2 story, wood frame, clapboard siding, large central chimney, 6/6 double-hung sash, entrance with sidelights and fanlights.
 - Hatch/Keener House, c. 1795-1805 3 Federal style, 2 story, wood frame, clapboard siding, hipped roof, double chimneys, windows with 2/2 or 6/6 double-hung sash, entry with pilasters, cornice and Gothic transom light. House moved a few hundred feet in 1982, ell detached and retained on original site, porch added to south side of main house.
 - 4 James Scott House, c. 1765 Vernacular, $1\frac{1}{2}$ story, wood frame, clapboard siding, gable roof, 6/6 and 9/6 double-hung sash, central chimney.
 - 5 Miles Gardner House, c. 1805 Federal period, $1\frac{1}{2}$ story, wood frame, clapboard siding, gable roof, one story ell on north side, 6/6 and 9/6 double-hung sash.
 - 6 Oliver Parker House, c. 1690-1810 Federal period, $1\frac{1}{2}$ story, wood frame, gable roof, clapboard siding, 2/2 double-hung sash, central chimney, two large dormers and ell added early twentieth century.
 - 7 James Hatch House, c. 1824 Federal period, $1\frac{1}{2}$ story, wood frame, clapboard siding, gable roof, central chimney. Renovation in 1960 removed attached carriage barn and two ells, added new smaller ell, replaced late nineteenth century 2/2 sash with 6/6 sash, rebuilt central chimney.
 - 8 Joseph Wescott House, c. 1800 Federal period, $1\frac{1}{2}$ story, wood frame, clapboard siding, gable roof

Statement of Significance (in one paragraph)

The area included in this nomination represents a rural landscape which has changed little in the last two centuries and includes eleven farmsteads dating between 1760 and 1820.

The turbulent history of the town of Castine is well known. Disputed for a long period between the English and French and later the English and Americans, it was an important seaport until the end of the days of merchant sail.

Geographically the town is dramatically separated between the more heavily populated and commercial peninsula located between Penobscot Bay and the Bagaduce River and the Off-The-Neck or mainland area connected to it by a narrow piece of land. The peninsula area was listed on the National Register as the Castine Historic District on February 23, 1973.

The Off-The-Neck area, part of which is the subject of this nomination, is separated from the village historically and econimically as well as by geography. Settled beginning in the 1760s it depended largely on an agragarian economy and provided the produce required by the more heavily settled peninsula which was entirely maritime oriented with shipping, ship building and fishing. Also unlike the peninsula, this region was relatively unaffected by the political and military strife which typified the history of the village. Indeed, the "British Canal", which marks the southern boundary of the district, was actually a defensive barrier constructed during the English occupation in the War of 1812. This earthen ditch is both a real and symbolic symbol of the division between the mainland and the strategic port of Castine.

The houses in Castine Off-the-Neck Historic District are typical examples of Maine farmhouses built during the Federal period (1790-1830). Similar examples can be found scattered throughout Hancock County. The hilly terrain, with combinations of woodland and open fields bordering rocky inlets, are also characteristic of the region. What distinguishes the area included in this district is the very high concentration of relatively unaltered Federal and Greek Revival style farmhouses located in an unspoiled area. Thus, the boundaries of the district are easy to discern and to extend them in any direction would take in large numbers of houses ranging in age from the late nineteenth century to the 1980s.

This historic district is based on a survey conducted by the Castine Historical Society of the entire Off-the-Neck region of the Town of Castine in 1985.
