General Superintendent's Residence

The General Superintendent's residence occupies a beautifully landscaped site on the shore of Trout Lake east of the general office building. The residence, constructed in 1911 under the superintendency of Michael Godfrey (J.C. Greenway's replacement), replaced an earlier log superintendent's residence. The structure housed either the district general superintendent or the superintendent of the local Walker Mine until the 1950s, when the company disposed of all its remaining rental property.

The large 2½ story frame structure is covered by a multi-gabled roof with gabled dormers on the north and south sides. The main gable on the east-west axis is clipped. An exterior brick chimney is situated on the east facade. A simple entry portico shelters the principal entrance on the north facade; a rear entrance is sheltered by an enclosed balconied porch. The structure is sheathed in clapboard, with the lower portion painted dark green and the upper portion, originally shingle-sheathed, painted light green. Fenestration is irregular with 3/1 and 4/1double-hung windows situated throughout the upper half. First floor windows are 1/1 double-hung windows. The interior remains virtually intact. A detached frame garage is located behind the house.
