

#### SUMMARY:

The Church of the Holy Spirit at 1099 Hesperides Road contributes to the Lake Wales Multiple Property Group under Associated Property Type F.3, Public, Transportation, and Religious Buildings of Lake Wales, 1919-1928. Built at the height of the Florida land boom in 1926, the church is an excellent example of high-style Spanish Mission architecture. The church is situated on a large corner lot dotted with palm trees. Its style is expressed by a gable roof with barrel mission tile, curvilinear parapet ends, large central dome, bell tower, entrance porch with round arch openings, stucco exterior wall fabric, and round arch triple windows with spiral column dividers.

#### PRESENT AND ORIGINAL PHYSICAL APPEARANCE:

The Church of the Holy Spirit is located on the southwest corner of Hesperides Road and Eleventh Street. The lot contains palm trees and shrubbery, some of which date from the historic period. The surrounding walkways also date from the historic period.

The building is constructed of hollow tile with a rough stucco exterior wall fabric. Its steeply-pitched gable roof runs perpendicular to the main facade and terminates at decorative curvilinear parapet gable ends. An octagonal dome with a flared roof, round-arch stained glass windows, and cross finial extends from the ridge of the main roof which is clad with barrel tile. The building sits on a poured concrete foundation.

The main (south) facade consists of a curvilinear parapet gable end wall with a cross finial. A two-story flat roof extension with a curvilinear parapet extends from the center of the facade and has a triple round-arch stained glass window flanked by recessed round-arch openings with inverted conical sconces. A one story, gable roofed entry, with arches, a curvilinear parapet, and cross finial, is attached to the two-story extension (photo 1).

The west side of the building has six bays and an entry similar to that on the main facade. It is distinguished,

however, by decorative scroll-cap buttresses, placed between large round-arch stained glass windows, and a corbelled arch frieze. The northernmost bay contains three rectangular window openings and a rectangular door approached by a steep stairway with wrought iron railings. A narrow tower with a side gabled, tiled roof rises above the buttress located to the south side of the stairway (photo 2).

The east side of the building is similar to the west side, with five round-arch windows divided by scroll-cap buttresses and a corbelled arch frieze. It is distinguished by a corner bell tower with chamfered corners and a rectangular hipped roof crowned by a cross finial. The belfry has round-arch and rectangular openings (photo 3). At the north end there is an entry and stairway similar to the one on the west side (photo 4).

The rear (north) elevation has a curvilinear parapet gable end wall and a large round-arch window flanked by two smaller windows. A small, rectangular service entrance is located in the east corner and a raised round-arch projection with a battered blind arch extends from the center of the elevation (photo 4).

The exterior of the building retains its architectural integrity to an unusually high degree. Alterations to the structure are minor, consisting of the addition of an air conditioning unit in a rectangular window opening in the rear of the building and the enclosure of a round-arch opening at the base of the bell tower.

The interior of the church features a large open sanctuary with wood pews and a vaulted, coffered ceiling supported by square columns and decorative cut stone arches (photos 5, 6, and 7). The center of the ceiling is pierced by a dome which has a central stained glass oculus window surrounded by round arch windows (photo 8). The rear of the church has a balcony with a large cut stone arch opening and an arcaded balustrade (photo 9).

The interior has been remodeled several times. The most obvious changes have been made to the sanctuary area. Recessed in a large arched opening, the sanctuary was

originally lighted by the three round arch windows on the rear elevation of the building (photo 4). A statue of Jesus Christ was perched on a round arch ledge and flanked by angel statuettes. In 1962 the statue and ledge were replaced by a wood panel with a crucifix. In 1970 a wall was constructed to cover the rear windows, the wood panel removed, and the crucifix placed on the wall. In 1989 the Catholic Diocese sold the church to the City of Lake Wales. It is now in the process of being renovated for use as a community art center, but the plans call for little change to the sanctuary. The basement will be remodelled somewhat to provide storage space and a reception hall.

#### SUMMARY:

The Church of the Holy Spirit at 1099 Hesperides Road is significant at the local level under Criterion C as an excellent example of high-style Spanish Mission style architecture, one of the most popular designs employed during the Florida land boom era of the mid-1920s. The church contributes to the Lake Wales Multiple Property Group under Associated Context: Boomtime Development, 1919-1928 and Associated Property Type F.3: Public, Transportation, and Religious Building, 1919-1928.

#### STATEMENT OF SIGNIFICANCE:

The 1927 construction of the Church of the Holy Spirit was the result of six years of planning and preparation. In 1920, the Lake Wales Land Company donated a lot on the corner of Fourth Street and Johnson Avenue as the site for a new Roman Catholic church. Later, church officials felt that this site would be too small for the future needs of the church and traded the land for the present lot on Hesperides Road. The church was originally intended to be a simple wood frame building; however, the affluence which the community achieved during the Florida land boom enabled the congregation to erect a more substantial structure. They hired architect P.C. Samuell of Winter Park, Florida, to draw the plans. The congregation insisted the building be constructed in the popular contemporary Spanish Mission style and that it cost no more than \$7,000 to build.

Although the church trustees voted in favor of Samuell's design for the building in January 1926, construction was delayed for over a year when the collapse of the Florida land boom dried up available loan capital. Not until March 1927 was ground broken and construction begun. The R.W. Burrows Construction Company, a local contracting firm, was hired to execute Samuell's design. In addition, the church hired landscape architect, A.E. de Leon to apply the exterior stucco and lay out the exotic shrubbery and trees that originally dotted the lot. The church was completed and the first services were held in December 1927.

The Church of the Holy Spirit is the one of the most architecturally distinctive buildings in Lake Wales. On the occasion of its dedication the local paper wrote of its appearance:

The building is a masterpiece of architecture and representative of the best thought of men who are on familiar terms with church and cathedral architecture and construction in the old world. One might easily believe that this interesting structure, with its time stained walls and ancient tower, slipped in from some bygone day and settled down for centuries to come in its new modern surroundings.

Almost all of the features which inspired such praise in 1927 remain intact. The church is notable for its incorporation of nearly every defining feature of the Spanish Mission Style: curvilinear parapets, red tile roof, towers, and arched entries and windows. The interior displays distinctive features, including an art glass dome, a coffered ceiling, stone arches, and elaborate capitals.
