ARCHITECTURAL DESCRIPTION

Built in 1914, Brewer's Mill is located about a block west of the Mountain View Courthouse square. The frame weatherboard structure has three distinctive rectangular sections that make up its overall configuration. The building consists of a two-story central block flanked by two one story shed wings to the east and west. Stone piers support each section.

The central block of the building is covered by gable tin roof. Its principal facade (north) is characterized by a wooden platform that leads to an oversized sliding batten door. A single six-over-six double-hung window is placed left of this main entry, presenting an asymmetrical street front facade. A wood awning covers both window and door. The rear elevation of the section has a single door opening flanked by a six-over-six double-hung window to the east. Two symmetrically arranged six-over-six double-hung windows are placed in each elevation on the second story of the block.

Two one-story shed wings flank the central section on the east and west sides. The east shed is a frame weatherboard structure with a fairly steep pitched shed roof. It has a single leaf door, surrounded by board and batten material, on its front and an identical door opening in the rear elevation. The side room addition, with small window openings on its north and south walls, further distinguishes the east wing. This room was built to help house the mill's machinery that proved too large for the standing shed.

A slightly less pitched shed roof identifies the west shed wing. The roof is attached just below the central block's second story fenestration. In keeping with the structure's fenestration, a six-over-six double-hung window is placed on the wing's street facade. Its west side also retains the same window configuration as well as a batten door in the south end of the elevation.

STATEMENT OF SIGNIFICANCE

Brewer's Mill stands as the only historic industrial structure in Stone County. Frances Brewer constructed the mill in 1915. The mill served Mountain View and the surrounding area until the 1960's. Recently, the rehabilitation of the mill's structure and operational equipment was completed and it now functions as a flour mill.
