

The St. Peter's Lutheran Church is located in the community of Dell Rapids in Minnehaha County in the southeastern section of South Dakota. The church is located on a corner lot at Seventh Street and North Orleans Avenue with the surrounding area being residential and commercial. The church was completed in the summer of 1902 and is an excellent example of the Romanesque Revival style of architecture.

The cross-shaped, asphalt shingled church is constructed of Sioux Quartzite, quarried locally. It rests on a foundation of the same material. A steeple is located at the southeast corner. It is constructed of the same materials.

The façade (east elevation) has an entry door at ground level at the northeast corner. The entry has a stone lintel with a keystone. Located north of the entry door is a three story steeple. A staircase leads to an entry in the steeple. A Romanesque stone arch surrounds the entry. The second floor of the steeple has a narrow, arched double hung window on each elevation. The third floor has a square opening on each elevation. It is covered with screen mesh. A stone water table is located above the square openings. The steeple is topped with a pyramidal roof. The roof is capped with a metal finial. The gable portion of the façade has a large central stained glass window with a smaller arched stained glass window on either side. Each window has a stone Romanesque arch lintel. Located in the gable peak are three small rectangular windows. They have a flat stone lintel and sill. A small, one story, shed roof portion is located at the northeast corner. It has an entry door with a transom window. The north elevation of this portion has a narrow window with a hopper window in the bottom section of the window.

The north elevation is three sided with a conical roof. The two sides have a fixed paned window, the main section and a hopper window at the bottom. The middle section has no openings.

The west elevation has a shed roof portion at the northwest corner. The west elevation has an entry door with a transom window. The north elevation of this portion has a narrow fixed pane window with a hopper window in the bottom section of the window. The gable portion of the west elevation has a large, central stained glass arched window with smaller stained glass window on either side. Each window has a stone Romanesque arch lintel. Located in the gable peak are three small rectangular windows. They have a flat stone lintel and sill. A small doorway was cut into this elevation adjacent to the large stained glass window to connect the historic church via a breezeway to the non-historic educational building. The northwest portion of the west elevation has two sets of one-over-one double hung windows at the basement level. The second floor has two sets of fixed pane windows with hopper windows at the bottom.

The south elevation has a three-over-one double hung window at the southeast and southwest corners of the basement level. Between the two windows is a band of four three-over-one double hung windows. Each of these windows has a flat stone lintel with a keystone. Located in the center of the first floor is a large round stained glass window. The round window is recessed with a Romanesque stone arch surrounding the window. On either side of the round window is a fixed pane window with a hopper window at the bottom. These windows have a flat stone lintel. Located in the gable peak are three small rectangular windows. They have a flat stone lintel and sill.

The interior of the church features an ornately carved oak altar with matching railings in a recessed alcove all accessed by a central aisle. All of the large stained glass windows depict religious symbolism.

Statement of Significance

The Dell Rapids Lutheran Church is eligible for the National Register of Historic Places under Criterion C for its architectural style of Romanesque Revival. This is a highly uncommon style in South Dakota.

Minnehaha County is situated in the southeastern portion of South Dakota and has an abundant water supply with the Big Sioux River and Split Rock Creek. While the major city for the State, Sioux Falls, is located in this county, the majority of the county remains rural and agricultural because of its rich soil. The community of Dell Rapids first saw claims made in the early 1870's. From the beginning of Dell Rapids settlement, there has always been a religious facility in the community.

St. Peter's congregation was organized in 1887. The congregation had no church and for some time their services were held in the homes of members. Later they rented the Episcopal hall. Soon, they needed more room and moved to the Presbyterian church and finally found a home in the Danish Baptist church. As the congregation was continuing to grow, the decision was made that a larger facility was needed. On December 28, 1900 action was taken and a new church building was started. The new church, located at the corner of Seventh Avenue and North Orleans Street was completed in August of 1902. It was designed and constructed by the Paulson Brothers of Dell Rapids.

In March 1918 the congregations of Stordahl and St. Peter's Lutheran Churches were combined in Dell Rapids. St. Peter's Church was to be used for divine services. It is at this point that the name of the facility changed to the Dell Rapids Lutheran Church.

The St. Peter's Lutheran Church is significant under Criterion C for its architectural merit. The church was constructed in the Romanesque Revival style. Romanesque Revival is typified by round topped arches occurring over the windows; masonry walls, usually rough faced; towers present; and an asymmetrical façade. The St. Peter's Lutheran Church exhibits all of these characteristics. Most Romanesque Revival buildings were constructed between 1890 and 1910 in South Dakota. Because of the expensive nature of this style of architecture, it is very rare in South Dakota.

The St. Peter's Lutheran Church is eligible for the National Register of Historic Places under Criterion C as an excellent example of Romanesque Revival style architecture in South Dakota.
