1790. The house has a shed-roof porch at the front and a one-story kitchen addition to the rear. The main section of the house and the rear addition have gable roofs.

The house has two corbeled gable-end chimneys and a large chimney at the rear of the old kitchen addition. The brick-courses in one of the gableend chimneys are laid in a diamond patterned tapestry, offset by glazed headers. The porch, the roof of which is supported by six wooden posts, rests upon brick pillars, as does the house itself.

Windows are 9/9 double-sash and are grouped in pairs; they also occur at the gable ends of each story -- one to either side of the chimneys. The double front entrance on the porch is matched on the second floor by a central window. Aside from the tapestry chimney, there is no exterior ornamentation.

<u>Interior</u>: The front entrance opens from the porch into a wide hall flanked by a room to either side. The rear addition contains two smaller rooms, and upstairs, there are two large rooms and one small bedroom.

The staircase and much of the original paneling remain. The original large double front doors are still in place, as are other doors in the house with strap hinges and leather washers. Three of the original hand-carved mantels remain; one has a denticulated cornice and high frieze with scalloped oval segments at the corners of the two end panels. The central panel has a complete scalloped oval cut into its center.

<u>Surroundings</u>: The house is standing at its original location on a hill overlooking the intersection of two roads shown on Mills' map (1825). Adjacent to a forest, the property is partially overgrown with brush. Smith's Tavern is approximately twelve miles south of Spartanburg between two creek basins.

Smith's Tavern, a farmhouse built at the end of the Revolution, served as a coach stop in the Spartanburg District of South Carolina and was probably a meeting place for farmers living in lower Spartanburg County.

<u>Transportation</u>: The house is significant as a reminder of the era between the Revolution and 1850, when the stagecoach was a key means of transportation in the state. Travel was slow, and many stops were made at inns and taverns before the final destination could be reached. Almost all of the coach stops were private homes whose owners accommodated guests. Smith's Tavern, overlooking the intersection of two eighteenth-century roads, is located on what was once a primary route from Columbia to Spartanburg and the North Carolina mountains.

<u>Architecture</u>: The tapestried chimney is one of few remaining in South Carolina. Its unusual pattern consists of a chain of concentric diamonds.

The house is on its original site on a high place overlooking two old roads; by virtue of its location, it is a prominent landmark. Many of the original features of the house -- the mantels, the woodwork, doors with original hardware, and windows -- remain in good condition. The house is structurally unaltered and is an excellent example of an eighteenth-century upcountry farmhouse.
