SUMMARY

These two ranch buildings, a headquarters house and a bunkhouse, are similar in style. Both were built of stone in the late 1880's or early 1890's, and have pitched metal roofs. Although they appear somewhat deteriorated, these buildings well express their historical associations.

DESCRIPTION

1. <u>Ranch Headquarters</u> Photos #1,2

The original headquarters house is L-shaped and was built with two-feetthick stone walls in the late 1880's or early 1890's. The hipped gable roof is covered with metal. A shed-roofed portal, supported by simple square posts, extends along the inside of the L. There is an small cement block and wood addition on the southwest side of the house which was built in the 1930's and is now the front entrance. Windows are generally 2/2. Two original chimneys remain, one of brick on the slope of the roof, and one of stone on the ridge. The interior is somewhat deteriorated, and has been divided into several living units for ranch hands.

2. Bunkhouse Photo #3

The bunkhouse, also of stone and built about the same time as the main house, extends to the rear of it. It has a gabled roof covered with corrugated metal and a shed-roofed portal across the front, supported by simple square posts.

SUMMARY

These two working ranch buildings of the late nineteenth century, a headquarters and a bunkhouse, represent one of the large cattle companies, headquartered outside of the Territory of New Mexico, which established vast cattle ranches in the Pecos Valley in the early 1880's. Further, it is associated with the ranching career of Burton ("Cap") Mossman, the founder of the Texas Rangers and a legendary figure in the range cattle business.

HISTORY OF THE RANCH DURING THE PERIOD OF SIGNIFICANCE (1883-1938)

The history of the ranch began in 1883 when W.E. Anderson, vice-president and general manager of the Anderson Cattle Company of Pueblo, Colorado, homesteaded on 160 acres on the Rio Hondo as the headquarters of the company's ranch. John A. Thatcher was the president of the company, M.D. Thatcher the secretary-treasurer, and Frank G. Bloome a director. A Number of small farms and ranches with water rights along the river were bought and consolidated until the Anderson Cattle company owned many acres of farm and grazing lands. After some merging of properties and corporate rearranging common in the cattle business, the Bloome Cattle Company registered the Diamond A cattle brand in 1899. In 1907, in response to a financial panic, the Diamond A Cattle Company was formed by the Thatcher brothers, and Bloome. In 1925 cowman Burton ("Cap") Mossman pooled his holdings with Bloome and Thatcher in a reorganized Diamond A Cattle Company, that owned several ranches including the nominated properties.

Born in 1867 in Illinois, Cap Mossman had arrived in New Mexico with his family in 1882. His long and colorful career in the range cattle business began when he was made foreman of a ranch at the age of twenty-one. By thirty he was superintendent of the Hash Knife ranch, a huge spread whose cattle grazed lands adjoining John Chisum's range until they were moved to Arizona. When the Hash Knife closed out in 1900, Mossman went into business for

himself. Soon thereafter, the governor of Arizona, knowing Mossman's reputation for putting down lawlessness as a ranch boss and a deputy sheriff, asked him to help form and captain a troop of Arizona Rangers to be patterned after the famous Texas Rangers. After a successful stint in Arizona law enforcement which gave him his nickname, Mossman returned to the cattle business, eventually becoming in 1925 a part owner and general manager of the Diamond A Cattle Company. Although a cattleman, he added sheep to the enterprise which he managed for the next twenty years.

The large rock house and the bunkhouse were built in the late 1880's or early 1890's. An adobe ranch house which had been the headquarters is said to have washed away in 1893. For many years the rock house was occupied by ranch managers; now it has been divided into several units for ranch hands. Although Mossman's Roswell home is listed on the National Register as contributing to the Roswell Historic District, these ranch buildings are the only documented properties associated with his ranching career in the Roswell vicinity.

HISTORY OF THE RANCH AFTER THE PERIOD OF SIGNIFICANCE

The Diamond A ranch was bought in 1941 by the J.P. White family, who did not continue to use the brand, but ran large herds of both sheep and cattle. Many acres of permanent pasture and a pecan orchard were planted. More recently, several acres have been devoted to vineyards. Verbal Boundary Description

Begin at point A as shown on the sketch map and proceed to point B along a line (AB) which is ten feet from the furthest extension of the facade of the ranch house. From point B proceed to point C along line BC which runs ten feet from the farthest extension of the facade of the ranch house. From point C proceed to point D along line CD which runs ten feet from the facade of the ranch house. From point D proceed along line DE which runs ten feet from the facade of the ranch house to point E. From point E proceed to point F along line EF to which runs ten feet from the facade of the bunkhouse. From point F proceed to point back to the starting point along a line (AF) which passes ten feet from the facade of the ranch house.

Boundary Justification

These buildings are surrounded by unplatted land. There are no other significant buildings to be included within the boundary. The boundaries have been drawn to encompass both buildings and a small strip of contiguous land.
