SUMMARY

Located on Wells Lake Road, two and half miles southwest of the town of Barling, Arkansas, is the Maness Schoolhouse. Constructed in 1937 to serve the community of Massard, the stone one-room school building was built by the Works Progress Administration (WPA). The structure is the only existing Massard building that was not moved or destroyed when the Department of Defense acquired the surrounding 72,000 acres to build Camp Chaffee in 1941. German POWs added a rear porch in 1943. When the base closed in 1997, the military marked it as an historical landmark to be preserved. The structure is located on 5.21 acres of excess property from the closure of the Fort Chaffee Military Base by the Department of Defense under the Base Realignment and Closure (BRAC 95). The Fort Chaffee Redevelopment Authority, located in the Fort Smith and Barling city limits, owns the structure and land. The future home of the western Arkansas \$4 million nature center will built ½ mile away from the school.

ELABORATION

The Maness Schoolhouse is a single story building with one classroom built by the WPA in February 1937. There are separate restrooms and probable coatrooms along the west side of the classroom. The exterior dimensions are 31 feet 6 inches by 61 feet 8inches (9.6 meters by 18.8 meters). German POWs added the rear porch in 1943, as indicated by the inscription on the north wall of the rear steps. The porch is 15 feet by 61 feet and 8 inches (4.6 meters by 18.8 meters).

The WPA used native sandstone and built the schoolhouse in a plain/traditional style. The dressed stone, thin mortar joints and fine ashlar work found at the Maness school indicates the hand of a trained stonemason. The native stone structure of the Maness School represents an integral part of the history of vernacular architecture in northwest Arkansas. Records indicate Joe Bullington was one of the WPA stonemasons hired for construction of the school.

The schoolhouse and porch are in good condition, although the headers over the rear windows are beginning to deteriorate. The Army maintained the composition shingled roof and it is in good condition. The Army also added gutters on the east and west side to control runoff. At one time there were two outhouses. However, they were removed when the military acquired the land in 1941. Other alterations include the installation of restrooms in the girl's cloakroom. Blackboards were removed and a window was replaced by a door in order for soldiers to go out on the porch. The remaining windows are original to the 1937 construction and are intact. All alterations to the school were made after the military acquired the land between 1941 and 1943.

West Elevation

The main façade of this building faces west and is defined by a gable one-bay central front porch with stone columns over two separate wooden doors. Wood siding and a vent cover the gable end of the porch. A poured concrete slab welcomes visitors to enter through either door. The façade, moving north to south, is fenestrated with two six-over-six windows, one four-over-zero window, then two more six-over-six windows. The stone wall exhibits random ashlar on the fringes of the walls moving toward rubble construction in the middle.

South Elevation

The south side of this building is not fenestrated except for a wooden vent located in the gable end. Large sandstone chunks were roughly squared and set on end with thick mortar joints in an ashlar pattern.

East Elevation

The rear of this building faces east and is defined by the large windows and full rear porch. The rear, moving south to north, is fenestrated with three nine-over-nine windows, a set of double, four-panel windows, doors located below a five-paned transom, then five nine-over-nine windows. The stone wall exhibits random ashlar on the fringes of the walls moving toward rubble construction in the middle. Two interior chimneys are located on the north elevation. A red brick chimney is located on the north side of the rear, and a metal chimney is located on the southern side.

Protruding away from the building on the east elevation is the full rear open porch with balustrades constructed by German POWs. Located along the steps of the porch, a handmade plaque bares witness to the labor of the stonemason who built the porch. Some of the letters of the epigraph are childishly scrawled into wet concrete; others appear either impressed or written by a surer, more literate hand. The message "Built by German Prisoner of War 1943" offers a mute testimony to the useful, mundane work of a foreigner held against his will in the middle of an ocean of land.

The German stonemasons participated in a craft tradition known and practiced in Europe as well as the United States. The WPA stonework on the building itself is random, while the German POW stonework on the rear porch is dressed and laid in courses. In addition, as you walk down the porch stairs, the German POWs laid a large concrete slab. North of the slab and schoolhouse, the German POWs also constructed a stone bar-b-que pit.

North Elevation

The north side of this building is identical to the south side. It is not fenestrated except for a wooden vent located in the gable end. Large sandstone chunks were roughly squared and set on end with thick mortar joints in an ashlar pattern.

SIGNIFICANCE

The Maness Schoolhouse is a wonderful example of WPA construction and a rare example of German POW stone masonry. The building is the last remaining structure from the community of Massard.

SUMMARY

Located on Wells Lake Road, two and half miles southwest of the town of Barling, Arkansas, is the Maness Schoolhouse. Constructed in 1937 to serve the community of Massard, the stone one-room school building was built by the Works Progress Administration (WPA). The structure is the only existing Massard building that was not moved or destroyed when the Department of Defense acquired the surrounding 72,000 acres to build Camp Chaffee in 1941. German POWs added a rear porch in 1943. It is being nominated to the National Register of Historic Places under **Criterion A** for its association with early 20th Century education in Sebastian County. It is also being nominated under **Criterion C** as a good example of WPA and Geman POW construction.

ELABORATION

In the 1820's, President Monroe awarded William McAlister a land grant. The current Maness Schoolhouse was eventually built on land from this grant. The community of Massard grew in this area, and a need for a schoolhouse quickly developed. The first school structure was a log building located a half-mile east of the current building. Sometime later, a white frame building was built to replace the log schoolhouse. This schoolhouse was called the Mazzard Schoolhouse because it was located on the Mazzard Prairie.

In 1889, another school was built on Little Rock Road near the Massard Post Office. The town's name changed from Mazzard to Massard, sometime in the mid-1800s. Since there were two schools named Mazzard/Massard, the first Mazzard School was renamed. Following the custom of the time, the first schoolhouse was named after the family that lived closest to it, which was the John Maness Family. The Maness family was one of the early settlers and was active in the community.

In 1930, the white frame building was replaced with a red brick building. This building burned in November 1936. In February 1937, the current stone building was completed by WPA workers. The schoolhouse was the only public building and was the center of community life. It was used for school, Sunday school, prayer meetings, gospel singing, 4-H Club and Home Demonstration Club meetings, Christmas programs, pie suppers and ice cream socials. After electricity was installed in the building, movies were held once a week.

In 1941 and 1942, the United States Army acquired 72,000 acres to develop Camp Chaffee, including the community of Massard. This was a difficult time for area residents. Approximately 1,300 families were forced to leave their farms and homes when Camp Chaffee was built. The Maness Schoolhouse was saved since the building was only four years old when the military acquired the land. It was turned into a recreational building for military personnel.

In 1943, German World War II prisoners built a rock porch across the back of the building. They also built a stone bar-b-que pit and laid a concrete slab. When the base closed in 1997, the military marked it as an historical landmark to be preserved.

Since 1990, former Maness pupils have held school reunions. A non-profit Maness School Historical Society was organized to keep and preserve the school building. Fundraisers have been held to assist with the preservation of the building and pursue restoration options.

Today, the Maness Schoolhouse in Fort Smith is a living reminder of the now non-existent community of Massard, and the workmanship of the WPA and German POWs. Also, as the last remaining building associated with Massard, the Maness Schoolhouse represents a rare and fast vanishing resource type.

STATEMENT OF SIGNIFICANCE

Located on Wells Lake Road, two and half miles southwest of the town of Barling, Arkansas, is the Maness Schoolhouse. Constructed in 1937 to serve the community of Massard, the stone one-room school building was built by the Works Progress Administration (WPA). The structure is the only existing Massard building that was not moved or destroyed when the Department of Defense acquired the surrounding 72,000 acres to build Camp Chaffee in 1941. German POWs added a rear porch in 1943. It is being nominated to the National Register of Historic Places under **Criterion A** for its association with early 20th Century education in Sebastian County. It is also being nominated under **Criterion C** as a good example of WPA and Geman POW construction.


