State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

White's Mill is significant under criterion A for its association with the milling industry of Blount County. The mill is one of only four existing grist mill properties extant in the county. The original mill at this site was established in 1842 and the present building was constructed ca. 1880. The mill operated until the early 1960s when it ceased operation and the building was abandoned. Grist mills were one of the main industries of the county during the 19th and early 20th centuries and White's Mill was a well known mill in this section of the county. Although the building is in poor condition it remains as one of only four grist mill structures in existence in the county.

The original building at this location was built in 1842 for Isaac White. White dammed a section of Crooked Creek and used tubine wheels to power his mill. The mill was typical of those built in the county and used stones to grind flour and meal for area residents. The mill also contained a tubine powered saw to cut lumber. Around 1880, the present mill building was constructed by miller "Snakey" John Martin who also built the John Martin mill on Hesse Creek. White's Mill was a well known landmark during these years and the road adjacent to the mill was named White's Mill Road.

Later owners of the mill included the Amerine and Whitehead families in the late 19th and early 20th century. John Russell operated the mill during much of the mid-20th century and finally closed the mill in the early 1960s. A photograph of mill taken in 1952 shows the mill building with a one-story porch on the main facade and separate building at the rear to house the turbine wheel. This building has since been razed.




