Summary Paragraph

The Truslow residence sits on a sloping 29, 867 square foot lot below the grade of Halaulani Place, landscaped with a spacious lawn dotted with areca palms and other tropical plants including Hawaiian tree ferns, crotons, and pygmy date palms. The house overlooks Pukihae stream, which forms the southern boundary of the property. The bungalow style house is distinguished by an octagonal sitting room at its northeast corner and an outset lanai running across the remainder of the façade. Two other lanai are on its east side. Its red corrugated metal hipped roof is broken numerous times: by the octagonal sitting room roof, the flat roof of the front lanai, intersecting side hip roofs and a right rear intersecting clipped gable roof, making for an irregular, picturesque composition. The rear, lateral running, intersecting gable roof has figure four brackets and a square, louvered ventilator in its gable end.

Narrative Description

The house sits on a lava rock post and pier foundation, with the 18' x 22', wrap around front lanai sitting on a lava rock base. The front lanai's crawl space is ventilated by round arched openings with vertical wood slats. A diamond pattern lattice apron covers the foundations on the sides of the house. The walls of the house are of 8" clapboard and pairs of eight lite casement windows are used throughout the house for light and ventilation.

Five concrete steps approach the house from the west side and lead up to the 9' wide front lanai. The lanai has a wood floor and is sheltered by a flat roof, which is supported by sets of three square columns that sit on lava rock piers. A simple balustrade with 2" x 2" balusters runs between the piers. The flat roof has overhanging eaves with exposed rafter tails. Its supporting beams have been decoratively carved with a demi-eliptic opening cut into their ends. Two sets of glass double doors, each with twelve panes, access the living room. The living room has a coffered ceiling, fir floor, and masonite walls with a 4' high, board and batten wainscot. Three flat arched openings with shallow pediments, open the living room onto the octagonal shaped sitting room, the central hall, and the dining room. Each of the octagonal sitting room's walls is 6' long and features a pair of casement windows. Two sets of double doors in the living room's east wall, similar to those on the front lanai, open onto an inset, 9' x 16' side lanai which is finished similar to the front lanai.

The dining room features a pair of green mottled glass, craftsman style, wood box lights suspended from the ceiling. It also has on its side wall a built-in sideboard. Its walls, ceiling, and floor are the same as the living room. Along the rear wall of the dining room the wainscot rises to the height of 6' and culminates in a dish rail. Three doors are in the rear wall of the dining room: a five panel hinged door leads into a breakfast room, a twelve lite, hinged door leads to a small rear lanai, and a five panel swinging, with a slit for the servants to look into the dining room, leads into a butler's pantry.

The diminutive, 5' x 11', inset rear lanai is appointed in a manner similar to the other lanai. The breakfast nook has an 8' high, board and batten, paneled dado with masonite walls above. A rear door leads to the kitchen, and a more recent pass through with a koa countertop has been made to connect it to the butler's pantry. Two, single pane, fixed windows are above the pass through. The butler's pantry has original cabinetry, beaded tongue and groove walls and ceiling and its rear door also leads to the kitchen. The kitchen has been remodeled, but retains its original cabinetry with its glass doors in the wall cabinets, and also its beaded tongue and groove ceiling. A stairway leads down to a 1,340 square foot finished basement of modern vintage, which has two bedrooms and a bath.

On the west side of the house are three bedrooms and two baths, connected by a central hall. The hall has a 4' high board and batten wainscot, and its walls and ceiling are composed of masonite. The two bathrooms, one off the rear bedroom, and the other accessed from the hall, have been remodeled; however each retain their original laundry chutes. The bedrooms have been remodeled, but retain their fenestration and the rear bedroom has its original walk-in closet with beaded tongue and groove walls. They retain their five panel doors and brass door knobs.

To the right rear of the house is a free standing garage which follows the design of the house, but is of recent construction.

The major public spaces of the house remain in excellent condition and are intact. The alterations that have transpired occur in less public areas, and are sensitively handled allowing the house to retain its strong sense of integrity.

Statement of Significance Summary Paragraph (provide a summary paragraph that includes level of significance and applicable criteria)

The Truslow/Lyman residence is significant at the local level for its associations with the development of Halaulani Place as well as the development of Hilo as described in the Multiple Property nomination Halaulani Place, 1917-1960. It was one of the first five houses constructed on Halaulani Place and is associated with the Security Trust Company's vice president H. A. Truslow. In addition, it is architecturally significant as a good example of a bungalow constructed in Hawaii in the 1920s. The property is also significant for its associations with Ellen G. Lyman.

Narrative Statement of Significance (provide at least one paragraph for each area of significance)

The Truslow/Lyman residence is significant for its architecture as a good example of a bungalow constructed in Hawaii during the period 1913-1920. The large house is typical of bungalows built in Hawaii in the period between 1913-1920 in that it sits under a hipped roof and incorporates lava rock in its porch elements, as well as its foundation. Its front octagonal sitting room is distinctive providing the residence with an asymmetry and modulation usually associated with the Queen Anne revival style of the late nineteenth century, but is known to have appeared in several bungalows in Honolulu, including the Leroy Bush residence in Kaimuki, as well as the sun room in the Spanish mission revival style Kin Lum residence, also in Kaimuki. The presence of two side lanai, off the living room and dining room also deviates from standard bungalow plans, and most likely is a Hawaii adaptation which not only allowed for outdoor living opportunities, but also afforded ocean views, which now have been obscured by tall trees. In addition, its craftsman style, mottled glass lights suspended from the dining room ceiling were reputedly made at the Hilo Boarding School, and are a rare decorative element in Hawaii houses. The remainder of the interior, with its coffered ceilings, use of beaded tongue and groove, built-in sideboard, and floor plan are all typical of its period.

The house is also significant for its associations with Ellen Lyman. Ellen G. Lyman was the daughter of Frederick and Isabella Lyman, and the sister of Levi Lyman, who resided next door to her on Halaulani Place. Lyman was born in Hilo in 1861, and was educated at Oahu College (now known as Punahou High School) and the Rockford Seminary in Illinois. Upon graduation she returned to Hilo and accepted a position teaching at the Hilo Boarding School, an institution founded by her paternal grandfather, missionary David Lyman in 1836, and over which her father presided for thirty four years as president of the board of trustees. She died in April 1940.

Developmental history/additional historic context information (if appropriate)

The house was built for Herbert Austin Truslow, who at the time of its construction was treasurer and general manager of the Security Trust Company. Truslow was born in Tennessee in 1890, and came to Hawaii in 1911 to work as an accountant for Parker Ranch. In 1912 he relocated to Hilo, where he was employed by the Hilo Breakwater Company as an accountant. He subsequently worked as a cashier for the First Bank of Hilo in Kealakekua and then the People's Bank in Hilo, rising to the position of vice president with the latter institution in 1921. He also served as treasurer and general manager for the Security Trust Company, and in 1921 assumed the positions of vice president and general manager for that company as well as the bank.

When the People's Bank failed, and the Security Trust Company became insolvent, his dwelling was sold at auction to the Lyman family in 1922. Miss Lyman lived in this house until her death in 1940.




