

Description

Summary Paragraph

The Old Holy Redeemer Catholic Church is a one-story, brick Gothic Revival style building located at 120 North Sproule Avenue, immediately north of the downtown commercial area of Kissimmee. The church was constructed in 1912 and features a variety of exterior and interior elements based on Gothic style ecclesiastical architecture. Chief among these are the battlemented entrance porch, wall buttresses, and the lancet arch motif of the stained glass windows. The most striking architectural feature of the interiors is the system of scissors trusses that support the ceiling. The building has gable roof and rests on a continuous brick foundation.

Supporting Narrative

The Holy Redeemer Catholic Church is located on the northern fringe of Kissimmee's downtown commercial area at the northeast corner of the intersection of East Mitchell Street and North Sproule Avenue. The building occupies the northern half of lots 1 & 2 of block 7 of the South Florida R. R. Co. subdivision. This structures and all of the other buildings on the block are owned by the First United Methodist Church, whose main facility is located at 215 Church Street. The other structures are the Sunday school (219 Church Street) and the church offices (116 Sproule Street). The former Catholic church is now the Wesley Memorial Chapel which also serves the Spanish speaking Methodist congregation of Kissimmee as the <u>Iglesia Metodista Hispana</u>. Buildings on the blocks surrounding the church property are commercial structures and those that are used by various department of the city government.

Building Description

The Old Holy Redeemer Catholic Church is constructed of load bearing masonry walls finished with red brick set in running bond. The structure is rectangular in shape and has a steeply pitched gable roof. There is a one-story, one-bay entrance porch on the main street facade and a small, one-story extension with a flat roof on the rear of the building.

Main (Northeast) Facade

The main facade of the building is dominated by a one-bay entrance porch featuring a high battlemented parapet (Photo 1). The parapet of the extension is modelled after a Gothic style

battlement. Rectangular stained glass windows crowned by concrete label moldings are located on all three sides of the parapet or short tower. The porch is supported by red brick piers that have white concrete capitals and bases. The center of the entrance porch features a "Tudor" arch.

The facade of the church is framed by brick buttresses that support heavy corbelled caps that rise above the gable of the facade. The gable end is adorned with sawtooth coping. Three triangular fixed stained glass windows in the gable wall surround the upper half of the entrance porch. Paired sash windows with label moldings flank the porch in the lower part of the wall.

Southeast Elevation

The southeast elevation of the church exhibits a row of paired stained glass windows set in rectangular openings (Photo 2). The windows have label molds that touch the brick buttresses that define the window bays. The southeast elevation of the rear extension exhibits a plain, wooden door with a rectangular transom and a 1/1 double hung sash window with stained glass lights

Southwest (Rear) Elevation

The rear elevation reveals the upper part of the main and secondary gable roofs that cover the sanctuary and altar area of the interior of the building. The one-story flat roof extension is also visible.] (Photo 3). The gable end is clad with pressed metal shingles and has a tripartite stained glass window. The brick wall of the rear elevation has no windows and is where one finds the air conditioning units and electrical service boxes.

Northwest Elevation

The northwest elevation of the church is nearly identical to that of the south (Photo 4). However, the rear extension has two 1/1 double hung sash windows with stained glass lights but no secondary entrance. There is also a small brick chimney located near the center of the elevation.

Interior Features

On the of the church one finds a choir loft, sanctuary, altar, and sacristy. The choir loft is located above the main entrance at the northeast end of the building (Photo 5). The

altar is located at the opposite end of the sanctuary (Photo 6). Doors on either side of the altar provide access to the sacristy. The most striking architectural feature of the sanctuary is the elaborate truss ceiling, which features carved drop pendants. The stained glass windows that line the north and south walls provide natural lighting and ventilation to the interior(Photo 7).

Major Alterations

The Old Holy Redeemer Catholic Church has retained most of its original features. The only major alteration occurred when all of the original stained glass windows in the building were replaced in 1978. That same year air conditioning vents were added to the rear of the building (Photo 3).

Significance

Summary Paragraph

The Old Holy Redeemer Catholic Church is eligible for listing in the National Register of Historic Places at the local level under criterion C in the area of Architecture as a notable local example of Gothic Revival style design as applied to a small church. The building is significant for its exterior and interior planning and for its various decorative details. The building was designed by Maryland architect George A. Ledvina in 1912 to serve the local Catholic congregation. The church contributes to the "Historic and Architectural Resources of Kissimmee" multiple property group as defined under sections E and F of the cover document.

Supporting Narrative

The Holy Redeemer parish of Kissimmee traces its roots to 1895, when a small group of Catholics began holding mass in the home of Mrs. Anthony Tress. The parish was formally organized as the Catholic Church of the Holy Redeemer in 1902. Monthly services were held by Father Fox, who lived in nearby Orlando, in the Kissimmee Theater on Stuart Avenue. In 1911, the growing congregation raised funds to purchase land at the intersection of Sproule Avenue and Mitchell Street on which construct a permanent home for its members. Architect George A. Ledvina of Baltimore, Maryland, was hired to design the structure and work on the church began in 1912. Labor to construct the church was provided by members of the congregation. The cornerstone of Holy Redeemer Catholic Church was laid on May 5, 1912, and the building was completed at a cost of \$7,000.

The building was used as a Catholic church until the 1970s when a new facility was built on Thacker Avenue in northwest Kissimmee. In November 1972, the structure was sold to the First United Methodist Church, which is located on the same block. In 1978 the building was renovated and renamed the Wesley Memorial Chapel. The renovation included the replacement of all of the original stained-glass windows. The building presently serves as a chapel for Spanish speaking members of the Methodist congregation.

Architectural Significance

The Old Holy Redeemer Catholic Church displays many of the defining elements of the Gothic Revival style. These include the

use of pointed arches, a battlemented tower entrance, buttresses, corbelled brick decorative elements, and stained glass. The overall style of the building reflects similar trends in other parts of the United States for the design and construction of small churches of various denominations. The church has no direct stylistic antecedents but is an eclectic mixture of "medieval" forms derived from European ecclesiastical architecture or the Middle Ages and later.

Boundary Description & Justification

Verbal Boundary Description

The boundary for the Holy Redeemer Catholic Church is the northern half of lots 1 and 2 of block 7 of the South Florida R. R. Company Subdivision of Kissimmee, Florida.

Boundary Justification

The boundary encompasses the lot upon which the Old Holy Redeemer Catholic Church was constructed in 1912. This structure and the others on block 7 are owned by the United Methodist Church; however, the other structures on the block are unrelated to the historical development of the Holy Redeemer Catholic Church.
