Description Built ca. 1895, the C.E. Corley House reveals influences of the Oueen Anne style. The house is composed of a two-story, L-shaped main block with a single story ell on the rear. It has a gable roof and weatherboard siding. There is a one-story porch on the facade in the turn of the L. The porch features a gabled and pedimented projecting porch entry, an attached gazebo under a conical wood shingled roof, and turned posts with brackets and turned balustrade. The porch shelters a central entrance with transom and sidelights. There is a similar entrance on the second story, which is sheltered by a small porch with turned posts and brackets and a turned balustrade. Windows are four-over-four. Other distinguishing features are a semicircular bay on the left of the first story, a twelve-inch wide baseboard circumscribing the house above the brick foundation, corbeled chimneys, and a flat scalloped cornice board on the gable ends. The main rooms on the interior feature dentiled crown molding and double-beaded board wainscoting. A large one-and-one-\*\* The C.E. Corley House was built by Charles Edward Corley (1866-1943), a prominent local builder. His expertise in building is discernible in the variety of building styles he constructed, e.g., the ca. 1912 Classical Revival Lexington Baptist Church, the ca. 1891 Lexington Manufacturing Company granite textile mill and operatives' dwellings, the brick bungalow of Dr. P.H. Shealy on East Main Street, and the ca. 1912 Bank of Western Carolina. Corley was also a farmer, and public official, who served as county supervisor (1912-20) and magistrate (1929).
