Pioneer School is located in Park County, Wyoming, approximately 8 miles North of the town of Clark. The school building faces South and is situated on a 2 acre parcel of land lying in a square. The acreage is enclosed by a wire fence except for the West side. County road 1-AG runs South of the school as well as the Clark ditch. The nearest building is more than one quarter of a mile distance, with a pasture and dairy to the West and hay field to the East. On the North the property borders unclaimed prairie. The school grounds are covered by crested wheat grass, sagebrush, and some cactus and Cottonwood trees. The area near the school building is sanded and gravelled with a baseball diamond Southwest of the building.

The Pioneer School is part of a rural agricultural setting and holds a commanding view of the Absaroka range to the West. The area surrounding the school is largely undeveloped with the exception of cultivated lands and appears much as it did earlier in this century.

Pioneer School is a large rectangular shaped one and one-half story, wood frame building with a concrete daylight basement. It has a medium hipped roof over the original one-room school building and the small music room addition on the North, with a gabled roof over the East end teacherage addition. The entrance and bell tower are located between the large school room and teacherage facing South. The building has in recent years been painted white with dark green trim. Originally it was painted brick red. The Pioneer School was designed by architect Curtis Oehme and contructed by H.P. Anderson in 1914. Dwight Wildman excavated the basement.

The original school consisted of one large classroom on the ground floor with double doors in the entry and a storage closet. A water cooler and wash basin were provided in the cloak room, North of the entry.

A coal furnace was placed in the center of the basement with a coal chute and bin on the West wall. In cold weather classes were held in the basement with students huddled around the furnace. In 1930 community dances were held to raise money for a new coal furnace. Students were allowed to work on special activities, hold story hour and have recess in the basement. Two outhouses were located on the Northwest side of the school but are no longer extant.

In 1953 Ray Daugherty completed work on a two-room teacherage addition to the East end of the Pioneer School. It still consists of a combination living room - kitchen and one bedroom. Two bathrooms were probably added at this time to replace the cloak room in an effort to modernize the building and provide a well and indoor plumbing.

In 1956 architect Vernon Drake designed a music room addition which was constructed on the North side of the Pioneer School. It was fitted with counters, cupboards for storage, a sink, and water fountain. At this time the school room was upgraded including the addition of plywood paneling, acoustic tile on the ceiling, new chalkboards, storage space, and fluorescent lighting. A bank of three double windows was added to the South wall of the school room to replace the old windows and two windows on the West wall were covered over. New stairs to the basement were added. A fuel oil furnace was purchased and installed in the basement which was extended to the North to accommodate the furnace. A storage room and hot water heater were added to the East wall. For the first time playground equipment was installed and improvements were made to the grounds.

The overall site possesses a strong sense of association with early twentieth century rural education in this sparsely populated farming and ranching community. Neither the immediate site nor the surrounding community has changed significantly since the school was constructed, and there are no significant modern intrusions.

The Pioneer School is an early twentieth century rural school in Northwestern Wyoming, lying in the Clark's Fork Valley near the Montana border. It is a significant property under National Register Criterion A, because it represents the theme of early twentieth century education in an isolated, sparsely-populated farming and ranching community. Providing the children of Park County with an education presented unique problems. In a vast region with poor transportation and severe winters a number of one-room schools were built to serve the farming community including: Pioneer, Clark, Line Creek, and Paint Creek. As the region became settled and the towns began to grow in population early in the twentieth century, more substantial and permanent buildings were built to replace the earlier one-room log buildings. The larger schools of Pioneer, Clark, and Belfry, Montana, are good examples of these.

The Pioneer School is representative of the second stage of educational development in the region. It represented a substantial physical improvement over the one-room log school. The Pioneer School also reflects the early twentieth century movement toward improved standard school facilities. This standard school plan is reflected in the high ceilings and large floor space, a cloak room and large multi-paned banks of windows set high in the walls. This architect-designed school was a radical departure from the folk vernacular architecture of the one-room log school of earlier days.

The Pioneer school is located where it commands an impressive view of the Absaroka Mountains and the Clark's Fork Valley. It is the only remaining country school for at least a fifty mile radius. This is significant in a county which had forty-five school districts early in the century. Rural schools were closed, abandoned, moved and demolished due to consolidation and transportation improvements. The Pioneer school, however, continued to operate until 1969.

The Pioneer School retains excellent integrity of setting, location, feeling and association. The addition has moderately impacted the buildings integrity of design, but because it retains most of its original exterior it retains strong integrity in the areas of workmanship and materials and does convey a strong sense of time and place.

In the 1890's, as pioneer families began to settle and farm in the Clark's Fork Valley of the Yellowstone, they formed school district #24. This district ran all the way to Yellowstone Park and the Park Reserve. In 1895, the first school for the area, known as the Sirrine School, was built. According to the old school records filed with the State: "The grounds and buildings of the above named district are located on ground that belonged to the public domain when the site was selected so that whoever the land reverts to when deeded, a deed will have to be obtained by the school board. The building was constructed constructed by H.M. Simpson and sons, William Fouse, and W.O. Sirrens and sons and the labor and money expended in the construction of the same was donated to the district. The outer buildings viz coal house and the two closets were built at the expense of the district...A well of water is very much needed but the cost of making one is great...There are seventeen children of school age in the district."

This school, which operated from 1895 to 1904, was located near the property of Warren and Mary Sirrine who also operated a stage stop, ferry crossing of the Clark's Fork, and the first post office which was in existence in 1891. The post office, the community, and the Clark's Fork of the Yellowstone were named for the Lewis and Clark expedition. (Present day Clark is located ten miles upriver from the Sirrine Ranch. The post office has changed locations from the Sirrine Ranch to the Berry Ranch and finally to the Lindquist Store where it operated until 1967.)

According to the 1900 Big Horn County census, which encompassed all of what is now Park County, this Montana border community was settled in the 1890's by the farmers, miners, and ranchers. The day of the cattle king was waning and irrigated farming was coming in on its shirtails bringing with it the first significant population in the Big Horn Basin. The Red Lodge-Meeteetse Trail ran through the Clark area and was the main North-South transportation route through the Big Horn Basin connecting the Northern Pacific railroad at Red Lodge with the Union Pacific at Rawlins.

In 1904, the first Pioneer School was built according to the school board minutes.

"A special meeting will be held in School House district #24, Big Horn County, Wyoming on the 21st day of May, 1904 at 2 o'clock P.M. for the purpose of considering the question of bonding said district to build one school house, one shed, two outhouses, one cistern, one coal house and purchase school house site, and fence in the same...The school was erected on Ed Simpson's property. Bonds for the new school were set at \$1500. This was one of the first standard schools in the area. According to school records compiled by Cody old-timers this school was sold in 1949 and moved to Ralston. School District #24 became School District #4 when Park County was established in 1910.

Pioneer School held classes from 1914-1969. Class rolls indicate that enrollment fluctuated from as few as five students to as many as twenty-eight students over the years.

Education was very important to the Park County populace. Although the Pioneer School was actually constructed before the plan and bulletin for standardizing rural schools was issued during the school year 1919-1920, the architect of the Pioneer School incorporated concepts of hygiene and lighting into the construction of this school in 1914. When standard schools were first recognized in Wyoming in 1920, Park County had nine schools that received the "Standard School" rating which was many more than the other counties in the state. Eight other counties had schools that received the "Standard School" moniker but each of those counties only had one or two schools unlike Park County's nine.

In an attempt to modernize and update the school, a teacherage addition was added in 1953 along with indoor bathrooms and plumbing. In 1956, the building was upgraded and a music room was added to the North side of the building. For the first time playground equipment was installed and the grounds were improved. Until 1957 classes were held for the first through the eighth grades. After that time classes were only held through the sixth grade with kindergarten being added in 1961. The upper grades attended classes at the school in Belfrey, Montana.

School District #4 consolidated with Powell School District #1 in 1969. On August 14, 1970, the Pioneer School, along with two acres, was deeded to the Pioneer Service Group to be used as a Community Center. It is currently governed by a board of five directors.

Over the years the Pioneer Community Center has been used to hold dances, extension club meetings, card parties, anniversary and wedding parties, receptions, benefits, carry-in dinners, and the Clark Reunion. the Pioneer School still serves as a gathering place and landmark tying the community to its past.

On September 9, 1913, board members W.W. Ballard, C.A. Pearson, and Edith Simpson Simpson, held an election to determine whether the taxpayers of the district would support a bond issue to fund a new school. The board resolution read, "Whereas, it is necessary for the proper conduct of the school in said district number four, that a suitable school building be erected and furnished and whereas, there are not sufficient funds in the treasury of said school district number four now available for the erection and furnishing of a suitable school building..." \$2500 in bonds were issued for sonstrucation of the new school. The school was located on 2 acres owned by Josephine Green Lukes and sold to School District #4 for \$1.00.
