Correction to the listing for the E. B. Williams House, part of the Kingman MRA, listed on May 14, 1986.

It has come to our attention that there is an address discrepancy for the E.B. Williams house in Kingman, Arizona. The Kingman MRA nomination lists the address correctly at 531 E.
