

DESCRIPTION: (cont.) brick archivolt on flat arches; stone quoins on ground floor to water table; dentils under cornice on sides; side windows have brick voussiors w/stone sills; brick addition in common bond. Interior has Gothic wooden pews and wooden arches vaulting ceiling; 4 candlelabras hang from the ceiling; split choir; central pulpit w/baptistry behind pulpit; quatrefoil decoration on rafters where they meet wall.

A three-story brick educational building was erected directly to the rear of the church in the 1950s. It is non-contributing.



The boundaries were chosen to conform to town lot R2-10. Beginning at point A on the northeast corner of the intersection of High Street and Lincoln Park Road, proceeding north 100' topoint B, thence east 200' to point C, thence south 100' to point D, thence 200' west to the point of origin. The boundaries were chosen to include the building and its immediate site. One contributing and no noncontributing buildings are included.
