NARRATIVE DESCRIPTION

The City of South Bend, the seat of government in St. Joseph County, lies in the central north section of the county a few miles south of the Michigan state line. The St. Joseph River winds through the city skirting the east side of the downtown commercial area before turning in a westerly direction. Howard Park lies just east across the river from downtown South Bend, and the Sample Street bridge carries its route over the river to Northside Boulevard. The Northside Boulevard riverwall extends southward, and then eastward along the north bank of the St. Joseph River from the south boundary of Howard Park nearly two-thirds of a mile to the Sample Street bridge.

Apart from the interruption created in 1962 when the construction of the SR 23 bridge caused the demolition of a section of wall, the riverwall is continuous for about 3360 feet¹. The site includes the riverwall (photos 1,12), a fieldstone bridge, a fieldstone grandstand located in Viewing Park, and five additional fieldstone stairways at irregular intervals, leading down the bank from the boulevard to the water's edge. Another small stair descends a shallow slope but does not reach the water. The two sets of stairs that lie between the Sample Street bridge and the SR 23 bridge are the most elaborate. A paved walk – dubbed the Riverwalk – created in 1984, runs along the upper bank at the top of the stairs, is routed behind the grandstand, then curves toward the river and continues alongside the riverwall. Only at this point is the Riverwalk within the boundaries of the historic site. While this was not part of the original development, it does not destroy the overall integrity of the WPA work. The stonework is dislodged, even missing in places, especially along the river, where the bank has eroded away from the wall. The concrete mortar needs attention and is gone in some areas. Even so, this is not so great as to compromise the integrity of the structure.

A fieldstone wall, an extension of the northwest abutment for the Sample Street bridge, flanks a stairway whose outside wall curves down to the river (photo 2). The entire ensemble is composed of fieldstone of random sizes. The walls taper at their top. There is not a comparable structure on the other side of the bridge approach.

The next stairway, 243 feet downstream, is more elaborate (photos 3, 4). The top of the stair is set off by low fieldstone piers with roughly conical tops. The stair, which is about twelve feet in width, as well as the associated features are composed of fieldstone in mortar. The landing expands on each side to form exhedras composed of the fieldstone and concrete for the seating. Conical-topped piers form a midpoint punctuation and then the stairway continues straight toward the water, finally set off again by conical-topped piers.

The next stairway (photo 5), 150 feet farther downstream, is the most fanciful of all. The main stair is entered by way of two sets of curving steps that flank an exhedra-shaped space with a seat projecting from its riverside wall at the first landing. Smaller semi-circular benches also extend into the landing area to more or less face the larger seat. From this landing, the main stair extends to the water's edge where there is opening in the riverwall. Like the stairway

upstream, this entire structure is composed of round-topped fieldstone walls punctuated at fairly even intervals by piers with conical tops. The seats are smooth concrete.

A grandstand (photo 6), located 741 feet downstream along the riverwall and past SR 23, was constructed to accommodate the audiences of boat races that were commonplace in the 1930s. This feature is located in a space known as Viewing Park, originally named LaSalle Park. The entire park has not been included in this nomination due to the number of modern intrusions it contains. The grandstand is 110 feet wide; its outside walls composed of the same fieldstone construction already seen in the previously described stairways. The concrete tiers within the walls replaced of the original concrete-capped fieldstone tiers at the time the Riverwalk was created. A staging area (photo 7) immediately in front of the grandstand juts into the river twelve feet and is surrounded by fieldstone-constructed riverwall. Prior to the construction of the Riverwalk, this area was surfaced in grass.

Another fieldstone stair, located 420 feet further downstream, extends directly down the bank to the water's edge with a landing about two-thirds there. These stairs are 8 feet wide and flanked by the same low fieldstone walls already described. The bank is interrupted by additional stairways 152 feet further downstream (photo 10) and 428 feet beyond that (photo 11) plus a shorter flight (photo 8) in the flatter part of Viewing Park. All are characterized by the same fieldstone construction already identified.

NARRATIVE STATEMENT OF SIGNIFICANCE

Southeast of downtown South Bend, following the St. Joseph River, the fanciful fieldstone walls and stairs along Northside Boulevard, built of glacial stones gathered from fields around the county, could be called the quintessential WPA project. As described in the multiple property listing document, "New Deal Work Relief Projects in St. Joseph County, Indiana", the identified property type, "New Deal work projects related to parks and recreation", the Northside Boulevard riverwall is eligible for the National Register for its significance in the areas of recreation and social history (Criterion A). It is also eligible under Criterion C because the site as a whole and its individual elements are representative of the style of construction and site development created by the WPA in St. Joseph County. The site retains integrity of location and setting. Its design and materials remain largely intact and display typical WPA workmanship, specifically the fieldstone construction. The site's high level of integrity confirms its association with New Deal Work Relief Projects in St. Joseph County.

At least on paper, Northside Boulevard along the St. Joseph River was part of George Kessler's 1912 plan for the city's park and boulevard system. His ambitious ideas, typical of his work, called for a system of greenways surrounding the city and running along both sides of the river with parks at intervals. Northside Boulevard was constructed to connect the extant Howard Park (itself to be enlarged) to the smaller property then called LaSalle Park and proceed on to the Mishawaka city limit.

Among the first WPA projects undertaken in South Bend upon its inception in August1935 was the construction and improvement of Northside Boulevard along the St. Joseph River southeastward from downtown. None of the original work on the boulevard roadway itself survives; later improvements built upon that foundation. The original surface of the roadway was gravel. Actually, work on the boulevard had begun before 1935 under the auspices of the Federal Emergency Relief Administration (FERA). Part of the development was the beautification of the riverbank itself, which was done in stages until all was completed in 1938. From Howard Park to Sample Street, WPA workers erected a riverwall using abundant fieldstone found throughout St. Joseph County. The wall was primarily decorative but helpful in flood control to some degree. At irregular intervals fieldstone stairways gave access from the boulevard to the river's edge. Improvement of the area, then called LaSalle Park², was the concluding phase completed in June 1938. Here the stairways were especially decorative, and WPA workers constructed a grandstand suitable for watching the boat races that were held on the river in that area. The park was adjacent to the National Guard Armory, on which the WPA also worked, building additions that included a garage. The riverbank beautification project was highly visible and a point of community pride.

WPA Projects related to parks and recreation often were constructed of recycled or locally acquired materials and assembled in a way that put less emphasis on high finish and refinement and

² Part of the former LaSalle Park became today's Viewing Park, which is the triangular area of land, the widest section between the river and the boulevard, that includes the fieldstone grandstand. The name LaSalle Park was transferred to another small park developed after World War II west of downtown South Bend.

more on direct application and simplicity. The stonework found in all elements of the riverwall site displays those qualities. The fieldstone, irregular in size and shape, was embedded in the mortar in such a way that it created irregular segments of wall and step surface that yielded an impression of rusticity. In summary, the site is locally significant and meets the registration requirements enumerated for its class of property type in the multiple property listing document. It merits listing in the National Register of Historic Places.

VERBAL BOUNDARY DESCRIPTION

From the point at which the east bank of the St. Joseph River meets the southern boundary of Howard Park, follow the edge of the river upstream (southeasterly) to the Sample Street bridge, a distance of 3360 feet. From this point, proceed northeast along the bridge to the near edge of Northside Boulevard, a distance of 49 feet. From there proceed northwesterly along a line exactly paralleling the river's edge to a line extending due east from the point of origin.

BOUNDARY JUSTIFICATION

The boundary includes all of the continuous WPA-built fieldstone structures along the bank of the St. Joseph River along Northside Boulevard southeastward from Howard Park to the Sample Street bridge.
