Narrative Description:

The W. W. Lassiter Building is a one-story brick warehouse, facing east, located at 1308 Levee Street in downtown Vicksburg, Mississippi. To the rear of the building is the Yazoo Diversion Canal, formerly the Mississippi River. Built circa 1907, the Lassiter Building is a rectangular structure with a flat roof ornamented by a corbelled brick parapet. A metal awning protects the east facade.

The building is divided into three separate warehouse spaces, two of which are thirty feet wide (south and center) and one which is sixty feet wide (north). Access to the two smaller rooms is made through wooden, sliding, double-leaf, solid plank doors in the front facade and through an arched opening between the two rooms. The larger warehouse section is entered through two single-leaf paneled doors with arched transoms or through two double-leaf doors identical those of the other two sections. A window filled with non-original sash also pierces the front facade on the far north end. The north facade has four windows which have been boarded up and a square opening into the basement which has also been closed. The west elevation has four small arched windows and four floor-length windows set in arched openings. All of these bays have been infilled with brick or covered with plywood.

The building has a full basement with twelve foot ceilings and a concrete and dirt floor. The north section retains a coal chute and two fireplaces on the east wall and two arched four-light fixed-sash windows and two large bricked-in openings used for loading produce, in the west wall. A large arched case opening provides access between the north section and the center section and an identical opening pierces the basement wall between the center and south sections.

The center and south sections each have a coal chute and fireplace on the east wall. The west wall of each section has a large bricked-in opening that was used to load and unload produce. When a fire destroyed the adjacent building (to the south) in the 1970s, six garage doors were added to the south basement wall. These are not visible from Levee Street.

The W.W. Lassiter Building retains its architectural integrity. Original roof trusses, brick arches between rooms, windows, doors, fireplaces, cypress floors, and coal chutes remain, although some elements have been hidden by new materials.

Narrative Statement of Significance:

The W. W. Lassiter Wholesale Grocery Warehouse, circa 1907, is historically significant in the context of commercial warehousing in Vicksburg, Mississippi. The building is one of three remaining wholesale buildings which help to identify what historically was the largest and most important wholesaling district in Mississippi. The period of significance extends from the date of construction, circa 1907, to 1940 when the W. W. Lassiter Wholesale Grocery closed and the building was converted to other uses.

When the Lassiter Wholesale Grocery Warehouse was constructed in circa 1907, it was one of over fifty warehouse and commercial buildings in the five block area, 1300-1700 Levee Street, that was the Vicksburg commercial waterfront. Warehouses in the district housed wholesale concerns that sold produce, grain, cement, hardware, meat, ice, bottled sodas, cotton, hay and oil.

This district developed because of easy access to the Mississippi River (later Yazoo River Diversion Canal). As early as 1866 (Polk's City Directory of Vicksburg 1866) this area was the home of wholesale and retail establishments selling groceries, boat provisions, shoes, liquor, guns, dry goods, and hardware. The 1300 block contained the majority of buildings, as well as the largest of the wholesale concerns.

The area continued to develop quickly with the construction of a number of railroad lines traversing the waterfront district. In and About Vicksburg, published in 1890, cited that the "Louisville, New Orleans and Texas Railroad and its branches penetrate the interior of this district, and radiate through it in all directions. Points east and west of the city are reached by the Queen and Crescent Railroad system, over which feed, flour, and other Western produce are shipped in large quantities to Alabama and Georgia, as well as Eastern Mississippi; while on the south the river and the LNO and TRR serve again as arteries of the city's commerce."

Vicksburg's location on the Mississippi River and its connection to rail service gave it advantage over other Mississippi cities and helped it continue to dominate import/export trade in Mississippi. Vicksburg's importance was further defined in <u>Picturesque Vicksburg</u> in 1895. The journal reported that "river competing with railroad routes reduce transportation to the minimum of cost and make the city one of the best markets in the entire country. The trade in Western produce, as a natural consequence of low freights, covers a remarkably extensive territory, Vicksburg being the most important centre (sic) for its distribution in the state and supplying an increasing demand, not only in Mississippi but in Louisiana, Alabama and even Georgia. The leading houses in this branch of commerce have warehouses fronting on both railroads and on the Yazoo River Canal, so that the cost of reshipping is reduced to a trifle."

"The largest grain and produce dealers in the State," according to <u>In and About Vicksburg</u>, "have their headquarters here, and are continually making inroads into new territory. Four hardware houses transact retail and wholesale business, the latter on a very extensive scale, and compete successfully with New Orleans, Memphis, and St. Louis. The wholesale grocery and provision trade is especially well represented, and one of the largest wholesale liquor and tobacco houses in the South is located here. The facilities for shipping and receiving merchandise are unexcelled."

Narrative Statement of Significance (continued)

Although Vicksburg lost its first place ranking by population in the state in 1910, it continued to remain the most important wholesale center in the state for many years. The Vicksburg City Directory for 1924 claimed that "Vicksburg is Mississippi's chief wholesale center. Included in the articles handled by its wholesale merchants are groceries, grain, meat, canned goods, dry goods, candy, hardware, agricultural implements, soda waters, furniture, lumber, sash doors and blinds, produce and fruits, clothing, shoes, drugs and druggist's specialities, bagging and ties, and other lines of goods."

The W. W. Lassiter Building is historically significant in the commercial warehousing history of Vicksburg, Mississippi. Because of Vicksburg's location on the Mississippi River (Yazoo Diversion Canal) and its location on several railroad lines that linked the city with points in all directions, it became the State's largest wholesale center following the Civil War and continuing into the first three decades of the 20th century. These establishments were located in the 1300-1700 blocks of Levee Street in downtown Vicksburg. Here there was easy access to the City's port facilities, and rail spurs allowed trains to pull up to loading docks with ease.

In the five block area that was the wholesale/warehousing center of Vicksburg, only three buildings remain in 1993 out of some fifty that stood when the area was at its peak of activity in about 1910. The P.P. Williams and Company Wholesale Grocery Warehouse on the southwest corner of Levee and South Streets, the Biedenharn Candy Company Warehouse on the northwest corner of Levee and South Streets and the W. W. Lassiter Wholesale Grocery Warehouse at 1300 Levee are the only historic buildings still extant in this area (see map).

Many of the warehouses and commercial buildings that were present when the Lassiter Building was constructed at the turn-of-the-century were destroyed by a tornado that hit downtown Vicksburg on December 5, 1953. Other buildings were demolished during the City's Urban Renewal Project in the 1970s or in later years to make way for new development or because of advanced decay caused by many years of neglect.


