# Historic School Is Being Replaced By A Parking Lot

Bishopville, SC (WLTx) -- For many, Bishopville High School was the first de-segregated school they attended. Now, the historic building is now being demolished and replaced with a parking lot and memorial.

Bert Lewis and Willie Charles are two of those students. Both say they'll remember the school for the day black children and white children were finally able to learn together.

While the county administrator, Alan Watkins, recognizes its historic value, he says the building hasn't been used since 2000 and it's time to move on.

"We've realized it's played a significant role in a lot of people's lives" said Watkins.

They're planning to put a memorial walkway where people who graduated from Bishopville High, or worked there, can buy bricks and have their names engraved on them.

They're keeping the school's athletic fields and using the spot where the building sat for additional parking.

When completed Watkins says it'll have, "a football field with stands and lights, we'll have a baseball field with lighting we'll have a gymnasium for our recreational programs" and most importantly, better parking for everyone.

The Lee County Athletic Director says the school gym has seen up to 500 people for a single game but the parking only holds about 120 cars.

The County Administrator plans to have this all finished by the fall and hopes the community will continue to enjoy the games on a site that first brought everyone together.

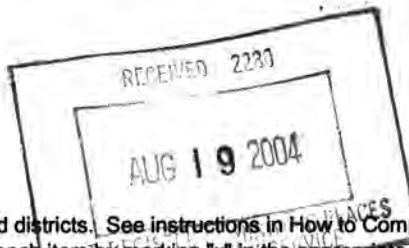

**Narrative Description**

Bishopville High School is located at 600 North Main Street in the city of Bishopville. The nominated property includes approximately 3.3 acres, bordered on the northwest by North Main Street [US Highway 15], on the southwest by College Street, on the southeast by a parking lot and modern brick building, and on the northeast by an athletic field.

**Bishopville High School (built 1936, wing added 1956):**

The original L-shaped building is a two-story masonry structure and rests on a masonry foundation. The lateral gabled roof consists of a steeply-pitched A-frame with asphalt shingles. The original building's elongated main block consists of a highly ornate rectangular central section featuring a row of twelve monumental pilasters [pilastrade] and two-story flanking, projecting, gabled entrance pavilions.

The building's main facade features a beveled cast stone water table, which also serves as a base for the two-story cast stone pilasters. Each pilaster, featuring a stylized Corinthian or minimally Art Deco capital, is highlighted with a stack course surround, which gives the building vertical emphasis. Between each pilaster are paired double-hung windows on both the first and second floors, with each containing nine-over-nine-light wood sash, brick sills and soldier course lintels. The original building is constructed in common bond with sixth course Flemish headers. A cast stone architrave rests atop the pilastrade and spans the length of the central section. The central main block also features a large, graduated, corbel-capped brick chimney with dual clay pots at each end. The gabled pediments are clad in stucco.

Each of the identical projecting entrance pavilions flanks the central bay section and features cast stone steps with brick and cast stone capped cheek walls, cast stone quoins, and a cast stone surrounded entry portal containing a frieze and cornice. Glazed and paneled, double-leaf entry doors with multi-light transoms and sidelights are located within the entrance portals. The upper level of each entrance pavilion features a tripartite window, in the Palladian form, that pierces the architrave. A stepped parapet contains cast stone lozenges, sunbursts, lintel and coping, as well as a field of brick in the upper pediment laid in English bond.

At either end of the central block are symmetrical wings that are recessed and less ornate. Each floor of the facade features a set of triple windows and flanking single windows, all consisting of double-hung, nine-over-nine light sash. The cast stone water table of the central block continues on these wings, as does the bond pattern and window accents. Each wing's end gables feature soldier course brickwork, decorative cast stone accents, and semicircular louvered ventilators with keystones.

The rear elevation is less decorative in detailing and fenestration when compared with the building's facade. The only notable features are the gabled wall dormers with segmental, keystone-arched windows that provide natural light for the interior stairwells.

The original gymnasium / auditorium's elevations are also less decorative in detailing. It is constructed of brick and stone and was designed to seat 600 persons. The roof was constructed of steel trusses and was

originally exposed on the interior.<sup>1</sup> Additions, according to plans by James & DuRant, Architects of Sumter, South Carolina, were made in 1956 to the gymnasium/auditorium wing and along College Street to the rear of the original building. The Avery Lumber Company carried out these renovations and additions. A new gymnasium was constructed in 1965 to the southeast of the 1956 College Street addition, but connected with the original gymnasium/auditorium wing. The original gymnasium / auditorium was renovated to house the school's library. About 1986, other one-story additions were made at the northeast end of the original building and on the southeast side of the 1956 addition to the original gymnasium/auditorium, but these additions do not impact the overall historic architectural integrity of the original high school building.

The interior of the school is accessed at the front through two wide portals located at each end of the building's central block. Within the south portal entrance are the original bronze dedication plaques that contain, on the one hand, the name of the school and the Federal Emergency Administration of Public Works [PWA] project number, and on the other, the school board of trustees' names and those of the builders, Sellers & Hogan, the architect, H.D. Harrall, and the date of construction, 1936. On the south corridor wall, just inside the main entrance doors, is another large bronze dedication plaque containing information for the 1956 remodeling of the school.

The building's corridors feature the original wood baseboards and chair rails. The corridors' original ceiling height is approximately twelve feet but was later lowered, perhaps to accommodate adequate artificial lighting. The long corridor is flanked on both sides by high recessed lockers. Most of the classrooms retain their original features including wood baseboards, built-in closets, wood-framed chalkboards, and twelve-foot ceilings.

The plaster on the interior walls shows some signs of cracks and moisture damage but is in good shape overall. Most of the wood window frames show significant deterioration and peeling paint. The first floor wood floor structure seems to remain in good shape but the second floor is showing signs of deterioration caused by roof leaks. These leaks are having larger effects on the building's interior including mold and plaster damage.

**Statement of Significance**

Bishopville High School in Bishopville, South Carolina, is eligible for listing in the National Register of Historic Places under Criterion C as an excellent example of the type of school architecture that flourished as a direct result of the educational reform campaign in the state of South Carolina in the first quarter of the twentieth century. Additionally, it is an excellent example of the work of Bennettsville, South Carolina, architect Henry Dudley Harrall.

Between 1900 and 1930, the State of South Carolina passed a number of laws aimed at improving education and educational facilities. The 1910 School Building Act, for example, required that buildings constructed with state funds adhere to approved design plans for small one, two, three or four-room schools. For larger schools, school districts were encouraged to use registered architects for design planning. During this period of increased state support for education, new schools such as the Bishopville High School were built across the state by some of the state's leading architects.

In 1933 President Franklin D. Roosevelt set up the Federal Emergency Administration of Public Works (PWA), which constructed new roads, dams, and public buildings. The PWA, like many other federal agencies established under the New Deal, was set up to put Americans back to work in order to stimulate the economy following the Great Depression. Bishopville High School was funded in part by this program and is listed as project number 1033-R.

Bishopville High School is also significant as an excellent example of an educational building in the Colonial Revival style built during a period when emergency funds were made available and many projects of this type were completed.

In addition, it is a noteworthy example of the work of a well-respected South Carolina architect, Henry Dudley Harrall, of Bennettsville, South Carolina. A native of Greenville, South Carolina, Harrall received his education from The Citadel in Charleston, South Carolina, then worked as a draftsman with both the Army Corps of Engineers at Fort Caswell, North Carolina, and the W.B. Smith Whaley & Company in Columbia and Boston. Harrall worked as early as 1906 in New York City, but returned to his native state a few years later and established a practice in Bennettsville, South Carolina, in 1915. He maintained an office there for the next forty years, concentrating his work on projects in the northeastern segment of the state. He served as president of the South Carolina chapter of the A.I.A in 1939-1940. Some of his South Carolina projects include the Bennettsville Presbyterian Church, the Agricultural High School in McColl, the Colored Elementary School in Bennettsville, the Marlboro County Hospital, the Bennettsville Elementary School, the Lee County Memorial Hospital in Bishopville, and Marlboro County Public Library in Bennettsville. Harrall is also well known as the architect for the extensive remodeling of the Marlboro County Courthouse in Bennettsville.<sup>2</sup>

**Statement of Significance (continued)**

As construction on the building began in early 1936, a local Bishopville newspaper read "Excavation work on Bishopville's new \$71,000 high school building started last week by contractor, W.F. Hogan, of Columbia, who is part of the Sellers Holding Company.<sup>3</sup> The new building was to face Main Street and located at the corner of Main and College streets. Part of the property already belonged to the school district as it was the spot where the former building stood. The other portion is to be used as an athletic field and was purchased some time ago."<sup>4</sup>

The former school had been overcrowded for some time and the addition of this building greatly alleviated this condition. The *Lee County Messenger* article continued, "The building alone will cost approximately \$62,000 and is to be constructed of stone and brick. It will have 16 large classrooms, together with offices, cloak rooms, etc., as well as a combination auditorium and gymnasium which will seat approximately six hundred persons. The floor of the gymnasium, according to plans, will be covered with maple flooring. It will be large enough to hold three basketball courts and will have tiers of seats at each end and will also have removable seats which can be placed on the court when it is not used for athletic purposes. The addition of the gymnasium will provide a place for indoor sports during the winter and will no doubt greatly increase the quality of the basketball teams. A suitable court has always been a crying need here."<sup>5</sup>

In addition to the \$62,000 for the building, about \$9,000 was made available at the time to furnish it completely. When completed the building was touted as one of the most modern school plants in the state.<sup>6</sup> Great pride was expressed throughout the school and surrounding community as it became a new place for sporting events and productions. One Bishopville High graduate recalls marching into the school's gymnasium to listen by radio to President Franklin D. Roosevelt's address to a joint session of Congress calling for the United States' entry into World War II following the Japanese attack on Pearl Harbor.<sup>7</sup>

The school continued to operate, with expansions to its physical plant being made in 1956, 1965 and 1986, until its doors finally closed in 2000. The building has been vacant since. Plans are underway for the Rural Crossroads Institute, a program of the South Carolina Department of Commerce, to help the town of Bishopville fund and design a renovation of the Bishopville High School for a community center in 2004-05.

**Verbal Boundary Description**

Bishopville High School is located at 600 North Main Street in the city of Bishopville; the boundary of the nominated property is shown as bold black line marked "Bishopville High School" on the accompanying Lee County Tax Map, City of Bishopville, drawn at a scale of 1" = 100'.

**Boundary Justification**

The nominated property contains the 1936 school building, its 1956 and later additions, the front lawn with mature plantings, and the building's immediate setting.
