Description: Condition: excellent, unaltered, original site

The Creek County Courthouse combines a number of classical architectural elements. It is primarily reminiscent of the Greek Revival and Neo-Classic Revival styles. A three-story structure, it has a partial attic story which accomodates itself to the lines of a monumental pediment. It is constructed of faced, quarry granite blocks. The ground-floor facade is rusticated and is separated from the upper stories by a prominent water table. The monumental pediment is supported by six Corinthian columns and two flanking pairs of plain pilasters. A decorative, carved band of Greek fret design follows the lines of the pediment. Three polished marble insets are centered in the low parapet above the projecting cornice. The six central window units of the second and third stories are woodframed one-over-ones with narrow one-over-one sidelights. The window frames are painted white. The front entrance incorporates an ornate pointed cornice supported by stone brackets. A new, metal-framed double door is topped by a single-pane glass transom.

Significance: 1915; Builder/architect: Unkown

The Creek County Courthouse is significant because it has served since 1915 as the repository of the county's official records and as the headquarters of local government. It is also architecturally significant because it is an outstanding example of monumental public architecture. The building is in very good condition and is centrally located in downtown Sapulpa. The quarter block behind the courthouse is a park with a grandstand where summer band concerts are held. The building and its grounds are very much a vital part of the community's political and social life.
