This courthouse has an unusual exterior plan. There are octagonal pavilions on each corner of the rectangular design. Double arches mark the entry and a dome, rather eastern in feeling, rises from the center of the building. In recent renovation the windows of the dome have been enclosed.

The interior has been renovated and wooden paneling and acoustical tile have been added. Some of floors are terrazzo; some are carpeted.
