

Summary

Located at 412 Powell Street, in the center of the town of Cotter, the Old Cotter High School Gymnasium is a rectangular stone structure with a gable-on-hip roof that was built by the Works Progress Administration from 1936 to 1938.

Elaboration

Constructed from 1936 to 1938, the Old Cotter High School Gymnasium is a single-story, gable-on-hip roof structure that was built by the Works Progress Administration in a heavy, rustic manner utilizing rough-cut native stone from Calico Rock. The almost monolithic expanse of irregular-coursed stone is punctuated on each elevation by concrete window sills and lintels.

The front, or northern, elevation is symmetrically composed with a dominant projecting center section that features two large concrete arches with keystones flanked by concrete pilasters. The arches originally denoted the opening into a large, recessed porch. Unfortunately, these arches were recently bricked-in and double doors installed within each archway. On either side of the projecting entrance bay, the facade is fenestrated by a pair of window openings with unadorned lintels and sills. The windows on all sides of the gymnasium were filled in with wood at some point, and the original sash configuration of the windows is currently unknown. Both window groups are outlined by a pair of plain concrete pilasters.

The northern end of the western elevation is fenestrated by two tall windows which are at the same height and configuration of those seen on the north facade. The remainder of the western elevation projects several feet out from the northernmost end. Although the interior is one-story in height, the projecting body of this western elevation is fenestrated by windows at both the top and the bottom levels which effectively divides the large mass of the structure. Another device that is used to add texture to the surface of the western elevation are the six pilasters which are spaced evenly along the wall. They begin as a part of the continuous cast concrete foundation and rise up almost to the eave. The four smaller windows on the first "level" and the five larger windows on the second "level" of the projection all have simple concrete sills and lintels.

Pilasters are absent on the rear, or southern, elevation, which contains two small windows directly under the eaves in the center and two larger windows directly below. Access to the interior can be gained on this elevation by two single-leaf doors on either side of the four center windows.

The eastern and western elevations are similarly composed; however, pilasters are not utilized on the eastern elevation, and there is only one level of windows due to shorter wall height.

The roof of the structure was altered in 1988 when the gabled portion of the roof was replaced with a metal design. The hipped roof component features an overhanging eave with exposed rafter ends. At the time the roof was changed, the concrete platform which flanks the entrance on the northern side was also replaced due to cracking and general deterioration.

The interior of the structure features new seating (which approximates the original style) on the east side and the original stage on the west side of the gym floor. The majority of the gymnasium floor is original, although certain sections have been replaced. The stage area features a brown formed concrete arched opening with a keystone and a single pilaster on each side. This concrete is intended to replicate randomly patterned stonework, much like that seen on the exterior of the structure.

Summary

The Old Cotter High School Gymnasium is being nominated under Criterion A as an amendment to the multiple property nomination, "Public Schools in the Arkansas Ozarks, 1920-1940." The gym is locally significant for its association with Works Progress Administration and as the only extant component of the historic Cotter High School complex.

Elaboration

Located on bluffs overlooking the White River, the town of Cotter was incorporated on July 7, 1904. The land was first homesteaded by Jonathan Cunningham in 1868, although the site had long been popular by the Native Americans due to the presence of the "Big Spring" (within the current Cotter City Park). Cunningham later sold his 300 acres to L. P. Kemp, and a ferry and steamboat landing were soon established under the name of "Lake's" near the Big Spring. Lake's Ferry became popular as a summer resort for many city dwellers during this period. In 1892, Thomas Combs purchased the land from Kemp, but prospects for development stagnated until a survey crew for the White River Division of the Missouri Pacific Railroad visited Baxter County

in 1901. Two years later, Combs formed the Red Bud Realty Company with W. V. Powell of St. Louis and Jerry South of Mountain Home. Powell was a member of the first survey crew and was in charge of securing right of ways. A new town was laid out in a grid pattern with provisions for the train yard and roundhouse to be located on the river bottom, the residential district extending up the bluffs, and the business district in between. The Cotter Post Office was established on January 26, 1903.

At the time of incorporation, the town had approximately 600 residents, many of whom were living in a "tent city" that was located along the river. However, the population more than doubled by the official opening ceremonies for the town on November 23, 1905, and most of the tent dwellers had moved into frame houses. In the late 1920's, Cotter was the most populated town in Baxter County due in part to the presence of the Missouri-Pacific Railroad repair shops.

During the difficult times of the Great Depression, the Works Progress Administration contributed to the struggling local economy by employing local craftsmen in the construction of a new high school and gymnasium for the town. Unfortunately, the high school building was destroyed by fire in 1977. In 1982, the ruins were leveled by the city to create Warrior Memorial Park, which includes a playground area and tennis courts. The gymnasium continued to be utilized by the school district until 1980, when the new high school complex was finished. Currently, the structure is undergoing rehabilitation for use as the North Arkansas Youth Center and will continue to be used as a gymnasium.

The Old Cotter High School Gymnasium is locally significant under Criterion A for its association with Works Progress Administration and as the only extant component of the historic Cotter High School complex. It is being nominated as an amendment to the multiple property nomination, "Public Schools in the Arkansas Ozarks, 1920-1940."

Beginning at a point created by the intersection of a line formed by the southern curbline of Powell St. and a line formed by, yet fifteen feet from, the western elevation of the gym, proceed southerly along said line to its junction with a line formed by, yet fifteen feet from, the southern elevation of the building; thence proceed easterly along a line formed by the southern elevation of the gym for approximately 108 feet to the intersection of said line and a line formed by a stone retaining wall (approximately eight feet from eastern elevation wall); thence proceed northerly along this line to the southern edge of Powell St.; thence proceed westerly along the road to the point of beginning.
Boundary Justification:
This boundary includes the historic gymnasium and surrounding associated property but excludes the adjacent nonhistoric tennis courts.






