

#### SUMMARY

The Alfred Ayer House is a c1885, two and a half story frame vernacular residence with some Italianate influences, located west of the community of Oklawaha, near the north shore of Lake Weir. It is regularly massed with intersecting gabled roofs. Fenestration is primarily single, wooden, 2/2 double hung sash. The house retains a high level of architectural integrity. It contributes to the Early Residences of Rural Marion County, Florida Multiple Property Listing under Associated Property Type F.1 Residential Buildings, c1870-c1940.

#### SETTING

The land surrounding the Ayer House was planted in orange grove and sparsely populated when Oklawaha was settled in the early 1880s. Buildings were limited to scattered houses and outbuildings and a few lakeside cottages. The Ayer House is north of U.S. Alternate 27/441 which once was the Old Lake Weir Road. The eight-acre, irregular parcel on which the building is sited is on a small spit of land on Bowers Lake. Until the mid-1980s, the land was planted in citrus grove. The grove was decimated by harsh freezes at that time and has since been cleared. A considerable amount of vegetation, however, exists around the house (Photo 1). There are two small, contributing sheds behind the house (Photos 2 & 3).

#### PRESENT AND ORIGINAL PHYSICAL APPEARANCE

The Alfred Ayer House is two and a half stories in height. The ground plan of the building is T-shaped, formed by intersecting front and side facing gables with raked cornice returns. The massing of the side gabled portion takes the form of an I-house. The building has a one story kitchen wing on its north side (Photo 4). A hipped end porch fronts on the east end of the south elevation, facing the Old Lake Weir Road (Photo 1).

The Ayer House is regularly massed. It has a balloon frame structural system resting on brick piers. The exterior finish is horizontal, wood weatherboard. Secondary roof types include a gable roof over the kitchen wing, flat roofs over the bays on the east and west elevations (Photo 4), shed or hipped roofs over the porches (Photos 1 & 5). Both primary and secondary roof surfaces are covered by sheet metal in a V-crimp pattern, except for the

bay window roofs which are tar and gravel. The primary roof is pierced by two massive, corbelled brick chimneys (Photo 1).

There are two porches, the most important of which is a hip roofed porch located on the main (south) elevation, facing Lake Weir (Photo 1). It is three bays wide on the south elevation and two bays deep on the east and west elevations. It covers the main entrance, which has a single doorway with a transom (Photo 5), and two side entrances to the house. A three bay wide side porch is located on the west side of the kitchen wing (Photo 4).

The fenestration of the building is regular. Original windows are singly placed, with the exception of paired windows on the front facing gable and the hexagonal bays on the east and west sides of the building (Photos 1 & 4). They are all wooden, 2/2, double hung sash.

The Alfred Ayer House is an excellent example of the Italianate style applied to a simple vernacular form. The Italianate influences in the style are expressed through its brackets, window surrounds, and gable returns (Photos 1 & 4).

The <u>interior</u> of the Alfred Ayer House reflects the T-shaped plan. The main entrance opens into a large foyer which leads directly into a dining room. To the west of the foyer is a livingroom with a fireplace, and to the east is a bedroom, also with a fireplace. These rooms form the cross bar of the T. Directly north of the dining room is a one story kitchen wing which forms the base of the T. There is also a half bath on the first floor. A stairway on the east side of the foyer leads to the second floor which has two bedrooms, each with a fireplace, a den and a bathroom. Original pine wood floors, ten foot ceilings, and plastered walls remain.

#### ALTERATIONS

The exterior of the main block of the building is largely unaltered. Aside from some windows on the east side of the kitchen wing which have been changed to jalousie type, no substantial alterations have been made to the exterior.

#### SUMMARY:

The Alfred Ayer House in the vicinity of Oklawaha, Marion County, Florida, is locally significant under Criterion A in the areas of Exploration and Settlement for its association with the early development of Oklawaha and Marion County. The house is significant under Criterion C as a large, frame vernacular house with Italianate influences which was typical of residences built by grove owners in Marion County during the last two decades of the nineteenth century. The house contributes to the Early Residences of Rural Marion County, Florida Multiple Property Listing under Associated Context: Marion County, 1847-1900 and Associated Property Type F.1, Residential Buildings, c1870-c1940.

#### STATEMENT OF SIGNIFICANCE:

The Alfred Ayer House is located in the vicinity of Oklawaha in southeast Marion County, near the northwest shore of Lake Weir. Oklawaha was first settled in 1884. Following the construction of the Florida Southern Railway through the area, it became one of the principal citrus producing communities in Marion County.

The house was constructed shortly after the settlement of Oklawaha by Alfred Ayer, one of the pioneer citrus growers of Marion County and one of the first settlers of the Lake Weir area. He arrived in Marion County in 1874 from Charleston, South Carolina, with other family members, Dr. Lewis M. Ayer and Thomas R. Ayer. All were prominently associated with the development of citrus at Lake Weir and all constructed large houses on or near the northwest shore of the lake. Alfred Ayer was also interested in truck farming and became a local authority on this activity as well as citrus culture. Active, too, in civic affairs, he served on the Marion Board of County Commissioners during the period. In 1889, Ayer sold the house to Enoch W. Agnew, owner of E. W. Agnew and Company, one of Marion County's most important mercantile and banking establishments. During the twentieth century the Ayer House has had numerous owners. Fortunately, all have chosen to maintain the essential features of the building.

The Alfred Ayer House is one of a group of private residences surrounding Lake Weir that are good surviving examples of late Victorian period architecture in rural Marion County. The Ayers House with its brackets, gable returns, classical window surrounds, and bay windows is one of the best examples of

a frame vernacular house with Italianate influences in rural Marion County. It is also one of the best examples in the county of the large houses constructed around Lake Weir and Orange Lake for grove owners during the latter two decades of the nineteenth century, when Marion County experienced a citrus boom.
