

#### NARRATIVE DESCRIPTION

The William H. Bucher House is an irregularly shaped adobe building with a front gable roof, double intersecting side gables, and a modern rear addition that continues the roof line of the second gable. The roofs are covered with corrugated metal. A raised, roofless porch bordered by a low concrete wall fronts the main entrance. The paneled front door has side and over lights and a pedimented lintel. The windows are trimmed with simple wooden casings and flat lintels. A stone wall approximately 36 inches high runs along the front of the property at the street line continuing east in front of a vacant lot to the corner and down the east side of the vacant lot. There are three other small buildings on the property, a contributing maid's house, a contributing, detached, double garage, and an uncounted shed.

By 1893 when the first Sanborn map was drawn much of the house was in place. It had a shingled roof and what appears to be an east facing porch, also shingle roofed. The front walls had to be reconstructed after they were swept away in the flood of 1914; the same year a kitchen and bath were added at the rear. The 1930 Sanborn map shows additions had been made since 1898 to complete a wide rectangle projecting on the east side of the building. A small room had also been added at the back.

Extensive remodeling by the present owner was completed in 1990. A pair of French doors at the front entrance was changed to a single paneled door and a Territorial-style pedimented lintel added. The kitchen and bath that had been added in 1914 at the back of the house were torn off and a kitchen, garden room, and portal were newly built. The interior plan was altered to create the long center hall in the Territorial mode.<sup>2</sup>

#### SIGNIFICANCE

The building is significant historically for its association with William H. Bucher, one of the leading citizens of Hillsboro. Bucher was extensively involved in mining and a major force in bringing a bank to Hillsboro.

Born in Ohio, Bucher came to Kingston in about 1885 with a cousin, John Zollars. Successful in mining enterprises, they opened the Percha Bank in Kingston. In the late 1880s, Bucher and Zollars opened the Sierra Bank in Hillsboro, of which Zollars was the president and Bucher the cashier. In 1896 Bucher bought a home on Main Street from George and Adelaida Alert Perrault who had owned it for just a few months. Previously the property had passed through a succession of four owners since 1890.

The bank prospered loaning money to area miners and ranchers and by 1899 claimed \$133,096.22 in resources and \$89,376.42 in deposits. In addition to serving as cashier of the bank, Bucher was extensively involved in mining both as an owner and lessee. Active in Republican politics, he served as the elected treasurer of Sierra County from 1889-1894. As Hillsboro declined, Bucher moved his banking interests to El Paso, Texas, which was growing. He gave up his interest in the Hillsboro bank after the turn of the century. However, he maintained his residence in Hillsboro where he left his family while traveling to El Paso for business. By 1911 when running for the state legislature, he had to defend the status of his residency in Sierra County. Finally in the early 1930s he moved permanently to El Paso.

After Bucher died in 1934 the Hillsboro house was inherited by his daughter, Ann, who never lived there. It remained locked up, just as it was, for nearly two decades into the early 1950s. Upon Ann Bucher's death the house passed to her parents' grandniece.
