NATIONAL REGISTER CRITERIA STATEMENT (if applicable)

The handsomely detailed West Somerville Branch Library retains integrity of location, design, materials, workmanship, and feeling, as well as associations with Somerville's municipal building program and extreme growth at the turn of the century. Somerville's most intact example of the Neo-classical style, the building fulfills Criteria A and C of the National Register of Historic Places on the local level.

ARCHITECTURAL SIGNIFICANCE Describe important architectural features and evaluate in terms of other buildings within the community.

This small branch library is one of Somerville's best conserved examples of the Neo-classical style. The fine entrance portico is composed of a triangular pediment carried by Ionic columns and broad pilasters. A modillioned cornice is carried around the building, and into the full raking cornice. Urns and acroteria finish the pediment. Built of smooth-cut granite, the building is 1 1/2 stories in height and three bays wide it is capped by a shallow hipped roof. Similar examples of the various expressions of the Neo-classical elsewhere in Somerville have been altered.

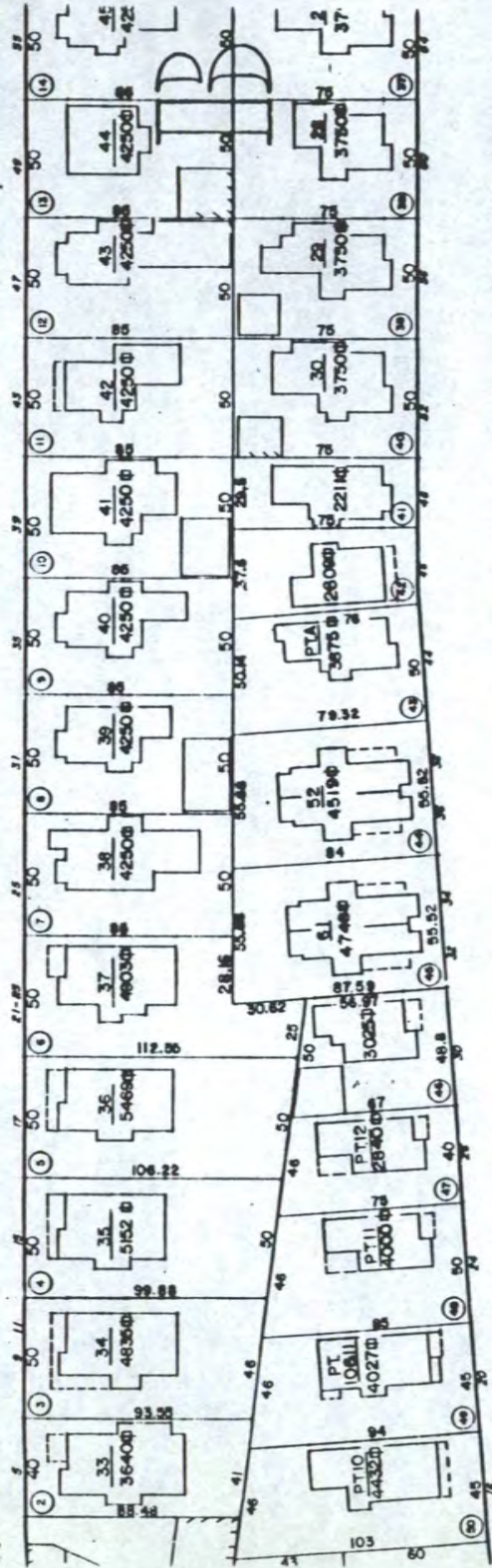
HISTORICAL SIGNIFICANCE Explain the role owners played in local or state history and how the building relates to the development of the community.

The West Somerville Branch Library was opened in 1909, during the administration of librarian Samuel Walter Foss, noted poet and author of the "House By the Side of the Road." The West Somerville branch originated in a store in Davis Square, and served the growing population near Davis Square and the Old Powderhouse. The library construction was funded through a gift of \$25,000 from the Andrew Carnegie Foundation and through city appropriations.

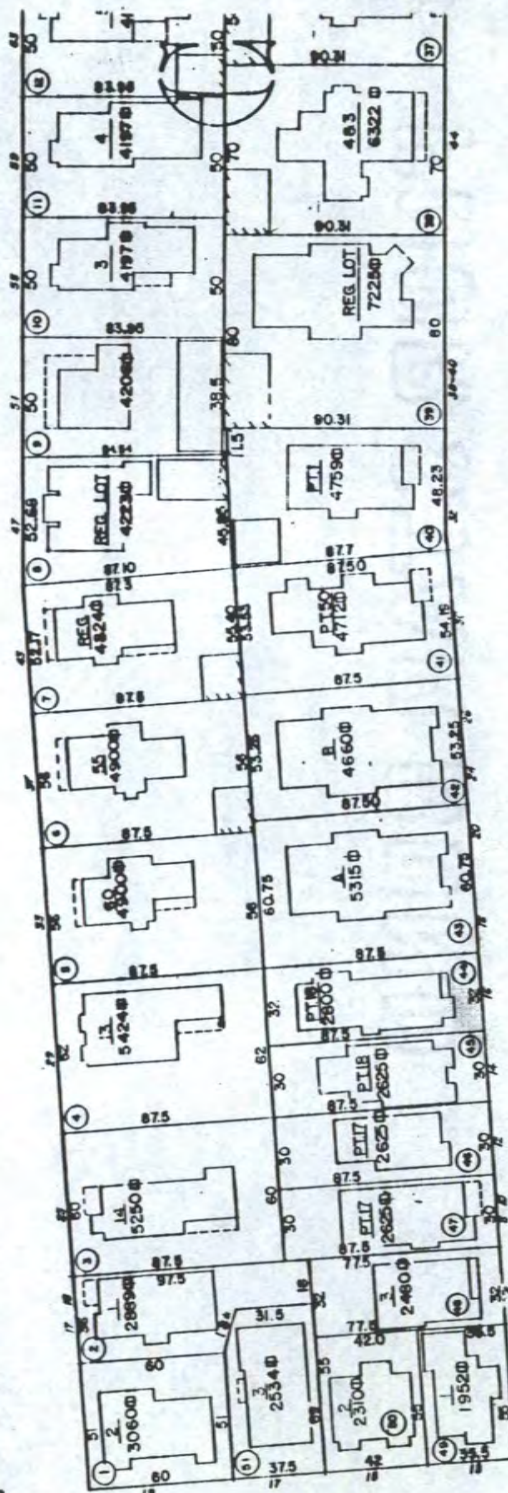

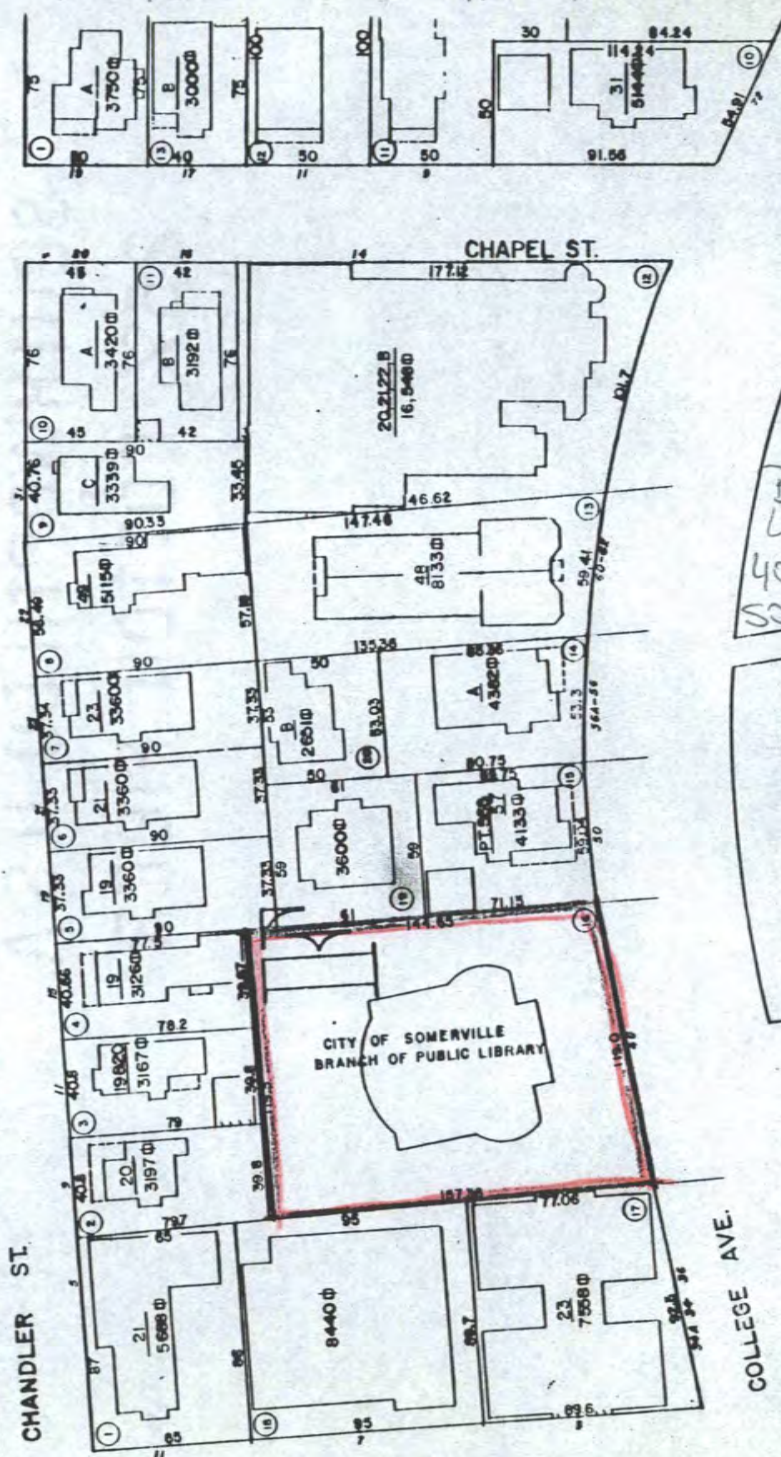
