**Describe present and historic physical appearance.**

The Friends Church is a one-story, symmetrical plan, three bay brick church built between 1871 and 1872. The church was originally built in a rectangular plan and was enlarged with transepts and a rear wing in 1963. The original section of the church is of six-course common bond construction and has a brick foundation and tile roof added in 1925. The original section displays a brick beltcourse which was copied and extended onto the added rear section. The main entrance has original double doors of raised panel frame design with an arched four light transom. Above the transom is brick hood molding. Windows are original triple hung wood frame with eight lights in each sash. The windows are arched with brick hood molding.

The transepts and rear wing repeat the window pattern, brickwork and tile roof of the original section and also display brick dentils at the roofline. The interior of the church is composed of open floor space with no partition walls in the nave or transepts. The church displays original oak floors, plaster walls and ceiling, and simple window surrounds. The pews, altar and woodwork in the transept were added in 1963. There are no decorative details. The church is located on an urban lot with an adjacent cemetery in the downtown section of Maryville.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The Friends Church is significant under criterion A for its association with the Friends or Quaker religion which was an important influence in the county in the 19th and early 20th century. The church is the only religious structure standing in the county which is associated with the religious heritage of the Friends. The church was built between 1871 and 1872 and served as the Friends meeting house until 1933. In 1946, the property was purchased by the St. Andrews Episcopal Church and later enlarged into its present form. Extensive additions to the church in 1963 render the building ineligible for the Register under criterion C, however, the church retains its integrity of association, site and location.

Members of the Friends Church moved into Blount County in the 1790s and organized their first church at Friendsville in 1808. Despite their abolitionist teachings the Friends congregation thrived in the county. In 1854, the Friendsville Institute was built at Friendsville and other schools were built throughout the county. Meetings of Friends took place in Maryville at various residences until a movement was begun after the Civil War to purchase property for a church. In 1869, J.A. Grinnell bought lot number 34 on Main Street and in 1871 deeded the lot to the Friends.

In 1871, work began on the construction of a one-story brick building as a meeting house and completion took place in mid-1872. The bricks for the church were furnished by local builder David Jones and the entire cost of the church was \$2,870. When it was completed the church reflected the Italianate style with arched windows and doors with label hood molding. The Maryville Church was a vital institution in the community for several decades. Many of its members were active in promoting local education and built the Friends Normal School. Other members were involved with local business and developed areas of Maryville. Members of the church were leading citizens of the community such as Dr. Jephtha Gardner and Dr. W.C. Stanley.

By the late 1890s, the number of members of the church began to decrease as members emigrated westward and as religious differences arose in the church doctrine itself. In 1900, the Friends Normal School was sold to the city and its sale signified the waning of the Friends' influence in the community. By 1915, all of the Friends schools in Maryville closed and in 1933 the church minutes recorded "discord and disunity" among members. In 1936, the church was officially closed and in 1946 the property was sold to St. Andrew's Episcopal Church.

The St. Andrew's Church occupied the original building until 1963 when it was enlarged with transepts and a rear addition. The design of these additions were in keeping with the original brickwork and detailing of the original building. The St. Andrew's Church continues to utilize the building for its congregation.

Because of their abolitionist teachings, the Friends denomination was not popular and did not settle in great numbers in West or Middle Tennessee. East Tennessee was more hospitable to the Friends and Blount County became a center for their religious activities in the state. The Friends were leaders in education and commerce and the Friends Church is the only major structure remaining in the county associated with this denomination's 19th century growth and development.

**Boundary Justification**

The boundary for the Friends Church includes the church and adjacent yard within its city lot. A line is drawn approximately 175' to the southeast of Broadway Avenue to form the southeast boundary of the property. This line is drawn to exclude a modern brick educational building constructed by St. Andrew's Church and is not associated with the Friends Church.

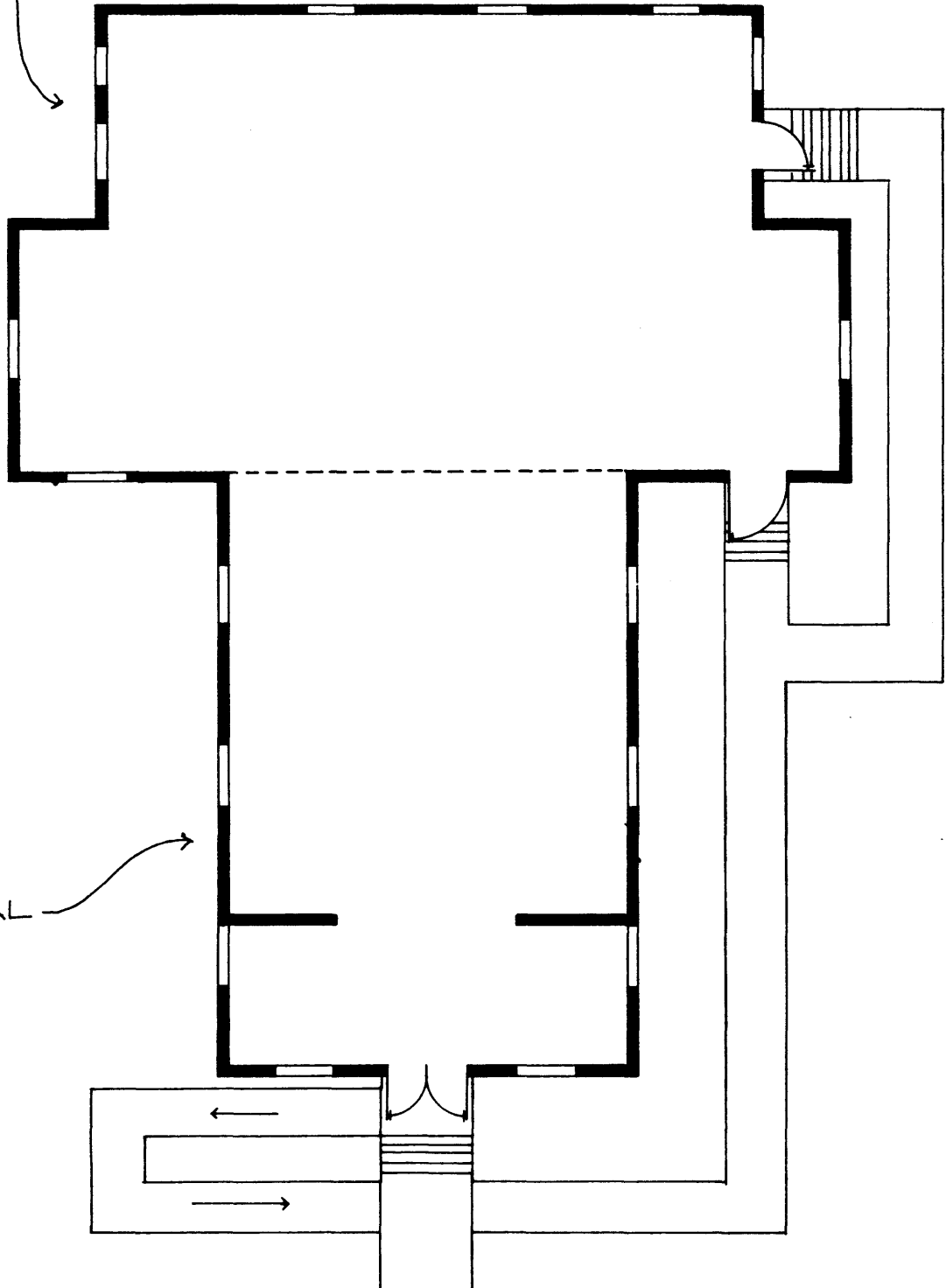

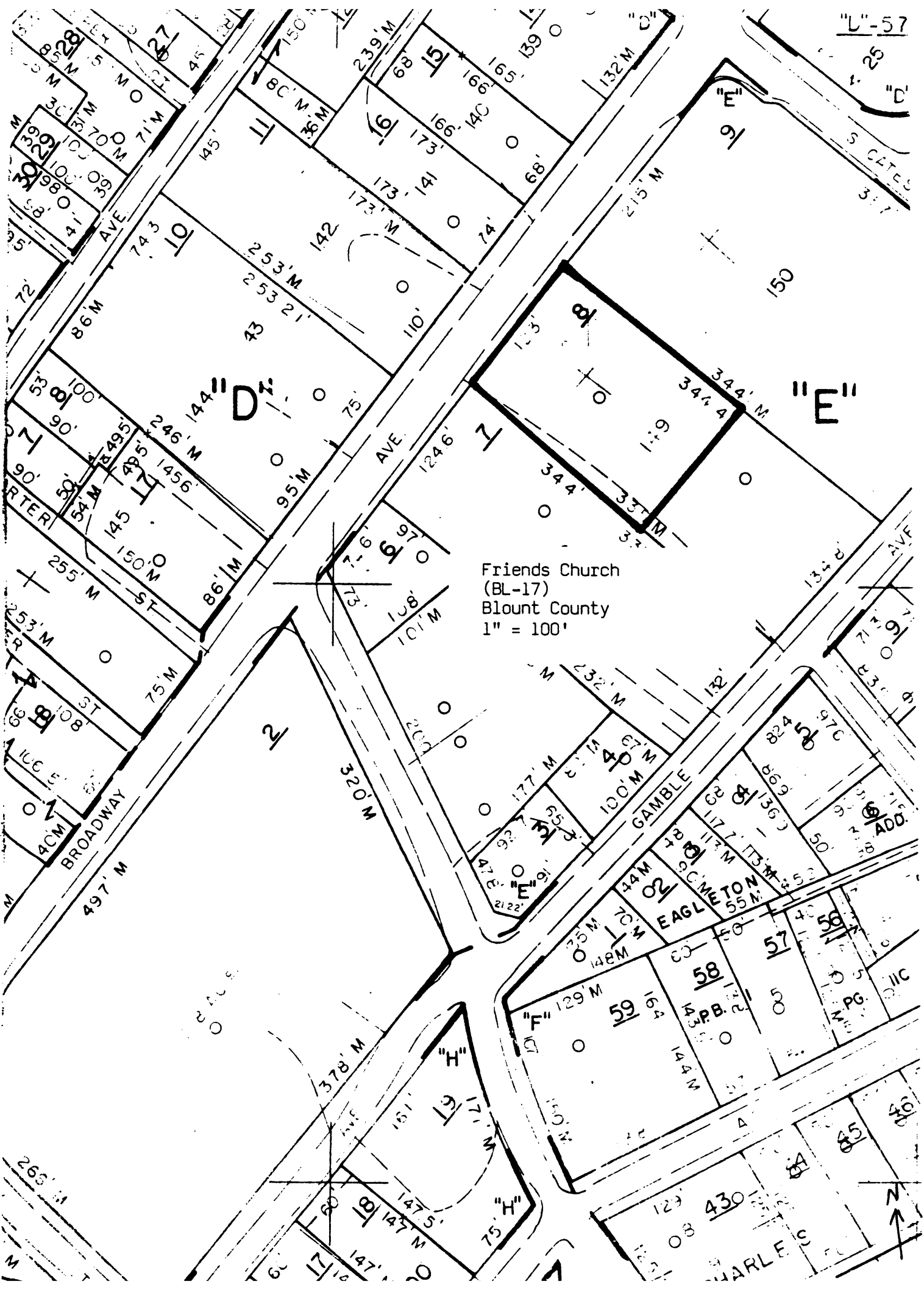
