

### DESCRIPTION

The Vashon Hardware Store is located on the southwest corner of the intersection of the Vashon Highway and 176<sup>th</sup> Street. The Vashon Highway runs nearly the length of the Island and serves as the main arterial for traffic to and from the Seattle-Vashon-Southworth ferry landing. It is situated within the commercial and business center of the community of Vashon which is concentrated along the highway and neighboring streets and is comprised of both historic and newly constructed buildings. Due to its corner location at the northern end of the business district, the Vashon Hardware Store is a prominent community landmark and particularly visible when approached from the north.

This store building is composed of two internally connected wood-frame structures with concrete foundations. Historically, the building housed two separate side-by-side commercial operations. The one-and-one-half story principal structure has a rectangular footprint measuring about 40 x 125 ft with a gable roof form. The smaller 16 x 40 ft wing is attached to the south side of this structure and has a shed roof form. Since 1973, the two structures have been internally connected. They are unified by a prominent storefront design that extends across the entire face encompassing both buildings.

The wood frame structures were initially constructed as two separate side-by-side buildings in c.1890. The original physical appearance of the buildings included a shed-roofed porch with wooden post supports that ran the length of both building facades. The main building included a gable roof with a prominent stepped, western-style false front façade that extended across to the smaller wing. Historic photographs indicate that by c.1913 business signage extended across the main façade, the building was clad with shiplap siding and painted advertisements were situated on the north side. In the mid-1930s, the covered porch was apparently removed and the original store buildings were expanded to the east. With the construction of a modern storefront and additional store and mezzanine, floor area was gained with the extension of the original gable roof form to the west.

The current storefront design dates from the 1930s remodel and exhibits Moderne stylist features with a horizontal emphasis and the use of curved elements. The one-part façade composition includes a horizontal bulkhead, a band of large display windows, a curved canopy. The façade is dominated by a curved false front which steps up in front of the gable end to give the impression of additional height to the main building. This stepped false front has rounded ends and is angled to 45-degrees at the corner of the building as a transition from to the north elevation and extends about 10 feet along that side of the building. Large wooden letters in a 1930s era typestyle are attached to the false front is a flat-roofed canopy with a wide fascia, which cantilevers out and extends the length of the east façade and wraps around the corner. Other stylist elements include rounded concrete entry steps, smooth plywood wall surfaces, and the continuous band of large plate glass display windows. In combination, these features reinforce the horizontal line that is a hallmark of the Moderne style.

The principal entrance to the store is a single glass panel storedoor located to the right of center of the façade and on axis with the main building. A similar secondary entrance is situated to the south end of the façade, indicative of the once separate wing addition portion of the structure. The doors have plain surrounds and are flanked on both sides by large plate glass display windows. A total of

eleven fixed windows extend across the façade. The windows are modern wooden sash and include mullions and muntins - dividing each window into four sections - smaller panes above larger. The present owners replaced the original windows. Because the new windows are very similar to the original window design and configuration and the mullions/muntins are painted a dark color, the fenestration has not been significantly altererd. A simple round faced clock is located just above the principal entrance door. A small sign stating "Est. by George P. McCormick Jan.1929" is located at the north end of the false front. The north elevation is clad with ship lap siding and includes a band of small square windows and a rolling delivery bay doors with a curved canopy cover and curb. The less visible west and south sides of the buildings have been recently clad with modern plywood panel type siding that was placed directly over the original ship lap siding. The replacement of the window sash and the addition of this cladding are the only notable exterior changes that have occurred since the building was remodeled in the 1930s.

The interior of the main store building has oiled wooden floors, open high ceilings, extensive wooden shelving and bin areas, and a long wooden sales counter. On the walls are various items of interest such as old photographs of Vashon, animal skins, and old tools, along with an extensive selection of traditional hardware merchandise. A mezzanine level business office is situated at the west end of the main store and the southernmost section of the building, which was formerly a separate retail space, is now used for storage purposes.

### STATEMENT OF SIGNIFICANCE

### **Summary Statement**

Located in the commercial center of the community of Vashon on Vashon Island, the Vashon Hardware Store building was the first store in the community and is the only commercial building remaining from the earliest period of this rural business district. Initially built in 1890 as a general store, the building began to be used as specialty hardware store c.1929. The building façade was modernized in the mid-1930s with the addition of a distinctive false front designed in the Moderne style. The new storefront, which incorporates distinctive horizontal features and curved elements, has been little altered since its construction. The Vashon Hardware Store building has been in operation almost continuously - 110 years of service to Vashon residents – and is significant in the context of the commercial history of Vashon Island and rural King County architecture.

### Vashon Island Historic Context

Most of Vashon Island is known to have been the aboriginal territory of predecessor bands of the Puyallup Tribe, who established winter villages along the shores of Quartermaster Harbor, toward the southern end of the Island. Ancestors of the Suquamish and Muckleshoot Tribes may have also inhabited northern and eastern portions of the Islands.

Euro-American settlement of Vashon Island began during the 1850s, primarily along the shores of Quartermaster Harbor, with logging and farming being the earliest vocations. Island pioneers purchasing land through the Donation Land Act established individual timber and homestead claims. Logging and milling companies including the Puget Mill Company purchased large tracts of timberland.

During the latter part of the 19th century, numerous communities were established along the Island's shoreline, serving a growing population with limited commercial establishments, and providing important maritime transportation connections to commercial markets in the growing cities of Tacoma and Seattle. Settlement of the inland areas of the Island occurred more slowly, due to the limited and rugged roads that connected the uplands with well-established steamboat landings dotting the shoreline.

Early industrial activities included shipbuilding and brick-making operations which were typically located on waterfront sites, with easy access to maritime transportation, and took advantage of abundant natural resources; fir and cedar trees, clay, sand and gravel. Brick making became the second most prosperous industry on Vashon after logging, acquiring materials from the blue-clay bank beaches of the Island. Quartermaster Harbor served as the location of several brickyards, the largest one being the Bleeker yard on the Burton peninsula. By 1893, at least eight brickyards were in operation around Quartermaster Harbor, with additional yards located along the eastern shore of the Island. Major shipbuilding operations were developed at Dockton, at the outlet of Quartermaster Harbor on Maury Island, with secondary activities at smaller waterfront communities on Vashon and

Maury Islands. However, logging continued to dominate the local economy, as thousands of acres of timber were harvested, and milled at both local and off-island mills.

Settlement patterns and the early industrial history of Vashon are clearly reflected in the development of the Island's built environment. The construction of late 19<sup>th</sup> century vernacular buildings reflects the rough living conditions with log cabins with shake roofs being prevalent. As lumber mills became more widespread, wood-frame construction with board and batten cladding became most common. By the late 1880s, when planed lumber became generally available, builders were able to construct more elaborate Victorian residences.

### **Commercial / General Store Historic Context**

Although Vashon Island was surveyed into sections in 1857, few settlers filed homestead claims until the 1880's when the population of the Island increased dramatically. Because the Island relied primarily on water transportation, most claims were located with easy access to the shoreline. As early as 1885, steamers were plying Puget Sound bringing supplies to Vashon settlers and, in turn, transporting their produce and eggs to Seattle and Tacoma markets. Before establishing regular routes, many of the boats were simply flagged down from the shore by Islanders wanting passage. One enterprising captain outfitted his boat with merchandise and brought his "floating department store" directly to Vashon customers.

As the steamer routes became better established, small retail stores were set up at or near various boat landings, including Cove, Lisabuela, Luana Beach, Colvos, Chautauqua, Vashon Landing and Portage. Because there were few roads on the Island, there was limited travel between communities and, in fact, this isolation bolstered self-sufficiency in these small settlements. Residents in each community came to depend on their corner grocery for daily supplies and the steamers for transportation to the mainland for other goods. The advent of ferry service in 1916 brought automobile transportation, which provided the stimulus for constructing better roads, which in turn increased contact between the communities. Some of the early stores suffered while others grew larger or introduced new services such as automotive repair and gas pumps. By the 1920s, Vashon Island had several paved roads the main business center was within the inland community of Vashon.

Of the myriad of early stores on Vashon Island, only a few continue to be used for their original purposes with minimal alterations. These include the Vashon Hardware Store and Harbor Mercantile (now Burton Trading Co.) in Burton. While some other historic general or specialty store buildings have survived, they have been converted to new uses and/or in most cases altered.

### Vashon Hardware Store History

In 1890, Frank W. Gorsuch purchased this site from a Mr. Boerstler and built the initial general store building that gradually evolved into the Vashon Hardware Store. When he opened the store in 1891, he received supplies and merchandise overland from Vashon Landing, situated approximately one mile to the east. The store was the first commercial enterprise to be built in the community of

Vashon and the fourth to be built on the Island during that year. Although the community of Center was larger than Vashon at that time, business was nonetheless steady.

In 1913, Gorsuch sold the business to two brothers, Fred and Henry Weiss. An historic photograph from this era shows the two portions of the original stepped false front and the covered porch that extended across the entire façade. The shiplap clad building also exhibited a facade sign reading "Weiss Bros., General Merchandise" and a painted wall advertisement for Fisher Flour on the north elevation. In 1917, the Weiss brothers sold the business to Robert Gerry who is known to have sold groceries, hardware, flour, feed, school shoes, wet weather goods, blankets, dry goods, notions and paint.

In 1921, Fred Weiss repurchased the business and took in a new partner, Ole Thorson. A green painted sign "Weiss and Thorson" was erected across the front of the building and the two men ran the store until about 1928 or 1929. Fred Weiss then moved his business across the street into a brick building on the northeast corner of the intersection. "Beall and Hanson", two wealthy Island residents who owned several commercial properties for investment purposes, had owned the general store building since the 1900s. After Weiss and Thorson moved across the street, the general store building remained vacant for a short period until C. G. Kimmel and George McCormick rented it in 1929.

C. G. Kimmel had been operating a nearby general store that offered a variety of merchandise, primarily groceries but also housewares, gardening supplies, and hardware. By 1929, the Mosquito Fleet ships were making frequent stops at Vashon Landing and bringing increased business traffic to the community of Vashon. Vashon had grown to be much larger than Center, and Kimmel's young clerk, George McCormick, saw an opportunity for expansion. He convinced his boss to go into partnership with him and to expand into the then vacant general store building. Because McCormick was particularly interested in the hardware portion of the business, all of the gardening and hardware supplies were relocated into this building leaving the groceries and general merchandise in the original Kimmel store. Eventually, McCormick bought out Kimmel's interest in the hardware portion of the enterprise, the business became known as the Vashon Hardware Store. Kimmel eventually outgrew his remaining premises and expanded to create the first supermarket on Vashon Island.

Around c.1935, the building owners, Beall-Hanson Company, hired A. C. Harrington to build additions to the west and east ends of the building and to add a distinctive Moderne style storefront. The building has been little altered in appearance since then and continues to stock the traditional specialty merchandise: garden tools, general hardware, some housewares, seeds and fertilizer. Until 1973, the smaller storefront within the south wing of the building housed various separate retail shops including a barbershop and a saw sharpening business. The hardware business and the entire building have remained the ownership of members of the McCormick family. George McCormick's daughters, Mary Jo Ballentine and Bonnie Shride and their husbands operated the enterprise after 1973. George McCormick's grandson, Gary Barrentine, currently owns and operates the hardware store. In addition to selling traditional hardware merchandise, the store displays historic photographs and houses a tool museum. In August 1986, it was designated a King County Landmark by the King County Landmarks and heritage Commission for its architectural and historic significance.






