#### **ARCHITECTURAL DESCRIPTION:**

The Krietz Residence is rectangular in plan, one and one half stories high, and two bays wide across its front facade. It is sheathed with shiplap siding and has a steeply pitched gable roof with boxed eaves. An interior brick chimney with a corbelled cap protrudes from the gable peak. One over one double hung sash windows with decorative surrounds are used throughout the building. The original front porch has been removed and replaced with a small enclosed stoop. Several additions have been made to the rear of the building. The main portion of the house measures 27' X 46'.

### HISTORICAL DESCRIPTION:

The exact date and original owner of this residence are not known. The County Assessor's records estimate its date of construction as 1901; however, because of its architectural style and detailing, it is assumed that it was built in the early 1890's soon after Lippincott's First Addition was platted (1889).

The house is associated with the Krietz Family. Upon the death of Catherine Krietz in August 1911, title to the house passed to Martin Krietz who is listed as a "laborer at odd jobs" in the 1910 census. In 1927, the property transferred again to Ralph Krietz, Martin's son. Ralph owned the adjacent property at the corner of 7th and Church where it is assumed he resided. Ralph is listed in the 1910 census as being a "league baseball" player. Beginning with the 1903-4 Gazeteer, for a number of years, Matthew W. Krietz is listed as a veterinarian surgeon; it is presumed Matthew was Catherine's husband and an early owner and resident of the house.

## SIGNIFICANCE:

The Krietz house is an example of the hybridization of several styles of architecture, resulting in its unique appearance. Criterion c.
