Summary Paragraph

The North Bass School is located on North Bass Island, Ottawa County in Lake Erie. North Bass Island is the northernmost Ohio island, situated less than 2 miles south of the United States/Canada border, north of South Bass which includes the village of Put-in-Bay, Middle Bass Island and Kelleys Island, roughly 60 miles northwest of Cleveland and 18 miles north of Port Clinton, the Ottawa County seat. The North Bass School is a purpose-built, one-room school with a teacher's residence. Built in 1952 of concrete block with red brick facing veneer, it was Ohio's longest and last operating one-room schoolhouse. The school was specifically constructed as a "fireproof" school (photo 14). The school was constructed within a vineyard and designed as a mid-century, minimal traditional brick ranch plan with Colonial Revival elements. The classroom having a northern wall of 14 windows including seven (7) operable awning windows to capture indirect northerly light and to also provide ventilation. The building is intact as built and remains operational with only cosmetic updates. The nomination includes the school building and surrounding playground site. There are no non-contributing resources included in the nomination. A concrete sidewalk traverses from the road to the front of the school building, crossing south east and south along the building and connecting to a concrete pad with picnic tables off the rear (west) of the building, also used for the children's play area in wet times and soft soil. On the property toward the northern boundary are three (3) propane storage tanks which are used for heating the school and providing hot water. The North Bass School retains historic integrity of location, setting, design, workmanship, feeling, and association.

Narrative Description

Built in 1952 the North Bass School is a rectangular building with small rear extension and gable roof. The building has a concrete block foundation and structure with red brick facing laid in

stretcher running bond. The mid-century, minimal traditional brick ranch influence is evident given the building's overall, twin intersecting open gable design and form. The gable roof pitch is accomplished with rafters attached to the brick faced concrete block walls. The façade includes a front gable projection featuring a Colonial Revival detail of a blind brick ornamental arch infilled with header brick bond (photo 7) with stone accents at the keystone and central points of each vertical side and the full lower, horizontal sill (photos 1, 2, 3). To the south of this projection the façade features a recessed porch with square wood columns. The main school entrance is the only opening on the front elevation and it is a single door with upper light and plain surround with sidelights.

The entrance opens immediately to a hallway with drinking fountain and to the right are coat hooks and location for student boots and materials. The entry hallway turns right to the classroom and left to the restrooms, teacher's residence and a boiler/utility room.

The interior space includes 1392 sq. ft. with the 22' X 34' classroom being the northern portion of the building. The classroom is accessed through the front door and to the right (photos 8, 9, 10, 11, 15, 16). Within a 5' X 8' front hallway is a drinking fountain and area with coat hooks. The classroom is also accessible through the rear door of the building (photo 5) which leads to the playground to the west of the building. By entering the rear door, the galley kitchen is immediately to the right (photo 13) and the classroom/teacher storage are accessible to the left (photo 12). Entering straight through the rear (western facing) door provides access to the classroom.

The classroom's northern wall includes fourteen (14) windows in a seven (7) wide and two (2) high format. The upper windows are fixed while the lower windows are operable awnings for ventilation thus moving rain away from the opening and providing lower opening ventilation (photo 6). The classroom windows have a total surface of 148 sq. ft. The northern classroom wall also includes the building's original book storage and shelf space below the windows (photos 15 and 16).

The classroom's east (photo 8) and south walls (photo 10) include chalk and bulletin boards. The western wall is an alcove that is used primarily for classroom bookshelves and location of the teacher's desk area (photo 9).

The western (rear) classroom door includes an area for storage of school supplies (photo 12) and an entryway to the 8' X 7' galley kitchen which also leads to the teacher's living quarters (photo 13). The kitchen includes the original cabinets, sink, counters, and stove. The south, east and north walls of the kitchen are glazed tile identical to the bathrooms and lower classroom walls while the east wall is cabinets and counters. A single-hung window faces west providing the teacher an opportunity to see the playground while providing light and ventilation to the kitchen.

Upon entering the school from the front door, to the left is a boys' bathroom and access hallway to the boiler room with its fireproof door (photo 14). Adjacent to the boys' bathroom to the west

County and State is a girls' bathroom with an attached shower that is also accessible to the teacher's shower which is accessed via the teacher's bedroom residence. Each bathroom has a single-hung window.

The 10' X 15' teacher's bedroom/living room occupies the southwest portion of the building. The room includes two (2) single-hung windows with one facing south and one facing west (photos 4 and 5).

The structural system of the school is concrete block with red brick exterior and a combination of interior surfaces including glazed tile (classroom, restrooms, kitchen), exposed brick (boiler room), and sheet-rock which is painted or covered with paneling (classroom, teacher's apartment). The roof shape is an intersecting gable with the classroom gable peaking east to west and the restroom/teacher's apartment area peaking north to south (photos 1-6). Original vinyl tile remains in the kitchen, bathrooms, and hallways. The original carpet in the teacher's bedroom was replaced with similar carpet and the original vinyl tile was replaced in the classroom due to age and wear.

The front porch has a 6' X 23' concrete stoop that covers and protects the front entry (photos 1, 2, 3). The covered porch faces east and provides a view of Pelee Island, Ontario, Canada, which is directly east of the property and is the only other land mass that can be seen from the school.

The building includes a 14' X 15' fuel oil storage room on northwestern portion of the building (photos 5 and 6). The fuel oil tanks were removed in 1970 through the western wall. Original bricks were restored to repair the opening created for the removal. Currently, the room is used for storage and remains only accessible from the outside. A square, single-hung window provides light and ventilation to the storage room on the northern wall. Propane replaced fuel oil as the heating source and three (3) tanks are visible on the northern portion of the property (Figures 4 and 5).

Alterations to the original property have no structural changes but include 1986 replacement of the wood windows and doors with aluminum products of the same dimensions and locations. The roof was re-shingled with asphalt shingles in 2004. The fuel oil boiler was replaced with propane heater in 1970 and the fuel oil tank was removed and three (3) propane tanks now occupy the northern portion of the property. In 1955, the male teacher was replaced by a female teacher and the "boys" and "girls" bathroom signs were reversed.

The school grounds also include the original playground equipment sans a "monkey" bar (photos 4 and 5). The original playground equipment included a concrete play and outdoor eating/patio area, swings, and a merry-go-round. The original 1870 island schoolhouse bell is a historic element in the front lawn (photo 1).

The setting of the building is centrally located (location map 4) on North Bass Island which is also known by its 1874 United States Postal Code designation as Isle St. George (Code of Federal Regulations, 1982). The island is the northern most of the archipelago of the Lake Erie Bass Islands (location map 1, 2). The 677-acre island is two miles from the Canadian border

and is the northern-most land mass in Ohio. (North Bass Island State Park, 2019). The building is offset approximately 80' from the center of Kenny Road. The building grounds are completely surrounded by North Bass Island State Park property and vineyard. The western portion of the school grounds include part of the operating vineyard (location maps 3 and 4).

Historic Integrity Assessment

The North Bass School retains integrity through its location, design, setting, material, workmanship, feeling, and association. The building's location and setting on a remote Lake Erie Bass Island archipelago on the grounds of a vineyard dating to the 1850s remain an important part of its history and original function as a purpose-built one room school house with a teacher's residence.

The building's exterior remains intact, including original plan and brick building materials that clearly express its distinct style as a school and residence. Modifications have been cosmetic and are sympathetic to the original purpose of the updates such as modernizing doors and windows with replacements of the same size and operating in the same function for lighting, ventilation, and egress.

On the interior, the building retains its historic floorplan with classroom, galley kitchen, restrooms, and the teacher's apartment. Original glazed wall tile remains visible throughout the school and where original vinyl tile flooring was worn in the classroom, it was replaced with another vinyl tile product of neutral color. The large classroom with its wall of windows providing light and ventilation to the classroom, along with its original chalk and bulletin boards and exposed ceramic tile wall covering provide as originally designed and purposed.

The materials on both the interior and exterior illustrate the integrity of the mid-20th century workmanship that the building exhibits especially considering that the materials and labor were all brought to the island by barge as no ferry boats operate to the island or were able to dock and unload during the period of construction.

The North Bass School retains its feeling and association with the island residents as a one-room school with a residence for the teacher, and the building exemplifies an operable picture of a school designed for a small, remote, island as its specific purpose.

The 1952 building is a distinguishable structure that retains its historic setting and characterdefining features as a one-room school with a teacher's residence that remains operable and wellmaintained. As Ohio's last operating one room schoolhouse, it maintains its integrity of location, design, setting, materials, workmanship, feeling, and association.



County and State **Statement of Significance Summary Paragraph** (Provide a summary paragraph that includes level of significance, applicable criteria, justification for the period of significance, and any applicable criteria considerations.)

The North Bass School is eligible for the National Register of Historic Places under Criterion A at the local and state level for its association with the educational and socio-cultural history of education in Isle St. George, North Bass Island, Ottawa County, Ohio, particularly for demonstrating the role of a one-room schoolhouse and education on the Lake Erie islands. Further, North Bass School is eligible under Criterion C for its architectural significance as a mid-century, minimal traditional, purpose-built one-room school with a residence for the teacher.

The period of significance for the North Bass School spans from the time the structure was built in 1952 to the fifty-year cut-off of 1970. The school was in continuous operation for North Bass Island during that time and until 2005 when the last students on the island moved to high school at Put-in-Bay, Ohio. North Bass Local School District was the last school district to operate a one-room school in Ohio.

Narrative Statement of Significance (Provide at least **one** paragraph for each area of significance.)

The nominated property has a history since 1952 as Ohio's only purpose built one-room school with a teacher residence. The significance that education provides to a community is paramount to the history of a city, town, and particularly to a remote island inaccessible via car or ferry boat. Particularly considering the nominated property was the only building with a generator or any source of electricity on the island until 1957.¹

History of North Bass Island

North Bass Island's prominence and the significance as a historical property is evidenced in the 1814 Treaty of Ghent where it was chosen as the northern-most land in Ohio ratified as part of the United States to end the War of 1812 where the epic Battle of Lake Erie was fought on the waters west of the Bass Islands. Visible from the school's front porch is Pelee Island, Canada, the southern-most part of Canada as designated in the 1814 treaty. From the school's other (rear) entry is an operating vineyard originally planted in the 1850s.²

Distinctive of the significance of the school grounds is its location on a Lake Erie island two miles from the Canadian border and 18 miles to the mainland of either the United States or Canada. The island was bisected by the international boundary of the United States and Canada

County and State until the Treaty of Ghent shifted the boundary north of island.³ The school grounds sat in the Canadian portion prior to the Treaty's ratification.

North Bass Island was first settled in 1849 and vineyards were planted in just two years after the Ohio Constitution of 1851 included a provision mandating the legislature to provide a "thorough and efficient system of common schools throughout the state." ⁴ The island established a school district in 1855, holding school in at least two locations until building a frame schoolhouse in 1870 which was replaced by the current 1952 structure.⁵ The isolated nature of teaching on the island presented challenges for attracting and retaining teachers. During the history of the island's school district, from 1855 until 1955, the island had 40 teachers with the average stay being about two years.⁶

A post office was established on the island and the island has also been known as Isle St. George since 1874.⁷ The island has had as many as 50 residents including 22 students when the school was constructed in 1952. All of the residents were associated with the vineyard operations. The island has no stores or commerce outside of the vineyard operation.⁸

Adding to the distinctive history of the island and its school is the designation of the entire North Bass Island and therefore the school building and grounds as an American Viticultural Area for the purpose of labeling wine to a specific grape-growing region.⁹

Educational History of North Bass Island and Lake Erie Islands

The number of one-room schoolhouses in existence in the United States in 1914 was 212, 000 with Ohio having nearly 10,000.¹⁰ By 1986, Ohio's only operational, public one-room school was the property in nomination.¹¹ The Lake Erie Island schools provide for Ohio's smallest enrollment school districts and no other school district is so isolated as to have no road or ferry access. The island first had a paved airstrip in 1996.

The island's primary foundation as a vineyard changed dramatically in 2004 when the State of Ohio purchased 593 of the islands 677 acres and opened North Bass Island State Park in 2005.¹². North Bass Island State Park completely surrounds the school. Previously the land was owned

by the Meier's Winery.¹³ Reflecting the history of the property, a portion of the operating vineyard is located on the school grounds on the northwestern corner of the school property (location map 4, 5; photo 7). The western half of the school property was part of the vineyard until the state purchase of the property in 2002 (location map 4, 5; photo 7). The Ohio Department of Natural Resources removed the majority of the school ground's vineyard sans the section of approximately eight partial rows that remain active.¹⁴

The socio-cultural history of the island community is one deeply connected to its tradition as a grape-growing location. The island's residents all have connection to the vineyard operation.

Without a school to support the children of the vineyard's workers, the community could not have satisfied the educational responsibilities of a community or the lives of the workers and families who developed and maintained the vineyard industry.

The original North Bass Island School (circa 1870) had fallen onto disrepair and required a completely new facility as the original facility had been regarded as "condemned" and the Ohio Department of Education had undertaken a joint effort with the North Bass Island Board of Education to build a new, purpose-built facility for students in grades K-8.¹⁵ A local levy to raise the funds for construction would be necessary but beyond the scope of the island residents. The Ohio Department of Education agreed to provide partial funding for the new school but encouraged the local district to ask voters for the largest amount possible, an 8% bond issue on the November 1949 ballot. The state education agency further suggested the local district plan to build a temporary type of metal building. On September 28, 1949 the North Bass School Board passed a resolution to place a bond issue on the ballot. In a special June 1950 election, the islanders approved a 7mill bond issue for \$9,800 to build a new fireproof school building with all necessary equipment. The school building addressed the need to make island life for a teacher more attractive by building a modern school facility with an adjoining apartment for the teacher.¹⁶

Construction of the school required all materials and labor arrive on the island by barges as there was no ferry service to the island at that time. Slow-moving, tug-powered barges moved the materials including stone, concrete, wood, electrical, boilers, toilets, sinks, bricks, chalkboards, flooring, kitchen cabinets and the furnishings, paint, books, playground equipment, and pencils necessary to build and supply the school. Workers were moved to the site for weeks at a time to build the school where they camped on the island.¹⁷

Transportation of workers was difficult and also noted is that students have never had transportation within the school district. There has never been a yellow school bus in the school

County and State district and when leaving the school district for high school, students were flown by small aircraft or, when possible by weather, private boats or snowmobiles. The Tin Goose, a 1930s Ford Trimotor flying for Island Airlines was the only means of air transit from the North Bass Airport.¹⁸

The education available to students of a one-room school requires multi-age lessons and collaboration to effectively instruct students.¹⁹ North Bass School students' education was guaranteed by the Ohio Constitution and repeatedly recognized throughout its history including a state-cooperative building agreement and exception to not operate a high school.²⁰ Isolation and lack of access to the other educational opportunities is evidenced by no ferry service and the island's publicly owned runway first being paved in 1996.²¹ The school has always operated in a kindergarten to eighth grade configuration with a single teacher. Since the construction of the 1952 school all of the teachers have stayed regularly in the teacherage apartment. Prior to the island having a paved runway the teachers would fly to the island and stay Monday through Friday. Since the runway has been paved, teachers would stay overnight at the school less regularly.

North Bass School once enrolled 22 students with more than half being migrant students of the families of workers on the island.²² In 2018, North Bass Island school graduated a high school senior who completed his education at EHOVE Career Center in Milan and Put-in-Bay School. Of the eight current residents on North Bass island, six completed their elementary education in the North Bass School building and the other two served the board of education.

Teacherage School Building Type and the Architecture of North Bass School

North Bass School is architecturally significant as a mid-century, minimal traditional, purposebuilt one-room school with a residence for the teacher. Known as a "teacherage", the design of the building as both a school and residence are distinctive and reflected by the building's residential appearance.²³ The property was Ohio's last operating one-room school house and the only schoolhouse in Ohio known to be built with a teacher's residence.

The first documented teacherage in the United States was built in Nebraska in 1894. The idea of providing a residence for the teacher, either incorporated into the design of the school building or as a stand-alone cottage was widely promoted as a progressive-era initiative during the first two decades of the twentieth century. Seen as a solution to addressing concerns over retaining quality teachers and maintaining high educational standards in rural or otherwise, remote school districts, the teacherage was endorsed in publications by the U. S. Bureau of Education, Bureau

County and State of Publications from the Teachers College at Columbia University, the *Ladies Home Journal*, and advocated by the Federation of Women's Clubs. The Bureau of Education documented 3,000 teacherages constructed in 36 states between 1915-1923, predominately southern, western, and far northwestern states.²⁴

During the 1920s the Radford Architectural Company published three designs for teacherages in their plan books. These examples ranged from stand-alone cottages or double houses to school buildings designed with a suite of rooms for the teacher. One known Ohio example of a stand-alone residence for a teacher was in Greenfield, Ohio. The early twentieth century Georgian Revival style cottage was part of a larger school complex designed by nationally recognized school architect William B. Ittner of St. Louis Missouri. The residence has been demolished. The National Lumber Manufacturers' Association published for the Bureau of Education guidance for building rural teacherages addressing setting, size, materials, expense, and interior plans. Mid-twentieth century examples were published in *Planning Rural Community Schools*, Bureau of Publications, Teachers College, Columbia University in 1949.²⁵ The models in the publication more closely resemble North Bass Island school as small school buildings with a living space and kitchen incorporated into the school plan. The publication explained the examples provided general concepts that could be adapted to the specific needs and circumstances of the rural school district.

The North Bass Island School reflects the postwar needs of educational facilities addressed in the *Planning Rural Community Schools* publication, especially the needs facing rural school districts. As was the case across Ohio and the country following World War II and the subsequent baby boom of the 1950s-1960s, the demand for providing adequate schools was high. The publication cited the United States Office of Education's estimate that nationwide 7 billion dollars were required to meet the need for new and remodeled school buildings within the decade of 1950-1960.²⁶ Additionally, the publication estimated that one-half of all school children lived in rural or smaller communities.

The 1949 publication's plans for one-room schools with living quarters for a teacher highlighted the importance of designing a practical and functional building that would not only provide modern educational classrooms, but also serve multi-purposes as a community gathering spot and residence. The North Bass Island School reflects these needs associated with rural schools through its versatile, functional plan and overall design. On the interior, the building retains its historic floorplan with classroom, galley kitchen, restrooms and the teacher's apartment. The separate living quarters for the teacher addresses one of the most important challenges facing a rural, and in this case, particularly remote location, providing a good place to live in order to keep a good teacher. Providing living space relived the uncertainty of finding adequate housing or difficult commute to and from the island. The kitchen plan was versatile to allow for

refreshments for the public use of the school building and the North Bass School was used as a meeting space, Sunday School, and church space at times over its history.²⁷ The large classroom with built-in shelving and large expanse of windows were similar to the practical designs illustrated in *Planning Rural Community Schools*. The classroom's purposeful 148 sq. ft. of awning windows provide an integrated modern design form of lighting and ventilation.

North Bass School's design in the minimal traditional style is evidenced in the intersecting gable roof, simple and purposeful built-in cabinetry, mixed wall cladding, brick veneer, small covered porch, and single-hung windows in the kitchen, bedroom, and bathrooms. Form followed function as the school required a teacher residence with materials needing to be "fireproof" and having to be transported by barge with consideration that operation, upkeep and utility would be considered for the remote location. The design of the school as a "fireproof" school is an important feature as the island has no fire department or equipment. The consideration of the architect (Shively) and the builder (Ohio State Construction Company) included the encompassing of a fuel oil heat source and generators as there was no electricity on the island until 1957 - five years after the school's construction.

The shared restroom for the teacher and students was subject to design debate by the architect (C. H. Shively) and the Ohio Department of Education where the access to the shower of the teacher's bedroom was added because "we do not feel it is practical for the bather to step into the living room to dry himself" (Figure 4). At the time of design, the teacher was a male and the design would allow for the boys' and girls' restrooms to be changed by reversing the "signs" on the doors.

A comparative analysis of other Ohio island schools demonstrates the distinct aspects of North Bass School. There are operating K-12 schools on Kelleys Island and South Bass Island (Put-in-Bay) which serve year-round populations of approximately 100 and 500 respectively and support active tourism. These schools were both constructed in the early 20th century. Both of these schools have multiple teachers with Put-in-Bay School and Kelleys Island School serving approximately 70 and 10 students respectively. Middle Bass School is a late 19th century, one-room school that closed in 1986.²⁸ North Bass School is the only school which was built with a residence and the last operating, public one-room school in Ohio.

The Estes School on Kelleys Island is listed in National Register as a contributing resource in the Kelleys Island Historic District (NR Ref. No. 88002734). Two earlier mid-19th century school buildings (now converted to residences) are included in the Kelleys Island Historic District. The Put-in-Bay School is recorded in the Ohio Historic Inventory (OTT0045205). A wood frame Gothic Revival style c. 1870 one-room school building on Middle Bass Island is recorded in the Ohio Historic Inventory (OTT0038605). C. H. Shively whose experience in school designs is

County and State evidenced elsewhere in northwestern and north-central Ohio including Port Clinton and Sandusky.²⁹ One other school designed by Shively is listed in the National Register, the 1957 Marion Catholic High School (NR Ref. No. SG100001587).

The cooperation of the Ohio State Department of Education and the North Bass Island Local School board are reflected in the school's design and interaction by state-level officials in the construction of a school building and the needs of a remote, island school district. The original correspondence and approval by the Ohio Department of Education was for a "temporary type of metal building" (Figure 1). The eventually agreed-upon design included consideration for detail and elements as small as doors to the teacher's shower and the galley kitchen (Figure 4). When the contract was finally agreed upon and let, the school would be brick and include a teacher's apartment.³⁰ The mid-century, minimal traditional design reflects more than a one-room school; it is actually an operable one-room schoolhouse and meeting space where the school was also a home to the resident teacher. The aesthetic of a school and home are carefully integrated and evident in the style as a post-World War II traditional design style.

The success of the design and foresight of a teacherage in the property is the fact that since the school's construction teachers averaged seven years of service in the building while those who served the island during the period of the original building (1870-1951) averaged just two years of service and after the school's opening, it became known as "Ohio's most modern one room school."³¹

The North Bass School qualifies for the National Register of Historic Places as a significant representation of mid-20th century educational practices and needs associated with Ohio's distinctive remote, island school districts and reflects design and plan characteristics of a modern, one-room school and teacher residence. The school building and teacherage provides a broader understanding of mid-20th century school designs in Ohio.





My dear Mrs. Wires:

As a result of my visit to your school district on September 22, 1949, I desire to make the following comments in writing:

It was understood that your board of education would pass a resolution sometime between the 26th and 29th of this month approving a bond issue to be voted on this November in order to provide the district's share toward the construction of a new school building. You will remember that when there we discussed the problem of whether you should vote the maximum 6% or go to the 8%. Mr. Dehn felt that the 6% was high enough since the 8% would entail a rather large tax levy each year during the life of the bond issue. On returning to Columbus I talked the matter over M th Mr. Rohe again and it was our opinion that the State Controlling Board would be much more favorably inclined to approve state assistance on a new building if the maximum percentage was voted. We, of course, here have no authority to tell you definitely what you shall vote but the problem of getting it through the Controlling Board should be kept definitely in mind since they have already ruled against new construction help in other districts outside of the island districts.

It was further agreed that the type of building which we would approve and be willing to take to the Controlling Board when costs are on hand is a temporary type of metal building which would provide for inside toilets and some type of automatic heat control if at all possible. It was understood that you would employ an architect to draw up plans and specifications and that these plans and specifications should be made available to this office in tentative form before finally being used to secure contract bids.

I trust that the above will clarify matters and make it possible for you to move in accordance with law and the above suggestions.






