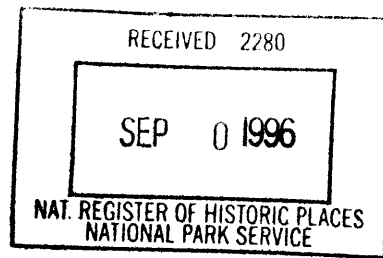

Northeast boundary stone #9 was the sixteenth marker to be located in Maryland. It was laid in 1792. Its fence was dedicated by the Captain Molly Pitcher Chapter of the Daughters of the American Revolution on May 6, 1918.

Verbal Boundary Description:

The stone is located in the front yard of 919 Eastern Avenue. It is located approximately 25 feet northeast of the Eastern Avenue curb and 370 feet northwest of 56th Avenue (Maryland). The fence surrounds the stone.

Boundary Justification:

The boundary stone and fence have historically been situated at this location and maintain historic integrity.
