

Description

The Edmunds County Courthouse is a three story brick and stone building, with a three and one-half central tower. The courthouse is in the Art Deco style. Art Deco is identified by smooth wall surface usually of stucco; zigzag, chevrons and other stylized geometric motifs occur as decorative elements on facade; towers and other vertical projections above the roof line give a vertical emphasis. This style was poplar from late 1920s-1940.

The building features tan brick and a natural Bedford stone exterior. The Courthouse is three stories in height with a basement rising one-half level above grade. All elevations feature symmetrical fenestration. The Bedford stone is used in the fluted pilasters on the corner of the building and tower. These pilasters have decorative motifs at the tops. All of the windows were replaced circa 1975, but the building retains good integrity.

The main façade features three sections. The center section has three levels. The third and second levels have five window openings with a basketweave brick pattern below. Two windows on either side of the main entrance are on the main level. The main entrance is an example of an ornamented door surround with an inscription that reads "Edmunds County Court House" and decorative molding. The other two section features a vertical row of three windows evenly spaced with a basketweave brick pattern between the third and second floor windows.

The side elevations are identical. Four evenly spaced one-over-one double hung windows appear on basement level. The side is divided into three sections. The center area features two large brick pilasters extending the height of the building and two smaller brick pilaster between them. Three windows opening appear in between the four center pilasters on each floor with a basketweave brick pattern between each floor. The other two section of the elevation features a vertical row of three windows evenly spaced with a basketweave brick pattern between the third and second floor windows.

The rear elevation is divided into three balanced masses. The center section features a five-fenestration pattern each divided by six pilasters. The corners pilasters are stone pilasters and the four remaining are brick pilaster capped with stone. The fourth level of the center area has five window openings; they are featured between the two main stone pilasters and four brick pilasters. Below these five windows is a basketweave brick pattern. The third level features a window next to the stone pilasters that are equal to most openings on the buildings. The next three openings are longer and currently exhibit smaller windows than the originals. Two panels cover the openings to allow for a smaller window. Below this third story windows is also the basketweave brick pattern. The second level has five window openings, one between each pilaster. The middle three windows are

lower than the two end windows. The main level features a centered entrance made of Bedford Stone with a window on either side of the stone and brick pilasters. The other two section features a vertical row of three windows evenly spaced with a basketweave brick pattern between the third and second floor windows.

Statement of Significance

The Edmunds County Courthouse is eligible for listing on the National Register of Historic Places under criteria A and C. The building is historically significant for its role as the symbolic and functional seat of government for Edmunds County. The courthouse is the most important single physical elements in the historic and contemporary government of Edmunds County, and is an important local reminder of the importance of county government. It is also significant historical because of its association with the WPA era.

The Edmunds County Courthouse is architectural significant as a representative example of early twentieth-century public and institutional architectural in South Dakota. The building uses the Art Deco style that is typical of a WPA era building. The building represents of an excellent example of an Art Deco style building.

Historic Context

Edmunds County was organized on July 26, 1883 at which point a small stone and brick building was constructed. When the county offices out grew the building in the 1930s, officials discussed building a new courthouse. A bond issue failed due to the Depression. Despite the lack of support by the citizens of Edmunds County, the officials were able to secure funding for the building from the United States Government. The county officials tapped into their building fund of \$61,000. They would use the building funds to purchase bonds and in return, the U.S. government would issued grant to the county for labor and material through the National Industrial Recovery Act.

Before construction of the new building started, the county faced two problems. One problem the officials faced was where to place the building. They determined that the best location was on the 1883 courthouse site. Therefore, the building would be torn down to make way for the new building. With this decision made the county faced their second problem, where to house governmental offices and records until the new building was completed. The county rented two building to serve the county needs until completion of the new courthouse.

The county hired Roland R. Wilken of Watertown as the architect of the building. His design called for the use of stone, brick, concrete, steel, and tile. The style of the building is a representative example of an Art Deco building. To accomplish the construction of the building, the county hired Gray Construction to actually build the structure.

When completed on January 7, 1935, the interior included pink Tennessee marble and a courtroom with a modern ventilating system. The county offices moved into the new building on January 16, 1935.

This Art Deco building has suffered few alterations. The original windows were removed circa 1977. Despite this alteration, the building retains a high degree of integrity. The exterior retains its geometric shapes and decorative fluting pilasters. The interior changes are cosmetic only including carpeting, wiring, paint, and air conditioning.
